3	to change requirements for an annual status report relating to the
4	Affordable Housing Trust Fund; and to repeal the original section.
5	Be it enacted by the people of the State of Nebraska,

Section 1. Section 58-711, Revised Statutes Cumulative Supplement,
 2018, is amended to read:

58-711 (1) The Department of Economic Development shall submit, as 3 4 part of the department's annual status report under section 81-1201.11, the following information regarding detailing the status of the 5 Affordable Housing Trust Fund: (a) - The status report shall list (1) the 6 7 applications funded during the previous calendar year; (b) $\frac{1}{2}$ the applications funded in previous years; (c) $\frac{1}{7}$ (3) the identity of the 8 9 organizations receiving funds; (d) - (4) the location of each project; 10 (e) τ (5) the amount of funding provided to each the project; (f) τ (6) the amount of funding leveraged as a result of <u>each</u> the project; (g) τ 11 (7) the number of units of housing created by <u>each</u> the project and the 12 13 occupancy rate; (h) $\overline{, (8)}$ the expected cost of rent or monthly payment of those units; (i) $\frac{1}{1}$ (9) the projected number of new employees and 14 community investment as a result of each the project; (j), and (10) the 15 16 amount of revenue deposited into the Affordable Housing Trust Fund pursuant to section 76-903; (k) the total amount of funds for which 17 applications were received during the previous calendar year, the year-18 end fund balance, and, if all available funds have not been committed, an 19 explanation of the reasons why all such funds have not been so committed; 20 (1) the amount of appropriated funds actually expended by the department 21 for the previous calendar year; (m) the department's current budget for 22 administration of the Nebraska Affordable Housing Act and the 23 24 department's planned use and distribution of funds, including details on 25 the amount of funds to be expended on projects and the amount of funds to be expended by the department for administrative purposes; and (n) 26 27 project summaries, including the applicant municipality, project 28 description, grant amount requested, amount and type of matching funds, and reasons for approval or denial for every application seeking funds 29 during the previous calendar year. 30
