2	sections 60-601, 60-605, 60-611, 60-640, and 60-678, Reissue Revised
3	Statutes of Nebraska; to define and redefine terms; to provide for
4	the regulation of electric bicycles as prescribed; to provide a
5	penalty; to harmonize provisions; and to repeal the original
6	sections.

7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-601, Reissue Revised Statutes of Nebraska, is 2 amended to read: 60-601 Sections 60-601 to 60-6,383 and sections 4, 5, 6, and 7 of 3 this act shall be known and may be cited as the Nebraska Rules of the 4 5 Road. Sec. 2. Section 60-605, Reissue Revised Statutes of Nebraska, is 6 7 amended to read: 60-605 For purposes of the Nebraska Rules of the Road, 8 the 9 definitions found in sections 60-606 to 60-676 and sections 4, 5, 6, and 10 7 of this act shall be used. Sec. 3. Section 60-611, Reissue Revised Statutes of Nebraska, is 11 amended to read: 12 60-611 Bicycle means: shall mean 13 (1) Every every device propelled solely by human power, upon which 14 any person may ride, and having two tandem wheels either of which is more 15 than fourteen inches in diameter; and or 16 17 (2) An electric bicycle a device with two or three wheels, fully 18 operative pedals for propulsion by human power, and an electric motor with a capacity not exceeding seven hundred fifty watts which produces no 19 more than one brake horsepower and is capable of propelling the bicycle 20 at a maximum design speed of no more than twenty miles per hour on level 21 22 ground. Sec. 4. Class I electric bicycle means a device with the following 23 24 components: 25 (1) Two or three wheels; (2) Fully operative pedals for propulsion by human power; and 26 27 (3) An electric motor: (a) Not exceeding seven hundred fifty watts of power; 28 (b) That produces no more than one brake horsepower; 29 (c) Capable of propelling the bicycle at a maximum design speed of 30 no more than twenty miles per hour on level ground; 31

9	(a) Not exceeding seven hundred fifty watts of power;									
10	(b) That produces no more than one brake horsepower;									
11	(c) Capable of propelling the bicycle at a maximum design speed of

13	(d) Capable of providing power whether or not the rider is pedaling;

15	<u>(e) That does not provide power if the electric bicycle is traveling</u>

17	Sec. 6. <u>Class III electric bicycle means a device with the</u>									
18	following components:									
19	<u>(1) Two or three wheels;</u>									
20	(2) Fully operative pedals for propulsion by human power; and									
21	<u>(3) An electric motor:</u>									
22	<u>(a) Not exceeding seven hundred fifty watts of power;</u>									
23	(b) That produces no more than one brake horsepower;									
24	(c) Capable of propelling the bicycle at a maximum design speed of									
25	no more than twenty-eight miles per hour on level ground;									
26	(d) That only provides power when the rider is pedaling; and									
27	<u>(e) That does not provide power if the electric bicycle is traveling</u>									
28	<u>at a speed of more than twenty-eight miles per hour.</u>									
29	Sec. 7. <u>Electric bicycle means a Class I electric bicycle, a Class</u>									
30	II electric bicycle, and a Class III electric bicycle.

2 60-640 (1) Motor-driven cycle means every motorcycle, including 3 every motor scooter, with a motor which produces not to exceed five brake 4 horsepower as measured at the drive shaft, mopeds, and every bicycle with 5 <u>a</u> motor attached except for <u>an electric</u> a bicycle<u>as</u> described in 6 <u>subdivision (2) of section 60-611</u>. Motor-driven cycle shall not include 7 an electric personal assistive mobility device.

8 (2) For purposes of this section, motorcycle does not include an9 autocycle.

10 Sec. 9. Section 60-678, Reissue Revised Statutes of Nebraska, is 11 amended to read:

60-678 The State of Nebraska or any department, board, commission, 12 13 governmental subdivision thereof is hereby authorized, or in its respective jurisdiction, to enact regulations permitting, prohibiting, 14 and controlling the use of motor vehicles, minibikes, motorcycles, off-15 road recreation vehicles of any and all types, <u>electric bicycles</u>, other 16 17 powered vehicles, electric personal assistive mobility devices, and vehicles which are not self-propelled. Any person who operates any of 18 such vehicles without the permission of the appropriate governmental 19 entity or in a place, time, or manner which has been prohibited by such 20 entity shall be guilty of a Class III misdemeanor. 21

22 Such governmental entity may further authorize the supervising official of any area under its ownership or control to permit, control, 23 24 or prohibit operation of any motor vehicle, minibike, motorcycle, offroad recreational vehicle of any or all types, <u>electric bicycles</u>, other 25 powered vehicle, electric personal assistive mobility device, or vehicle 26 27 which is not self-propelled on all or any portion of any area under its ownership or control at any time by posting or, in case of an emergency, 28 by personal notice. Any person operating any such vehicle where 29 prohibited, where not permitted, or in a manner so as to endanger the 30 peace and safety of the public or as to harm or destroy the natural 31
