1 Section 1. Section 73-301, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 73-301 (1) The Director of Administrative Services shall
- 4 review and approve or disapprove any contract for personal services
- 5 between a private entity and any state agency, other than $\frac{(1)}{(a)}$ the
- 6 University of Nebraska, $\frac{(2)}{(b)}$ the Nebraska state colleges, and $\frac{(3)}{(3)}$
- 7 (c) any other board, commission, or agency established by the
- 8 Constitution of Nebraska, if, on the effective date of the contract,
- 9 the personal services are performed by permanent state employees of
- 10 the agency and will be replaced by services performed by the private
- 11 entity. The contract shall be subject to the public bidding
- 12 procedures established in sections 81-145 to 81-162 except in
- 13 emergencies approved by the Governor.
- 14 <u>(2)</u> For purposes of this section, contract for personal
- 15 services means an agreement by a contractor to provide human labor
- 16 but does not mean a contract to supply only goods or personal
- 17 property. The term includes contracts with private service providers,
- 18 consultants, and independent service contractors.
- 19 <u>(3) This section applies to any such contract for</u>
- 20 personal services, regardless of whether any state employee is
- 21 <u>displaced by such contract.</u>

- 2 <u>employees_employee_</u>of such state agency who will be displaced by such
- 3 contract. The plan shall include, but need not be limited to, the
- 4 following provisions:
- 5 (1) Efforts by the state agency to place <u>any</u> displaced
- 6 <u>employees employee</u> in <u>a vacant position position</u> in that agency or
- 7 another state agency;
- 8 (2) Provisions in the contract for personal services, if
- 9 feasible, for the hiring of <u>any displaced employees employee</u> by the
- 10 contractor; and
- 11 (3) Demonstration by the state agency that it has taken
- 12 formal and positive steps in considering alternatives to such
- 13 contract, including reorganization, reevaluation of service, and
- 14 reevaluation of performance.
