- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 81-6,122, Revised Statutes Cumulative Supplement,

2 2016, is amended to read:

81-6,122 (1) The Department of Health and Human Services shall 3 4 develop a comprehensive strategic plan for providing services to qualified persons with disabilities in the most integrated community-5 based settings pursuant to the Olmstead decision. The strategic plan 6 shall include, but not be limited to, (a) a reflective analysis of the 7 extent to which the department is providing services to qualified persons 8 with disabilities, (b) concrete and reliable commitments to expand 9 integrated opportunities for services to qualified persons with 10 disabilities, (c) measurable goals with specific and reasonable 11 timeframes for which the department may be held accountable, and (d) 12 13 funding support.

(2) The department shall (a) convene a team consisting of persons 14 from each of the six divisions of the department to assess components of 15 the strategic plan which may be in development; (b) consult with other 16 17 agencies that administer programs serving persons with disabilities; (c) appoint and convene a stakeholder advisory committee to 18 assist in the review and development of the strategic plan, such 19 committee members to include a representative from the State Advisory 20 Mental Health Services, the Advisory Committee 21 Committee on 22 Developmental Disabilities, the Nebraska Statewide Independent Living Council, the Nebraska Planning Council on Developmental Disabilities, the 23 24 Division of Rehabilitation Services in the State Department of Education, 25 a housing authority in a city of the first or second class and a housing authority in a city of the primary or metropolitan class, the Assistive 26 Technology Partnership, the protection and advocacy system for Nebraska, 27 an assisted-living organization, the behavioral health regions, mental 28 health practitioners, developmental disability service providers, an 29 organization that advocates for persons with developmental disabilities, 30 an organization that advocates for persons with mental illness, an 31

- 1 organization that advocates for persons with brain injuries, and an area agency on aging, and including two persons with disabilities representing 2 3 self-advocacy organizations, and, at the department's discretion, other persons with expertise in programs serving persons with disabilities; (d) 4 <u>hire</u> determine the need for a consultant to assist with the development 5 6 of the strategic plan; (e) provide a preliminary progress report to the 7 Legislature and the Governor by December 15, 2016, which includes, but is 8 not limited to, (i) the components of the strategic plan which may be in 9 development and (ii) the department's recommendation on hiring a consultant; (f) provide a second progress report to the Legislature and 10 the Governor by December 15, 2017; and (g) provide the completed 11 strategic plan to the Legislature and the Governor by December 15, 2019 12 2018. The reports and completed plan shall be submitted electronically to 13
- the Legislature.
