- 1 Section 1. DEFINITION OF APPROPRIATION PERIOD.
- 2 For purposes of this act and any other legislative bill passed by
- 3 the One Hundred Eighth Legislature, First or Second Session, which
- 4 appropriates funds, FY2021-22 means the period July 1, 2021, through June
- 5 <u>30, 2022; FY2022-23 means the period July 1, 2022, through June 30, 2023;</u>
- 6 FY2023-24 means the period July 1, 2023, through June 30, 2024; FY2024-25
- 7 means the period July 1, 2024, through June 30, 2025; FY2025-26 means the
- 8 <u>period July 1, 2025, through June 30, 2026; and FY2026-27 means the</u>
- 9 period July 1, 2026, through June 30, 2027.
- 10 Sec. 2. APPROPRIATION LANGUAGE.
- 11 There are hereby appropriated, for FY2021-22 and FY2022-23, the sums
- 12 <u>set forth in this act to each agency for each program from the respective</u>
- 13 <u>funds</u> for the general operations of state government, postsecondary
- 14 education, capital construction, and state aid, except as otherwise
- 15 appropriated.
- 16 Sec. 3. UNEXPENDED BALANCES AND CERTIFIED ENCUMBRANCES.
- 17 All General Fund appropriations existing on June 30, 2021, in excess
- 18 of expended and certified encumbrance amounts are hereby lapsed unless
- 19 <u>otherwise provided. All Cash Fund and Revolving Fund appropriations</u>
- 20 existing on June 30, 2021, in excess of expended and certified
- 21 encumbrance amounts are hereby lapsed unless otherwise expressly
- 22 provided. All certified encumbrance amounts on June 30, 2021, and June
- 23 30, 2022, are hereby reappropriated for FY2021-22 and FY2022-23,
- 24 respectively, which amounts shall be in addition to the amounts shown in
- 25 this act.
- Sec. 4. <u>REAPPROPRIATION OF BALANCES, FY2021-22 to FY2022-23.</u>
- 27 <u>In addition to the appropriations set forth in this act, there are</u>
- 28 hereby reappropriated all unexpended appropriation balances existing on

- 9 total expenditures for permanent and temporary salaries and per diems
- 10 shall mean all remuneration paid to employees treated as taxable
- 11 compensation by the Internal Revenue Service or subject to social
- 12 security coverage, specifically including payments accounted for as
- 13 vacation, holidays, sick leave, military leave, funeral leave, maternity
- 14 leave, administrative leave, compensatory time, deferred compensation, or
- 15 any other similar form, and amounts withheld pursuant to law, but
- 16 <u>excluding state contributions for social security, retirement, and</u>

- 18 (2) Total expenditures for permanent and temporary salaries and per
