## **LEGISLATIVE BILL 824**

Introduced by Blood, 3. Read first time January 03, 2024 Committee:

1	A BILL FOR AN ACT relating to public health; to amend section 38-1101,
2	Revised Statutes Cumulative Supplement, 2022, and section 38-131,
3	Revised Statutes Supplement, 2023; to adopt the Dentist and Dental
4	Hygienist Compact; to change provisions relating to criminal
5	background checks under the Uniform Credentialing Act; to require
6	criminal background checks under the Dentistry Practice Act as
7	prescribed; to harmonize provisions; to provide an operative date;
8	and to repeal the original sections.

9 Be it enacted by the people of the State of Nebraska,

1 Section 1. This section shall be known and may be cited as the 2 Dentist and Dental Hygienist Compact. The State of Nebraska adopts the Dentist and Dental Hygienist Compact in the form substantially as 3 4 follows: 5 SECTION 1. TITLE AND PURPOSE The purposes of this Compact are to facilitate the interstate 6 7 practice of dentistry and dental hygiene and improve public access to dentistry and dental hygiene services by providing Dentists and Dental 8 9 Hygienists licensed in a Participating State the ability to practice in 10 Participating States in which they are not licensed. The Compact does this by establishing a pathway for Dentists and Dental Hygienists 11 licensed in a Participating State to obtain a Compact Privilege that 12 13 authorizes them to practice in another Participating State in which they are not licensed. The Compact enables Participating States to protect the 14 15 public health and safety with respect to the practice of such Dentists 16 and Dental Hygienists, through the State's authority to regulate the 17 practice of dentistry and dental hygiene in the State. The Compact: A. Enables Dentists and Dental Hygienists who qualify for a Compact 18 19 Privilege to practice in other Participating States without satisfying burdensome and duplicative requirements associated with securing a 20 21 License to practice in those States; 22 B. Promotes mobility and addresses workforce shortages through each Participating State's acceptance of a Compact Privilege to practice in 23 24 that State; 25 C. Increases public access to qualified, licensed Dentists and Dental Hygienists by creating a responsible, streamlined pathway for 26 27 Licensees to practice in Participating States; 28 D. Enhances the ability of Participating States to protect the public's health and safety; 29 E. Does not interfere with licensure requirements established by a 30 Participating State; 31

1	F. Facilitates the sharing of licensure and disciplinary information
2	among Participating States;
3	<u>G. Requires Dentists and Dental Hygienists who practice in a</u>
4	Participating State pursuant to a Compact Privilege to practice within
5	the Scope of Practice authorized in that State;
6	<u>H. Extends the authority of a Participating State to regulate the</u>
7	practice of dentistry and dental hygiene within its borders to Dentists
8	and Dental Hygienists who practice in the State through a Compact
9	<u>Privilege;</u>
10	I. Promotes the cooperation of Participating States in regulating
11	the practice of dentistry and dental hygiene within those States; and
12	J. Facilitates the relocation of military members and their spouses
13	who are licensed to practice dentistry or dental hygiene.
14	SECTION 2. DEFINITIONS
15	<u>As used in this Compact, unless the context requires otherwise, the</u>
16	following definitions shall apply:
17	<u>A. "Active Military Member" means any person with full-time duty</u>
18	status in the armed forces of the United States, including members of the
19	National Guard and Reserve.
20	B. "Adverse Action" means disciplinary action or encumbrance imposed
21	on a License or Compact Privilege by a State Licensing Authority.
22	<u>C. "Alternative Program" means a nondisciplinary monitoring or</u>
23	practice remediation process applicable to a Dentist or Dental Hygienist
24	approved by a State Licensing Authority of a Participating State in which
25	the Dentist or Dental Hygienist is licensed. This includes, but is not
26	limited to, programs to which Licensees with substance abuse or addiction
27	issues are referred in lieu of Adverse Action.
28	D. "Clinical Assessment" means examination or process, required for
29	licensure as a Dentist or Dental Hygienist as applicable, that provides
30	evidence of clinical competence in dentistry or dental hygiene.
31	E. "Commissioner" means the individual appointed by a Participating

State to serve as the member of the Commission for that Participating 1 2 State. 3 F. "Compact" means this Dentist and Dental Hygienist Compact. G. "Compact Privilege" means the authorization granted by a Remote 4 State to allow a Licensee from a Participating State to practice as a 5 6 Dentist or Dental Hygienist in a Remote State. 7 H. "Continuing Professional Development" means a requirement, as a condition of License renewal, to provide evidence of successful 8 9 participation in educational or professional activities relevant to 10 practice or area of work. I. "Criminal Background Check" means the submission of fingerprints 11 or other biometric-based information for a License applicant for the 12 purpose of obtaining that applicant's criminal history record 13 information, as defined in 28 C.F.R. 20.3(d) from the Federal Bureau of 14 15 Investigation and the State's criminal history record repository as defined in 28 C.F.R. 20.3(f). 16 17 J. "Data System" means the Commission's repository of information about Licensees, including, but not limited to, examination, licensure, 18 investigative, Compact Privilege, Adverse Action, and Alternative 19 20 Program. K. "Dental Hygienist" means an individual who is licensed by a State 21 22 Licensing Authority to practice dental hygiene. L. "Dentist" means an individual who is licensed by a State 23 Licensing Authority to practice dentistry. 24 25 M. "Dentist and Dental Hygienist Compact Commission" or "Commission" means a joint government agency established by this Compact comprised of 26 each State that has enacted the Compact and a national administrative 27 body comprised of a Commissioner from each State that has enacted the 28 29 Compact. N. "Encumbered License" means a License that a State Licensing 30 Authority has limited in any way other than through an Alternative 31

2	0. "Executive Board" means the Chair, Vice Chair, Secretary, and
3	Treasurer and any other Commissioners as may be determined by Commission
4	<u>Rule or bylaw.</u>
5	<u>P. "Jurisprudence Requirement" means the assessment of an</u>
6	individual's knowledge of the laws and Rules governing the practice of
7	<u>dentistry or dental hygiene, as applicable, in a State.</u>
8	Q. "License" means current authorization by a State, other than
9	authorization pursuant to a Compact Privilege, or other privilege, for an
10	individual to practice as a Dentist or Dental Hygienist in that State.
11	<u>R. "Licensee" means an individual who holds an unrestricted License</u>
12	from a Participating State to practice as a Dentist or Dental Hygienist
13	<u>in that State.</u>
14	<u>S. "Model Compact" means the model for the Dentist and Dental</u>
15	Hygienist Compact on file with the Council of State Governments or other
16	entity as designated by the Commission.
17	T. "Participating State" means a State that has enacted the Compact
18	and been admitted to the Commission in accordance with the provisions
19	herein and Commission Rules.
20	U. "Qualifying License" means a License that is not an Encumbered
21	License issued by a Participating State to practice dentistry or dental
22	<u>hygiene.</u>
23	V. "Remote State" means a Participating State where a Licensee who
24	is not licensed as a Dentist or Dental Hygienist is exercising or seeking
25	to exercise the Compact Privilege.
26	<u>W. "Rule" means a regulation promulgated by an entity that has the</u>
27	force of law.
28	X. "Scope of Practice" means the procedures, actions, and processes
29	a Dentist or Dental Hygienist licensed in a State is permitted to
30	undertake in that State and the circumstances under which the Licensee is
31	permitted to undertake those procedures, actions, and processes. Such

procedures, actions, and processes and the circumstances under which they 1 may be undertaken may be established through means, including, but not 2 3 limited to, statute, regulations, case law, and other processes available to the State Licensing Authority or other government agency. 4 "Significant Investigative Information" means information, 5 Υ. records, and documents received or generated by a State Licensing 6 7 Authority pursuant to an investigation for which a determination has been made that there is probable cause to believe that the Licensee has 8 9 violated a statute or regulation that is considered more than a minor 10 infraction for which the State Licensing Authority could pursue Adverse 11 Action against the Licensee. Z. "State" means any state, commonwealth, district, or territory of 12 the United States of America that regulates the practices of dentistry 13 14 and dental hygiene. 15 AA. "State Licensing Authority" means an agency or other entity of a State that is responsible for the licensing and regulation of Dentists or 16 17 Dental Hygienists. 18 SECTION 3. STATE PARTICIPATION IN THE COMPACT A. In order to join the Compact and thereafter continue as a 19 <u>Participating State, a State must:</u> 20 1. Enact a compact that is not materially different from the Model 21 22 Compact as determined in accordance with Commission Rules; 2. Participate fully in the Commission's Data System; 23 3. Have a mechanism in place for receiving and investigating 24 25 complaints about its Licensees and License applicants; 4. Notify the Commission, in compliance with the terms of the 26 Compact and Commission Rules, of any Adverse Action or the availability 27 of Significant Investigative Information regarding a Licensee and License 28 29 applicant; 5. Fully implement a Criminal Background Check requirement, within a 30

31 <u>timeframe established by Commission Rule, by receiving the results of a</u>

gualifying Criminal Background Check; 1 2 6. Comply with the Commission Rules applicable to a Participating 3 State; 7. Accept the National Board Examinations of the Joint Commission on 4 National Dental Examinations or another examination accepted by 5 Commission Rule as a licensure examination; 6 7 8. Accept for licensure applicants for a Dentist License that graduate from a predoctoral dental education program accredited by the 8 9 Commission on Dental Accreditation, or another accrediting agency 10 recognized by the United States Department of Education for the accreditation of dentistry and dental hygiene education programs, leading 11 to the Doctor of Dental Surgery (D.D.S.) or Doctor of Dental Medicine 12 (D.M.D.) degree; 13 9. Accept for licensure applicants for a Dental Hygienist License 14 that graduate from a dental hygiene education program accredited by the 15 Commission on Dental Accreditation or another accrediting agency 16 17 recognized by the United States Department of Education for the accreditation of dentistry and dental hygiene education programs; 18 10. Require for licensure that applicants successfully complete a 19 20 Clinical Assessment; 11. Have Continuing Professional Development requirements as a 21 22 condition for License renewal; and 12. Pay a participation fee to the Commission as established by 23 24 Commission Rule. 25 B. Providing alternative pathways for an individual to obtain an 26 unrestricted License does not disqualify a State from participating in the Compact. 27 28 C. When conducting a Criminal Background Check, the State Licensing Authority shall: 29 1. Consider that information in making a licensure decision; 30 2. Maintain documentation of completion of the Criminal Background 31

1	Check and background check information to the extent allowed by State and
2	federal law; and
3	3. Report to the Commission whether it has completed the Criminal
4	Background Check and whether the individual was granted or denied a
5	License.
6	D. A Licensee of a Participating State who has a Qualifying License
7	in that State and does not hold an Encumbered License in any other
8	Participating State shall be issued a Compact Privilege in a Remote State
9	in accordance with the terms of the Compact and Commission Rules. If a
10	Remote State has a Jurisprudence Requirement, a Compact Privilege will
11	not be issued to the Licensee unless the Licensee has satisfied the
12	Jurisprudence Requirement.
13	SECTION 4. COMPACT PRIVILEGE
14	A. To obtain and exercise the Compact Privilege under the terms and
15	provisions of the Compact, the Licensee shall:
16	<u>1. Have a Qualifying License as a Dentist or Dental Hygienist in a</u>
17	<u>Participating State;</u>
18	<u>2. Be eligible for a Compact Privilege in any Remote State in</u>
19	accordance with subsections D, G, and H of this section;
20	3. Submit to an application process whenever the Licensee is seeking
21	<u>a Compact Privilege;</u>
22	4. Pay any applicable Commission and Remote State fees for a Compact
23	<u>Privilege in the Remote State;</u>
24	5. Meet any Jurisprudence Requirement established by a Remote State
25	in which the Licensee is seeking a Compact Privilege;
26	6. Have passed a National Board Examination of the Joint Commission
27	on National Dental Examinations or another examination accepted by
28	<u>Commission Rule;</u>
29	7. For a Dentist, have graduated from a predoctoral dental education
30	program accredited by the Commission on Dental Accreditation, or another
31	accrediting agency recognized by the United States Department of

1 Education for the accreditation of dentistry and dental hygiene education

2 programs, leading to the Doctor of Dental Surgery (D.D.S.) or Doctor of

3 <u>Dental Medicine (D.M.D.) degree;</u>

8. For a Dental Hygienist, have graduated from a dental hygiene
education program accredited by the Commission on Dental Accreditation or
another accrediting agency recognized by the United States Department of
Education for the accreditation of dentistry and dental hygiene education
programs;

9 <u>9. Have successfully completed a Clinical Assessment for licensure;</u>

10. Report to the Commission Adverse Action taken by any non 11 Participating State when applying for a Compact Privilege and, otherwise,
 12 within thirty days from the date the Adverse Action is taken;

13 <u>11. Report to the Commission when applying for a Compact Privilege</u> 14 <u>the address of the Licensee's primary residence and thereafter</u> 15 <u>immediately report to the Commission any change in the address of the</u> 16 <u>Licensee's primary residence; and</u>

17 <u>12. Consent to accept service of process by mail at the Licensee's</u> 18 primary residence on record with the Commission with respect to any 19 action brought against the Licensee by the Commission or a Participating 20 State, and consent to accept service of a subpoena by mail at the 21 Licensee's primary residence on record with the Commission with respect 22 to any action brought or investigation conducted by the Commission or a 23 Participating State.

B. The Licensee must comply with the requirements of subsection A of this section to maintain the Compact Privilege in the Remote State. If those requirements are met, the Compact Privilege will continue as long as the Licensee maintains a Qualifying License in the State through which the Licensee applied for the Compact Privilege and pays any applicable Compact Privilege renewal fees.

30 <u>C. A Licensee providing dentistry or dental hygiene in a Remote</u>
 31 <u>State under the Compact Privilege shall function within the Scope of</u>

Practice authorized by the Remote State for a Dentist or Dental Hygienist
 licensed in that State.

3 D. A Licensee providing dentistry or dental hygiene pursuant to a 4 Compact Privilege in a Remote State is subject to that State's regulatory authority. A Remote State may, in accordance with due process and that 5 State's laws, by Adverse Action revoke or remove a Licensee's Compact 6 7 Privilege in the Remote State for a specific period of time and impose fines or take any other necessary actions to protect the health and 8 9 safety of its citizens. If a Remote State imposes an Adverse Action 10 against a Compact Privilege that limits the Compact Privilege, that Adverse Action applies to all Compact Privileges in all Remote States. A 11 Licensee whose Compact Privilege in a Remote State is removed for a 12 13 specified period of time is not eligible for a Compact Privilege in any other Remote State until the specific time for removal of the Compact 14 15 Privilege has passed and all encumbrance requirements are satisfied.

E. If a License in a Participating State is an Encumbered License, the Licensee shall lose the Compact Privilege in a Remote State and shall not be eligible for a Compact Privilege in any Remote State until the License is no longer encumbered.

F. Once an Encumbered License in a Participating State is restored
 to good standing, the Licensee must meet the requirements of subsection A
 of this section to obtain a Compact Privilege in a Remote State.

<u>G. If a Licensee's Compact Privilege in a Remote State is removed by</u>
 <u>the Remote State, the individual shall lose or be ineligible for the</u>
 <u>Compact Privilege in any Remote State until the following occur:</u>

26 <u>1. The specific period of time for which the Compact Privilege was</u>
 27 removed has ended; and

28 <u>2. All conditions for removal of the Compact Privilege have been</u>
 29 <u>satisfied.</u>

30 <u>H. Once the requirements of subsection G of this section have been</u>
 31 met, the Licensee must meet the requirements in subsection A of this

section to obtain a Compact Privilege in a Remote State. 1 2 SECTION 5. ACTIVE MILITARY MEMBERS AND THEIR SPOUSES 3 An Active Military Member and the member's spouse shall not be required to pay to the Commission for a Compact Privilege the fee 4 otherwise charged by the Commission. If a Remote State chooses to charge 5 a fee for a Compact Privilege, it may choose to charge a reduced fee or 6 7 no fee to an Active Military Member and the member's spouse for a Compact 8 Privilege. 9 SECTION 6. ADVERSE ACTIONS 10 A. A Participating State in which a Licensee is licensed shall have exclusive authority to impose Adverse Action against the Qualifying 11 12 License issued by that Participating State. 13 B. A Participating State may take Adverse Action based on the Significant Investigative Information of a Remote State, so long as the 14 Participating State follows its own procedures for imposing Adverse 15 16 Action. 17 C. Nothing in this Compact shall override a Participating State's 18 decision that participation in an Alternative Program may be used in lieu 19 of Adverse Action and that such participation shall remain nonpublic if required by the Participating State's laws. Participating States must 20 21 require Licensees who enter any Alternative Program in lieu of discipline 22 to agree not to practice pursuant to a Compact Privilege in any other 23 Participating State during the term of the Alternative Program without 24 prior authorization from such other Participating State. 25 D. Any Participating State in which a Licensee is applying to practice or is practicing pursuant to a Compact Privilege may investigate 26 27 actual or alleged violations of the statutes and regulations authorizing 28 the practice of dentistry or dental hygiene in any other Participating State in which the Dentist or Dental Hygienist holds a License or Compact 29 30 Privilege.

31 <u>E. A Remote State shall have the authority to:</u>

<u>1. Take Adverse Actions as set forth in Section 4.D against a</u>
 <u>Licensee's Compact Privilege in the State;</u>
 <u>2. In furtherance of its rights and responsibilities under the</u>
 <u>4. Compact and the Commission's Rules, issue subpoenas for hearings and</u>

investigations that require the attendance and testimony of witnesses and 5 for the production of evidence. Subpoenas issued by a State Licensing 6 7 Authority in a Participating State for the attendance and testimony of witnesses, or the production of evidence from another Participating 8 9 State, shall be enforced in the latter State by any court of competent 10 jurisdiction, according to the practice and procedure of that court applicable to subpoenas issued in proceedings pending before it. The 11 issuing authority shall pay any witness fees, travel expenses, mileage, 12 13 and other fees required by the service statutes of the State where the

14 witnesses or evidence are located; and

<u>3. If otherwise permitted by State law, recover from the Licensee</u>
 <u>the costs of investigations and disposition of cases resulting from any</u>
 Adverse Action taken against that Licensee.

18 <u>F. Joint Investigations</u>

<u>1. In addition to the authority granted to a Participating State by</u>
 <u>its Dentist or Dental Hygienist licensure act or other applicable State</u>
 <u>law, a Participating State may jointly investigate Licensees with other</u>
 Participating States.

23 <u>2. Participating States shall share any Significant Investigative</u>
 24 <u>Information, litigation, or compliance materials in furtherance of any</u>
 25 joint or individual investigation initiated under the Compact.

26 <u>G. Authority to Continue Investigation</u>

27 <u>1. After a Licensee's Compact Privilege in a Remote State is</u>
 28 <u>terminated, the Remote State may continue an investigation of the</u>
 29 <u>Licensee that began when the Licensee had a Compact Privilege in that</u>
 30 <u>Remote State.</u>

31 <u>2. If the investigation yields what would be Significant</u>

1	Investigative Information had the Licensee continued to have a Compact
2	<u>Privilege in that Remote State, the Remote State shall report the</u>
3	presence of such information to the Data System as required by Section
4	8.B.6 as if it was Significant Investigative Information.
5	SECTION 7. ESTABLISHMENT AND OPERATION OF THE COMMISSION.
6	A. The Compact Participating States hereby create and establish a
7	joint government agency whose membership consists of all Participating
8	<u>States that have enacted the Compact. The Commission is an</u>
9	instrumentality of the Participating States acting jointly and not an
10	instrumentality of any one State. The Commission shall come into
11	existence on or after the effective date of the Compact as set forth in
12	Section 11.A.
13	B. Participation, Voting, and Meetings
14	<u>1. Each Participating State shall have and be limited to one</u>
15	Commissioner selected by that Participating State's State Licensing
16	Authority or, if the State has more than one State Licensing Authority,
17	selected collectively by the State Licensing Authorities.
18	2. The Commissioner shall be a member or designee of such Authority
19	<u>or Authorities.</u>
20	<u>3. The Commission may by Rule or bylaw establish a term of office</u>
21	for Commissioners and may by Rule or bylaw establish term limits.
22	<u>4. The Commission may recommend to a State Licensing Authority or</u>
23	Authorities, as applicable, removal or suspension of an individual as the
24	<u>State's Commissioner.</u>
25	<u>5. A Participating State's State Licensing Authority, or</u>
26	Authorities, as applicable, shall fill any vacancy of its Commissioner on
27	the Commission within sixty days of the vacancy.
28	<u>6. Each Commissioner shall be entitled to one vote on all matters</u>
29	<u>that are voted upon by the Commission.</u>
30	7. The Commission shall meet at least once during each calendar
31	year. Additional meetings may be held as set forth in the bylaws. The

1	<u>Commission may meet by telecommunication, videoconference, or other</u>
2	<u>similar electronic means.</u>
3	C. The Commission shall have the following powers:
4	1. Establish the fiscal year of the Commission;
5	2. Establish a code of conduct and conflict of interest policies;
6	3. Adopt Rules and bylaws;
7	4. Maintain its financial records in accordance with the bylaws;
8	5. Meet and take such actions as are consistent with the provisions
9	of this Compact, the Commission's Rules, and the bylaws;
10	6. Initiate and conclude legal proceedings or actions in the name of
11	the Commission, provided that the standing of any State Licensing
12	Authority to sue or be sued under applicable law shall not be affected;
13	7. Maintain and certify records and information provided to a
14	Participating State as the authenticated business records of the
15	Commission, and designate a person to do so on the Commission's behalf;
16	8. Purchase and maintain insurance and bonds;
17	9. Borrow, accept, or contract for services of personnel, including,
18	but not limited to, employees of a Participating State;
19	<u>10. Conduct an annual financial review;</u>
20	<u>11. Hire employees, elect or appoint officers, fix compensation,</u>
21	define duties, grant such individuals appropriate authority to carry out
22	the purposes of the Compact, and establish the Commission's personnel
23	policies and programs relating to conflicts of interest, qualifications
24	of personnel, and other related personnel matters;
25	<u>12. As set forth in the Commission Rules, charge a fee to a Licensee</u>
26	for the grant of a Compact Privilege in a Remote State and thereafter, as
27	may be established by Commission Rule, charge the Licensee a Compact
28	<u>Privilege renewal fee for each renewal period in which that Licensee</u>
29	<u>exercises or intends to exercise the Compact Privilege in that Remote</u>
30	<u>State. Nothing herein shall be construed to prevent a Remote State from</u>
31	<u>charging a Licensee a fee for a Compact Privilege or renewals of a</u>

1	<u>Compact Privilege, or a fee for the Jurisprudence Requirement if the</u>
2	Remote State imposes such a requirement for the grant of a Compact
3	Privilege;
4	13. Accept any and all appropriate gifts, donations, grants of
5	money, other sources of revenue, equipment, supplies, materials, and
6	services, and receive, utilize, and dispose of the same; provided that at
7	all times the Commission shall avoid any appearance of impropriety and/or
8	<u>conflict of interest;</u>
9	<u>14. Lease, purchase, retain, own, hold, improve, or use any</u>
10	property, real, personal, or mixed, or any undivided interest therein;
11	<u>15. Sell, convey, mortgage, pledge, lease, exchange, abandon, or</u>
12	otherwise dispose of any property, real, personal, or mixed;
13	16. Establish a budget and make expenditures;
14	<u>17. Borrow money;</u>
15	18. Appoint committees, including standing committees, which may be
16	composed of members, State regulators, State legislators or their
17	representatives, and consumer representatives, and such other interested
18	persons as may be designated in this Compact and the bylaws;
19	19. Provide and receive information from, and cooperate with, law
20	<u>enforcement agencies;</u>
21	20. Elect a Chair, Vice Chair, Secretary, and Treasurer and such
22	other officers of the Commission as provided in the Commission's bylaws;
23	21. Establish and elect an Executive Board;
24	22. Adopt and provide to the Participating States an annual report;
25	23. Determine whether a State's enacted compact is materially
26	different from the Model Compact language such that the State would not
27	qualify for participation in the Compact; and
28	24. Perform such other functions as may be necessary or appropriate
29	to achieve the purposes of this Compact.
30	D. Meetings of the Commission
01	1 All mostings of the commission that are not closed numericant to

31 <u>1. All meetings of the Commission that are not closed pursuant to</u>

this subsection shall be open to the public. Notice of public meetings 1 2 shall be posted on the Commission's website at least thirty days prior to 3 the public meeting. 2. Notwithstanding subsection D.1 of this section, the Commission 4 may convene an emergency public meeting by providing at least twenty-four 5 hours prior notice on the Commission's website, and any other means as 6 7 provided in the Commission's Rules, for any of the reasons it may dispense with notice of proposed rulemaking under Section 9.L. Notice of all Commission meetings shall provide the time, date, 11 and location of the meeting, and if the meeting is to be held or 12 accessible via telecommunication, videoconference, or other electronic 13 14 means, the notice shall include the mechanism for access to the meeting 15 through such means. 16 4. The Commission may convene in a closed, nonpublic meeting for the 17 Commission to receive legal advice or to discuss: a. Noncompliance of a Participating State with its obligations under 18 19 the Compact; b. The employment, compensation, discipline, or other matters, 20 21 practices, or procedures related to specific employees or other matters 22 related to the Commission's internal personnel practices and procedures; c. Current or threatened discipline of a Licensee or Compact 23 24 Privilege holder by the Commission or by a Participating State's 25 Licensing Authority; <u>d. Current, threatened, or reasonably anticipated litigation;</u> 26 27 e. Negotiation of contracts for the purchase, lease, or sale of goods, services, or real estate; 28 29 f. Accusing any person of a crime or formally censuring any person; q. Trade secrets or commercial or financial information that is 30 privileged or confidential; 31

1	h. Information of a personal nature where disclosure would
2	constitute a clearly unwarranted invasion of personal privacy;
3	i. Investigative records compiled for law enforcement purposes;
4	j. Information related to any investigative reports prepared by or
5	<u>on behalf of or for use of the Commission or other committee charged with</u>
6	responsibility of investigation or determination of compliance issues
7	pursuant to the Compact;
8	<u>k. Legal advice;</u>
9	1. Matters specifically exempted from disclosure to the public by
10	federal or Participating State law; and
11	m. Other matters as promulgated by the Commission by Rule.
12	5. If a meeting, or portion of a meeting, is closed, the presiding
13	officer shall state that the meeting will be closed and reference each
14	relevant exempting provision, and such reference shall be recorded in the
15	<u>minutes.</u>
16	6. The Commission shall keep minutes that fully and clearly describe
17	all matters discussed in a meeting and shall provide a full and accurate
18	summary of actions taken, and the reasons therefor, including a
19	description of the views expressed. All documents considered in
20	connection with an action shall be identified in such minutes. All
21	minutes and documents of a closed meeting shall remain under seal,
22	subject to release only by a majority vote of the Commission or order of
23	a court of competent jurisdiction.
24	E. Financing of the Commission
25	<u>1. The Commission shall pay, or provide for the payment of, the</u>
26	reasonable expenses of its establishment, organization, and ongoing
27	<u>activities.</u>
28	2. The Commission may accept any and all appropriate sources of
29	revenue, donations, and grants of money, equipment, supplies, materials,
30	and services.
31	3. The Commission may levy on and collect an annual assessment from

1	each Participating State and impose fees on Licensees of Participating
2	States when a Compact Privilege is granted, to cover the cost of the
3	operations and activities of the Commission and its staff, which must be

17	Commission shall be subject to an annual financial review by a certified
18	or licensed public accountant, and the report of the financial review
19	shall be included in and become part of the annual report of the
20	Commission.
21	F. The Executive Board
22	1. The Executive Board shall have the power to act on behalf of the
23	Commission according to the terms of this Compact. The powers, duties,
24	and responsibilities of the Executive Board shall include:
25	a. Overseeing the day-to-day activities of the administration of the
26	Compact including compliance with the provisions of the Compact and the
27	<u>Commission's Rules and bylaws;</u>
28	<u>b. Recommending to the Commission changes to the Rules or bylaws,</u>
29	changes to this Compact legislation, fees charged to Compact
30	Participating States, fees charged to Licensees, and other fees;

31 <u>c. Ensuring Compact administration services are appropriately</u>

10	duties expressly reserved to the Commission by Rule or bylaw; and
11	<u>i. Other duties as provided in the Rules or bylaws of the</u>
12	<u>Commission.</u>
13	2. The Executive Board shall be composed of up to seven members:
14	a. The Chair, Vice Chair, Secretary, and Treasurer of the Commission
15	and any other members of the Commission who serve on the Executive Board
16	shall be voting members of the Executive Board; and
17	<u>b. Other than the Chair, Vice Chair, Secretary, and Treasurer, the</u>
18	<u>Commission may elect up to three voting members from the current</u>
19	membership of the Commission.
20	3. The Commission may remove any member of the Executive Board as
21	provided in the Commission's bylaws.
22	4. The Executive Board shall meet at least annually.
23	<u>a. An Executive Board meeting at which it takes or intends to take</u>
24	formal action on a matter shall be open to the public, except that the
25	Executive Board may meet in a closed, nonpublic session of a public
26	meeting when dealing with any of the matters covered under subsection D.4
27	<u>of this section.</u>
28	<u>b. The Executive Board shall give five business days' notice of its</u>
29	public meetings, posted on its website and as it may otherwise determine
30	to provide notice to persons with an interest in the public matters the
31	Executive Board intends to address at those meetings.

6	<u>G. Qualified Immunity, Defense, and Indemnification</u>
7	<u>1. The members, officers, executive director, employees, and</u>
8	representatives of the Commission shall have no greater liability than a
9	state employee would have under the same or similar circumstances, either
10	personally or in their official capacity, for any claim for damage to or
11	loss of property or personal injury or other civil liability caused by or
12	arising out of any actual or alleged act, error, or omission that
13	<u>occurred, or that the person against whom the claim is made had a</u>
14	reasonable basis for believing occurred, within the scope of Commission
15	employment, duties, or responsibilities; provided that nothing in this
16	paragraph shall be construed to protect any such person from suit or
17	<u>liability for any damage, loss, injury, or liability caused by the</u>
18	intentional or willful or wanton misconduct of that person. The
19	procurement of insurance of any type by the Commission shall not in any
20	way compromise or limit the immunity granted hereunder.
21	2. The Commission shall defend any member, officer, executive
22	director, employee, or representative of the Commission in any civil
23	action seeking to impose liability arising out of any actual or alleged
24	act, error, or omission that occurred within the scope of Commission

25 employment, duties, or responsibilities, or that the person against whom 26 the claim is made had a reasonable basis for believing occurred within

that nothing herein shall be construed to prohibit that person from retaining their own counsel at their own expense; and provided further, 29

2	officer, executive director, employee, or representative of the

11	<u>4. Nothing herein shall be construed as a limitation on the</u>

14	<u>5. Nothing in this Compact shall be interpreted to waive or</u>
15	otherwise abrogate a Participating State's state action immunity or state
16	action affirmative defense with respect to antitrust claims under the
17	<u>Sherman Act, the Clayton Act, or any other State or federal antitrust or</u>
18	anticompetitive law or regulation.
19	<u>6. Nothing in this Compact shall be construed to be a waiver of</u>
20	sovereign immunity by the Participating States or by the Commission.
21	SECTION 8. DATA SYSTEM
22	A. The Commission shall provide for the development, maintenance,
23	operation, and utilization of a coordinated database and reporting system
24	containing licensure, Adverse Action, and the presence of Significant
25	Investigative Information on all Licensees and applicants for a License
26	<u>in Participating States.</u>
27	<u>B. Notwithstanding any other provision of State law to the contrary,</u>
28	<u>a Participating State shall submit a uniform data set to the Data System</u>
29	on all individuals to whom this Compact is applicable as required by the

16	the Commission or an agent thereof, shall constitute the authenticated
17	business records of the Commission, and shall be entitled to any
18	associated hearsay exception in any relevant judicial, quasi-judicial, or
19	administrative proceedings in a Participating State.
20	D. Significant Investigative Information pertaining to a Licensee in
21	any Participating State will only be available to other Participating
22	<u>States.</u>
23	E. It is the responsibility of the Participating States to monitor
24	<u>the database to determine whether Adverse Action has been taken against a</u>
25	Licensee or License applicant. Adverse Action information pertaining to a
26	Licensee or License applicant in any Participating State will be
27	available to any other Participating State.
28	F. Participating States contributing information to the Data System
29	may designate information that may not be shared with the public without
30	the express permission of the contributing State.
31	<u>G. Any information submitted to the Data System that is subsequently</u>

1 <u>expunged pursuant to federal law or the laws of the Participating State</u>

2 <u>contributing the information shall be removed from the Data System.</u>

## 3 <u>SECTION 9. RULEMAKING</u>

A. The Commission shall promulgate reasonable Rules in order to 4 effectively and efficiently implement and administer the purposes and 5 provisions of the Compact. A Commission Rule shall be invalid and have no 6 7 force or effect only if a court of competent jurisdiction holds that the Rule is invalid because the Commission exercised its rulemaking authority 8 9 in a manner that is beyond the scope and purposes of the Compact, or the 10 powers granted hereunder, or based upon another applicable standard of 11 review.

B. The Rules of the Commission shall have the force of law in each Participating State, provided however that where the Rules of the Commission conflict with the laws of the Participating State that establish the Participating State's Scope of Practice as held by a court of competent jurisdiction, the Rules of the Commission shall be ineffective in that State to the extent of the conflict.

<u>C. The Commission shall exercise its Rulemaking powers pursuant to</u>
 <u>the criteria set forth in this section and the Rules adopted thereunder.</u>
 <u>Rules shall become binding as of the date specified by the Commission for</u>
 <u>each Rule.</u>

D. If a majority of the legislatures of the Participating States reject a Commission Rule or portion of a Commission Rule, by enactment of a statute or resolution in the same manner used to adopt the Compact, within four years of the date of adoption of the Rule, then such Rule shall have no further force and effect in any Participating State or to any State applying to participate in the Compact.

28 <u>E. Rules shall be adopted at a regular or special meeting of the</u>
 29 <u>Commission.</u>

30 <u>F. Prior to adoption of a proposed Rule, the Commission shall hold a</u>
 31 <u>public hearing and allow persons to provide oral and written comments,</u>

2	<u>G. Prior to adoption of a proposed Rule by the Commission, and at</u>
3	least thirty days in advance of the meeting at which the Commission will
4	hold a public hearing on the proposed Rule, the Commission shall provide

6	<u>1. On the website of the Commission or other publicly accessible</u>
7	<u>platform;</u>
8	2. To persons who have requested notice of the Commission's notices
9	of proposed rulemaking; and
10	3. In such other ways as the Commission may by Rule specify.
11	H. The Notice of Proposed Rulemaking shall include:
12	<u>1. The time, date, and location of the public hearing at which the</u>
13	Commission will hear public comments on the proposed Rule and, if
14	<u>different, the time, date, and location of the meeting where the</u>
15	Commission will consider and vote on the proposed Rule;
16	2. If the hearing is held via telecommunication, videoconference, or
17	other electronic means, the Commission shall include the mechanism for
18	access to the hearing in the Notice of Proposed Rulemaking;
19	3. The text of the proposed Rule and the reason therefor;
20	<u>4. A request for comments on the proposed Rule from any interested</u>
21	person; and
22	<u>5. The manner in which interested persons may submit written</u>
23	<u>comments.</u>
24	I. All hearings will be recorded. A copy of the recording and all
25	written comments and documents received by the Commission in response to
26	the proposed Rule shall be available to the public.
27	J. Nothing in this section shall be construed as requiring a
28	separate hearing on each Commission Rule. Rules may be grouped for the
29	convenience of the Commission at hearings required by this section.
30	K. The Commission shall, by majority vote of all Commissioners, take
31	final action on the proposed Rule based on the rulemaking record.

1	1. The Commission may adopt changes to the proposed Rule provided
2	the changes do not enlarge the original purpose of the proposed Rule.
3	2. The Commission shall provide an explanation of the reasons for

16	than ninety days after the effective date of the Rule. For the purposes

21	<u>3. Meet a deadline for the promulgation of a Rule that is</u>

direct revisions to a previously adopted Rule for purposes of correcting typographical errors, errors in format, errors in consistency, or grammatical errors. Public notice of any revisions shall be posted on the website of the Commission. The revision shall be subject to challenge by any person for a period of thirty days after posting. The revision may be challenged only on grounds that the revision results in a material change to a Rule. A challenge shall be made in writing and delivered to the

1	<u>Commission prior to the end of the notice period. If no challenge is</u>
2	made, the revision will take effect without further action. If the
3	revision is challenged, the revision may not take effect without the
4	approval of the Commission.
5	N. No Participating State's rulemaking requirements shall apply
6	<u>under this Compact.</u>
7	SECTION 10. OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT
8	<u>A. Oversight</u>
9	1. The executive and judicial branches of State government in each
10	Participating State shall enforce this Compact and take all actions
11	necessary and appropriate to implement the Compact.
12	2. Venue is proper and judicial proceedings by or against the
13	Commission shall be brought solely and exclusively in a court of
14	competent jurisdiction where the principal office of the Commission is
15	located. The Commission may waive venue and jurisdictional defenses to
16	the extent it adopts or consents to participate in alternative dispute
17	resolution proceedings. Nothing herein shall affect or limit the
18	selection or propriety of venue in any action against a Licensee for
19	professional malpractice, misconduct, or any such similar matter.
20	3. The Commission shall be entitled to receive service of process in
21	any proceeding regarding the enforcement or interpretation of the Compact
22	<u>or Commission Rule and shall have standing to intervene in such a</u>
23	proceeding for all purposes. Failure to provide the Commission service of
24	process shall render a judgment or order void as to the Commission, this
25	<u>Compact, or promulgated Rules.</u>
26	B. Default, Technical Assistance, and Termination
27	1. If the Commission determines that a Participating State has
28	defaulted in the performance of its obligations or responsibilities under
29	this Compact or the promulgated Rules, the Commission shall provide
30	written notice to the defaulting State. The notice of default shall
31	describe the default, the proposed means of curing the default, and any

<u>other action that the Commission may take, and shall offer training and</u>
 specific technical assistance regarding the default.

3 <u>2. The Commission shall provide a copy of the notice of default to</u>
4 the other Participating States.

5 <u>C. If a State in default fails to cure the default, the defaulting</u> 6 <u>State may be terminated from the Compact upon an affirmative vote of a</u> 7 <u>majority of the Commissioners, and all rights, privileges, and benefits</u> 8 <u>conferred on that State by this Compact may be terminated on the</u> 9 <u>effective date of termination. A cure of the default does not relieve the</u> 10 <u>offending State of obligations or liabilities incurred during the period</u> 11 of default.

D. Termination of participation in the Compact shall be imposed only after all other means of securing compliance have been exhausted. Notice of intent to suspend or terminate shall be given by the Commission to the governor, the majority and minority leaders of the defaulting State's legislature, the defaulting State's State Licensing Authority or Authorities, as applicable, and each of the Participating States' State Licensing Authority or Authorities, as applicable.

E. A State that has been terminated is responsible for all
 assessments, obligations, and liabilities incurred through the effective
 date of termination, including obligations that extend beyond the
 effective date of termination.

F. Upon the termination of a State's participation in this Compact, that State shall immediately provide notice to all Licensees of the State, including Licensees of other Participating States issued a Compact Privilege to practice within that State, of such termination. The terminated State shall continue to recognize all Compact Privileges then in effect in that State for a minimum of one hundred eighty days after the date of the notice of termination.

30 <u>G. The Commission shall not bear any costs related to a State that</u> 31 is found to be in default or that has been terminated from the Compact,

unless agreed upon in writing between the Commission and the defaulting 1 2 State. 3 H. The defaulting State may appeal the action of the Commission by petitioning the United States District Court for the District of Columbia 4 or the federal district where the Commission has its principal offices. 5 The prevailing party shall be awarded all costs of such litigation, 6 7 including reasonable attorney's fees. 8 I. Dispute Resolution 9 1. Upon request by a Participating State, the Commission shall 10 attempt to resolve disputes related to the Compact that arise among Participating States and between Participating States and non-11 12 Participating States. 13 2. The Commission shall promulgate a Rule providing for both mediation and binding dispute resolution for disputes as appropriate. 14 15 J. Enforcement 1. The Commission, in the reasonable exercise of its discretion, 16 17 shall enforce the provisions of this Compact and the Commission's Rules. 2. By majority vote, the Commission may initiate legal action 18 against a Participating State in default in the United States District 19 Court for the District of Columbia or the federal district where the 20 21 Commission has its principal offices to enforce compliance with the 22 provisions of the Compact and its promulgated Rules. The relief sought 23 may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing party shall be awarded all costs 24 25 of such litigation, including reasonable attorney's fees. The remedies herein shall not be the exclusive remedies of the Commission. The 26 27 Commission may pursue any other remedies available under federal or the 28 defaulting Participating State's law. 29 3. A Participating State may initiate legal action against the Commission in the United States District Court for the District of 30

31 Columbia or the federal district where the Commission has its principal

offices to enforce compliance with the provisions of the Compact and its 1 2 promulgated Rules. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the 3 prevailing party shall be awarded all costs of such litigation, including 4 reasonable attorney's fees. 5 4. No individual or entity other than a Participating State may 6 7 enforce this Compact against the Commission. SECTION 11. EFFECTIVE DATE, WITHDRAWAL, AND AMENDMENT 8 9 A. The Compact shall come into effect on the date on which the 10 Compact statute is enacted into law in the seventh Participating State. 1. On or after the effective date of the Compact, the Commission 11 12 shall convene and review the enactment of each of the States that enacted 13 the Compact prior to the Commission convening ("Charter Participating States") to determine if the statute enacted by each such Charter 14 15 Participating State is materially different than the Model Compact. a. A Charter Participating State whose enactment is found to be 16 17 materially different from the Model Compact shall be entitled to the 18 default process set forth in Section 10. 19 b. If any Participating State is later found to be in default, or is terminated or withdraws from the Compact, the Commission shall remain in 20 21 existence and the Compact shall remain in effect even if the number of 22 Participating States should be less than seven. 2. Participating States enacting the Compact subsequent to the 23 24 Charter Participating States shall be subject to the process set forth in 25 Section 7.C.23 to determine if their enactments are materially different 26 from the Model Compact and whether they qualify for participation in the 27 Compact. 28 3. All actions taken for the benefit of the Commission or in furtherance of the purposes of the administration of the Compact prior to 29 30 the effective date of the Compact or the Commission coming into existence

31 shall be considered to be actions of the Commission unless specifically

repudiated by the Commission. 1

2 4. Any State that joins the Compact subsequent to the Commission's 3 initial adoption of the Rules and bylaws shall be subject to the Commission's Rules and bylaws as they exist on the date on which the 4 5 Compact becomes law in that State. Any Rule that has been previously adopted by the Commission shall have the full force and effect of law on 6 7 the day the Compact becomes law in that State.

B. Any Participating State may withdraw from this Compact by 8 9 enacting a statute repealing that State's enactment of the Compact.

10 1. A Participating State's withdrawal shall not take effect until one hundred eighty days after enactment of the repealing statute. 11

12 2. Withdrawal shall not affect the continuing requirement of the 13 withdrawing State's Licensing Authority or Authorities to comply with the investigative and Adverse Action reporting requirements of this Compact 14 15 prior to the effective date of withdrawal.

3. Upon the enactment of a statute withdrawing from this Compact, 16 17 the State shall immediately provide notice of such withdrawal to all Licensees within that State. Notwithstanding any subsequent statutory 18 19 enactment to the contrary, such withdrawing State shall continue to recognize all Compact Privileges to practice within that State granted 20 21 pursuant to this Compact for a minimum of one hundred eighty days after 22 the date of such notice of withdrawal.

23 C. Nothing contained in this Compact shall be construed to 24 invalidate or prevent any licensure agreement or other cooperative 25 arrangement between a Participating State and a non-Participating State that does not conflict with the provisions of this Compact. 26

27 D. This Compact may be amended by the Participating States. No amendment to this Compact shall become effective and binding upon any 28 Participating State until it is enacted into the laws of all 29 30 Participating States.

SECTION 12. CONSTRUCTION AND SEVERABILITY 31

A. This Compact and the Commission's rulemaking authority shall be liberally construed so as to effectuate the purposes, and the implementation and administration of the Compact. Provisions of the Compact expressly authorizing or requiring the promulgation of Rules shall not be construed to limit the Commission's rulemaking authority solely for those purposes.

7 B. The provisions of this Compact shall be severable, and if any phrase, clause, sentence, or provision of this Compact is held by a court 8 9 of competent jurisdiction to be contrary to the constitution of any 10 Participating State, of a State seeking participation in the Compact, or of the United States, or the applicability thereof to any government, 11 12 agency, person, or circumstance is held to be unconstitutional by a court 13 of competent jurisdiction, the validity of the remainder of this Compact and the applicability thereof to any other government, agency, person, or 14 15 circumstance shall not be affected thereby.

C. Notwithstanding subsection B of this section, the Commission may 16 17 deny a State's participation in the Compact or, in accordance with the requirements of Section 10.B, terminate a Participating State's 18 19 participation in the Compact, if it determines that a constitutional 20 requirement of a Participating State is a material departure from the Compact. Otherwise, if this Compact shall be held to be contrary to the 21 22 constitution of any Participating State, the Compact shall remain in full force and effect as to the remaining Participating States and in full 23 24 force and effect as to the Participating State affected as to all 25 severable matters.

## 26 <u>SECTION 13. CONSISTENT EFFECT AND CONFLICT WITH OTHER STATE LAWS</u> 27 <u>A. Nothing herein shall prevent or inhibit the enforcement of any</u> 28 <u>other law of a Participating State that is not inconsistent with the</u> 29 <u>Compact.</u>

B. Any laws, statutes, regulations, or other legal requirements in a
 Participating State in conflict with the Compact are superseded to the

<u>C. All permissible agreements between the Commission and the</u>
Participating States are binding in accordance with their terms.

1 (3) This section shall not apply to a dentist who is an applicant 2 for a dental locum tenens under section 38-1122, to a physician or 3 osteopathic physician who is an applicant for a physician locum tenens 4 under section 38-2036, or to a veterinarian who is an applicant for a 5 veterinarian locum tenens under section 38-3335.

6 (4) An applicant for a temporary educational permit as defined in 7 section 38-2019 shall have ninety days from the issuance of the permit to 8 comply with subsection (1) of this section and shall have such permit 9 suspended after such ninety-day period if the criminal background check 10 is not complete or revoked if the criminal background check reveals that 11 the applicant was not qualified for the permit.
