2	81-2,165.01, 81-2,165.02, 81-2,166, and 81-2,179, Reissue Revised
3	Statutes of Nebraska; to restate legislative intent; to define and
4	redefine terms; to provide a penalty; to create the Pollinator Task
5	Force and provide powers and duties to the task force; to provide
6	duties to the Department of Agriculture, Director of Agriculture,
7	Director of Natural Resources, Director of Environment and Energy,
8	secretary of the Game and Parks Commission, and Director-State
9	Engineer; to require a report; to create the Nebraska Apiary
10	Registry; to provide immunity for certain damages related to bees as
11	prescribed; to harmonize provisions; and to repeal the original
12	sections.

(4) Beekeeper means a person who engages in beekeeping;

(5) (4) Beekeeping means shall mean the moving, raising, 31 and

 condition of egg, larva, pupa, or adult stages of bees;

<u>(11)</u> (10) Exotic disease, parasite, or pest <u>means</u> shall mean any
 disease, parasite, or pest not known to be established in this state;

(12) (11) Hive means shall mean a frame hive, box hive, box, barrel,
 log gum, skep, or any other receptacle or container, natural or
 artificial, or any part thereof, which is used or employed as a domicile
 for bees;

<u>(13) Nucleus means</u> (12) Nuclei shall mean a small mass of bees and
 combs of brood used in forming a new colony;

(14) (13) Parasite means shall mean any harmful organism living in
 or on bees, including, but not limited to, Varroa destructor jacobsoni,
 Acarapis woodi, and Tropilaelaps clareae; and

(15) (14) Pest means shall mean any harmful subspecies of the
 honeybee Apis mellifera, including, but not limited to, Apis mellifera
 scutellata; -

27 (16) Pollinator means any animal that carries pollen from the stamen
 28 of a flower to the pistil of the same or another flower; and

29 (17) Specialty crop has the same meaning as defined in the federal
 30 Specialty Crops Competitiveness Act of 2004, Public Law 108-465, as such
 31 act existed on January 1, 2024.

Words used in the act shall be construed to import either the plural
 or singular, as the case demands.

3 Sec. 4. Section 81-2,179, Reissue Revised Statutes of Nebraska, is
4 amended to read:

5 81-2,179 (1) If the director has reason to believe that any person has violated any provision of the provisions of the Nebraska Apiary Act 6 7 or any rule or regulation rules and regulations adopted and promulgated under the act, the director an order may enter an order be entered 8 9 requiring such person to appear before the director and show cause why an 10 order should not be entered requiring such person to cease and desist from any violation the violations charged. Such order shall set forth any 11 the alleged violation violations, fix the time and place of the hearing, 12 13 and provide for notice to be given at least twenty days before the date of such hearing. After such hearing, if the director finds such person to 14 be in violation, the director shall enter an order requiring such person 15 to cease and desist from the specific acts, practices, or omissions. Such 16 17 order shall be a final order and may be appealed . Any person aggrieved may appeal the order. The appeal shall be in accordance with the 18 19 Administrative Procedure Act.

(2) The director may apply for a restraining order, a temporary or 20 permanent injunction, or a mandatory injunction against any person 21 22 violating or threatening to violate the Nebraska Apiary Act, the rules and regulations adopted and promulgated under the act, or a final order 23 24 of the director. The district court of the county where the violation is 25 occurring or is about to occur shall have jurisdiction to grant such relief upon good cause shown. Relief may be granted notwithstanding the 26 existence of any other remedy at law and shall be granted without bond. 27

(3) It shall be the duty of the Attorney General or the county attorney of the county where a in which any violation occurs or is about to occur when notified by the department of a violation or a threatened violation to institute appropriate proceedings, either criminal,

9	<u>(2) The Pollinator Task Force shall consist of the following</u>
10	members:
11	<u>(a)(i) The Director of Agriculture or a designee of such director</u>
12	from the Department of Agriculture;
13	<u>(ii) The Director of Natural Resources or a designee of such</u>
14	director from the Department of Natural Resources;
15	<u>(iii) The Director of Environment and Energy or a designee of such</u>
16	director from the Department of Environment and Energy;
17	<u>(iv) The director of the Game and Parks Commission as described in</u>
18	section 37-106 or a designee of such director from the Game and Parks
19	<u>Commission; and</u>
20	<u>(v) The Director-State Engineer of the Department of Transportation</u>
21	<u>or a designee of such Director-State Engineer from the Department of</u>
22	Transportation; and
23	(b) The following members appointed by the Director of Agriculture,

8	also a member of a beekeeping club or organization; and
9	<u>(xi) One member of the general public who resides in Nebraska and is</u>
10	not described in subdivisions (2)(b)(i) through (2)(b)(x) of this
11	section.
12	<u>(3)(a) A member who is appointed to the Pollinator Task Force</u>
13	pursuant to subdivision (2)(b) of this section shall serve until the next
14	July 1.
15	(b) A member may be reappointed to successive terms.
16	<u>(c) In the event of a vacancy by a member appointed pursuant to</u>
17	subdivision (2)(b) of this section, the Director of Agriculture shall
18	appoint a replacement member to serve the remainder of the vacating
19	<u>member's term.</u>
20	<u>(4)(a) The Pollinator Task Force shall conduct meetings with a</u>
21	majority of members present at least twice each year.
22	<u>(b) The Director of Agriculture or the designee of the director</u>
23	shall serve as chairperson of the task force.
24	(c) Members of the task force shall serve without compensation, but
25	shall be entitled to receive reimbursement for expenses pursuant to
26	<u>sections 81-1174 to 81-1177.</u>
27	(5) It is the intent of the Legislature that the Pollinator Task
28	Force invite participation from the following individuals at each meeting
29	<u>of the task force:</u>
30	<u>(a) At least one representative of any Indian tribe from Nebraska;</u>
31	(b) At least one representative from the University of Nebraska-

2	<u>(c) At least one representative who is younger than nineteen years</u>
3	of age who participates in an organization that encourages students to
4	<u>engage in agriculture; and</u>
5	<u>(d) Any individual who has expertise in any topic under</u>
6	consideration by the task force.
7	Sec. 6. <u>The purposes of the Pollinator Task Force are to:</u>
8	<u>(1) Annually research existing pollinators in Nebraska and the</u>
9	<u>habitat for such pollinators;</u>
10	<u>(2) Research issues relevant to pollinators in Nebraska and how to</u>
11	resolve those issues; and
12	(3) Work with the Legislature to achieve a healthy and sustainable
13	pollinator population in Nebraska.
14	Sec. 7. <u>(1) The Pollinator Task Force shall examine existing</u>
15	statutes, rules, regulations, policies, and practices in Nebraska and the
16	United States relating to pollinators and pollinator habitat and develop
17	a pollinator plan that includes the following:
18	<u>(a) How the state should focus efforts relating to understanding,</u>
19	preventing, and recovering from pollinator losses;
20	<u>(b) The food production systems in Nebraska that rely on pollinators</u>
21	and the impact on such systems without sufficient pollinators;
22	<u>(c) How the state should develop and coordinate education programs</u>
23	to promote public knowledge about the effects of the loss of pollinators
24	and how private individuals and businesses can help address the loss of
25	pollinators;
26	<u>(d) An evaluation of and potential risk-reduction solutions to</u>
27	pesticide:
28	<u>(i) Use, storage, and disposal, including pesticide-treated seeds;</u>
29	(ii) Nontarget contamination; and
30	<u>(iii) Exposure to pollinators;</u>
31	<u>(e) Recommendations for developing public and private partnerships</u>

1	to encourage pollinator protection and increase the quality and amount of
2	habitat and forage for pollinators;
3	(f) Specific policies and practices that state agencies should adopt
4	to enhance pollinator habitat on state-managed property;
5	<u>(g) Recommendations for promoting availability of native seeds and</u>
6	plants that are beneficial to pollinators;
7	(h) The marketing and promotion of products derived from bees that
8	are kept in Nebraska, including honey, queen bees, bee packages, nucleus
9	colonies, products derived from bees or beekeeping, and products related
10	to support for bees or beekeeping; and
11	(i) Recommendations for legislative, administrative, and budgetary
12	actions necessary to implement the pollinator plan.
13	<u>(2) The Pollinator Task Force shall submit the pollinator plan</u>
14	electronically to the Legislature not later than November 1, 2026, and by
15	<u>November 1 of each year thereafter.</u>
16	Sec. 8. The department may employ one or more individuals to assist
17	the Pollinator Task Force with the following:
18	(1) Apiary inspections; and
19	(2) Research related to apiaries or pollinators.
20	Sec. 9. (1) The Nebraska Apiary Registry is created.
21	<u>(2) The Nebraska Apiary Registry shall be administered by the</u>
22	<u>department.</u>
23	<u>(3)(a) Beginning on January 1, 2025, each person keeping an apiary</u>
24	shall annually register each apiary with the department and provide the
25	following information by April 30 of each year and, for any apiary
26	acquired after April 1 of each year, within thirty days after acquiring
27	<u>such apiary:</u>
28	<u>(i) The name and contact information of the person keeping the</u>
29	<u>apiary;</u>
30	(ii) The location of each apiary kept by the person; and
31	(iii) The number of colonies and nuclei at each apiary.

1	(b) The department shall collect the following fees each year with
2	each registration and remit such fees to the State Treasurer for credit
3	to the State Apiary Cash Fund:
4	<u>(i)(A) For a veteran, ten dollars;</u>
5	<u>(B) For a person sixty-five years of age or older, ten dollars; and</u>
6	(C) For any person not described in subdivision (3)(b)(i)(A) or (3)
7	<pre>(b)(i)(B) of this section, fifteen dollars; and</pre>
8	<u>(ii) For each apiary location, one dollar.</u>
9	(4) Except as provided in subsection (5) of this section and section
10	<u>10 of this act, the information provided for registration on the Nebraska</u>
11	<u>Apiary Registry and all related documents are confidential, are not</u>
12	considered public records subject to disclosure pursuant to sections
13	<u>84-712 to 84-712.09, are not subject to subpoena, are privileged and</u>
14	<u>inadmissible in evidence in any legal proceeding of any kind or</u>
15	character, and shall not be disclosed to any other department or agency
16	<u>of the State of Nebraska.</u>
17	<u>(5) The department and faculty from the University of Nebraska may</u>
18	access and utilize information in the Nebraska Apiary Registry for the
19	following purposes:
20	<u>(a) Research;</u>
21	(b) Increasing the profitability of beekeepers;
22	(c) Providing support services to beekeepers;
23	<u>(d) Promoting bee health; and</u>
24	<u>(e) Developing best-management practices to protect pollinators in</u>
25	<u>Nebraska.</u>
26	<u>(6) The department shall notify any person keeping an apiary that is</u>
27	registered on the Nebraska Apiary Registry of any disease, parasite, or
28	<u>pest outbreak detected within a five-mile radius of the registered</u>
29	<u>apiary.</u>
30	(7) The department may adopt and promulgate rules and regulations to
31	<u>administer the Nebraska Apiary Registry.</u>

1	Sec. 10. <u>A person keeping an apiary that is registered with the</u>
2	<u>Nebraska Apiary Registry:</u>
3	<u>(1) Except for gross negligence or intentional wrongful acts, shall</u>
4	<u>not be liable for any injury related to one or more bees stinging a</u>
5	<u>person or otherwise causing damage within a two-mile radius of such</u>
6	apiary; and
7	<u>(2) May request the department to provide proof of registration to a</u>
8	party in any suit for damages, and the department shall comply with such
9	<u>request.</u>
10	Sec. 11. Original sections 81-2,165.01, 81-2,165.02, 81-2,166, and
11	81-2,179, Reissue Revised Statutes of Nebraska, are repealed.
