Committee:

- 1 A BILL FOR AN ACT relating to state government; to require pay increases
- for state employees to recognize length of service; and to provide a
- 3 duty for the Revisor of Statutes.
- 4 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) The purpose of this section is to provide pay
- 2 <u>increases to state employees to recognize their commitment to the State</u>
- 3 of Nebraska. Such pay increases shall be based on the length of service
- 4 of state employees and shall be in addition to any other pay increase
- 5 provided for in state law or in any collective bargaining agreement.
- 6 (2) For purposes of this section:
- 7 (a) Date of hire means the date a state employee begins employment
- 8 with the State of Nebraska; and
- 9 (b) State employee means any person or officer who is employed by
- 10 the state including the head of any department or agency, except when
- 11 <u>such a head is a board or commission, and who works a full-time or part-</u>
- 12 <u>time schedule on an ongoing basis.</u>
- 13 (3) Each state employee shall be entitled to the following pay
- 14 <u>increases:</u>
- 15 <u>(a) A pay increase of \$.0625 per hour, or its equivalent for a</u>
- 16 salaried employee, on the fifth anniversary of his or her date of hire;
- 17 (b) A pay increase of \$.125 per hour, or its equivalent for a
- 18 salaried employee, on the tenth anniversary of his or her date of hire;
- 19 <u>(c) A pay increase of \$.1875 per hour, or its equivalent for a</u>
- 20 <u>salaried employee, on the fifteenth anniversary of his or her date of</u>
- 21 <u>hire;</u>
- 22 (d) A pay increase of \$.25 per hour, or its equivalent for a
- 23 <u>salaried employee, on the twentieth anniversary of his or her date of</u>
- 24 hire;
- 25 (e) A pay increase of \$.3125 per hour, or its equivalent for a
- 26 <u>salaried employee, on the twenty-fifth anniversary of his or her date of</u>
- 27 hire;
- 28 (f) A pay increase of \$.375 per hour, or its equivalent for a
- 29 <u>salaried employee</u>, on the thirtieth anniversary of his or her date of
- 30 <u>hire;</u>
- 31 (g) A pay increase of \$.4375 per hour, or its equivalent for a

1 salaried employee, on the thirty-fifth anniversary of his or her date of

- 2 <u>hire; and</u>
- 3 (h) A pay increase of \$.50 per hour, or its equivalent for a
- 4 salaried employee, on the fortieth anniversary of his or her date of
- 5 hire.
- 6 (4) If a state employee is employed with the state on the effective
- 7 date of this act, his or her service with the state prior to such date
- 8 shall count for purposes of this section, but he or she shall not receive
- 9 <u>a pay increase for any anniversary date described in subsection (3) of</u>
- 10 this section that has already passed.
- 11 (5) The Director of Personnel may adopt and promulgate such rules
- 12 and regulations as are necessary to administer this section.
- 13 Sec. 2. The Revisor of Statutes shall assign section 1 of this act
- 14 to Chapter 81, article 13.
