## Committee:

- 1 A BILL FOR AN ACT relating to the Medical Assistance Act; to amend
- 2 section 68-901, Revised Statutes Supplement, 2019; to provide for a
- diabetes pilot study; and to repeal the original section.
- 4 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 68-901, Revised Statutes Supplement, 2019, is

- 2 amended to read:
- 3 68-901 Sections 68-901 to 68-994 and section 2 of this act shall be
- 4 known and may be cited as the Medical Assistance Act.
- 5 Sec. 2. (1) The Department of Health and Human Services shall
- 6 administer a diabetes pilot study by awarding a competitive grant to a
- 7 postsecondary institution having a college of medicine and located in the
- 8 State of Nebraska to conduct the pilot study. The pilot study shall
- 9 identify ways to reduce the financial costs of diabetes to the medical
- 10 assistance program.
- 11 <u>(2) The grant recipient shall:</u>
- 12 (a) Test the hypothesis that the integration of technology into the
- 13 case management protocol of a patient with diabetes in the medical
- 14 <u>assistance program, including use of remotely monitored glucose sensors,</u>
- 15 <u>interdisciplinary coaching</u>, and telehealth communication, will lead to
- 16 improved health outcomes and decreased health care costs;
- 17 (b) Use technology-based platforms for the delivery of effective
- 18 diabetes self-management education, support, and treatment for up to one
- 19 thousand diabetic patients receiving funds under the medical assistance
- 20 program;
- 21 <u>(c) Conduct the study statewide;</u>
- 22 (d) Compile data on patients described in subdivision (b) of this
- 23 <u>subsection and patients receiving standard diabetes care and compare and</u>
- 24 <u>analyze the data;</u>
- 25 (e) Make recommendations to the Legislature on policy changes to
- 26 improve population health management for patients with diabetes in the
- 27 <u>medical assistance program and reduce costs in such population; and</u>
- 28 (f) Maintain patient confidentiality.
- 29 <u>(3) The Department of Health and Human Services and the Department</u>
- 30 of Administrative Services shall provide necessary data to the grant
- 31 recipient to carry out the study.

- 1 (4) The grant recipient shall submit a report electronically to the
- 2 Appropriations Committee of the Legislature and the Health and Human
- 3 Services Committee of the Legislature on or before December 1 of each
- 4 year beginning in 2021 through 2024 and shall submit a final report
- 5 <u>electronically to such committees on or before July 1, 2025.</u>
- 6 (5) It is the intent of the Legislature to appropriate two million
- 7 dollars for each fiscal year for FY2020-21, FY2021-22, FY2022-23,
- 8 FY2023-24, and FY2024-25 from the General Fund for the diabetes pilot
- 9 study.
- 10 (6) The diabetes pilot study terminates on July 1, 2025.
- 11 Sec. 3. Original section 68-901, Revised Statutes Supplement, 2019,
- 12 is repealed.
