- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 37-327.03, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 37-327.03 The Game and Parks State Park Improvement and Maintenance
- 4 Fund is created. The fund shall consist of transfers made by the
- 5 Legislature, money credited to the fund pursuant to section 9 of this
- 6 act, and any gifts, grants, bequests, or donations to the fund. Money in
- 7 the fund shall be used to build, repair, renovate, rehabilitate, restore,
- 8 modify, or improve any infrastructure in the state park system. The
- 9 proceeds remitted to the fund pursuant to section 9 of this act shall be
- 10 used only for the improvement and maintenance of state recreational
- 11 trails as defined in section 37-338. Any money in the fund available for
- 12 investment shall be invested by the state investment officer pursuant to
- 13 the Nebraska Capital Expansion Act and the Nebraska State Funds
- 14 Investment Act.

- 20 amended to read:
- 21 60-393 Any owner who has two or more motor vehicles or trailers
- 22 required to be registered under the Motor Vehicle Registration Act may
- 23 register all such motor vehicles or trailers on a calendar-year basis or
- 24 on an annual basis for the same registration period beginning in a month
- 25 chosen by the owner. When electing to establish the same registration
- 26 period for all such motor vehicles or trailers, the owner shall pay the
- 27 registration fee, the motor vehicle tax imposed in section 60-3,185, the
- 28 motor vehicle fee imposed in section 60-3,190, and the alternative fuel
- 29 fee imposed in section 60-3,191 on each motor vehicle for the number of
- 30 months necessary to extend its current registration period to the
- 31 registration period under which all such motor vehicles or trailers will

- 1 be registered. Credit shall be given for registration paid on each motor
- 2 vehicle or trailer when the motor vehicle or trailer has a later
- 3 expiration date than that chosen by the owner except as otherwise
- 4 provided in sections 60-3,121, 60-3,122.02, 60-3,122.04, 60-3,128,
- 5 60-3,224, 60-3,227, 60-3,233, 60-3,235, 60-3,238, 60-3,240, 60-3,242, and
- 6 60-3,244 and section 9 of this act. Thereafter all such motor vehicles or
- 7 trailers shall be registered on an annual basis starting in the month
- 8 chosen by the owner.

- 1 to be illegal or ineligible to be operated or towed on the public roads
- 2 and no longer subject to registration fees, the motor vehicle tax imposed
- 3 in section 60-3,185, the motor vehicle fee imposed in section 60-3,190,
- 4 and the alternative fuel fee imposed in section 60-3,191;
- 5 (e) Upon a trade-in or surrender of a motor vehicle under a lease;
- 6 or
- 7 (f) In case of a change in the situs of a motor vehicle or trailer
- 8 to a location outside of this state.
- 9 (2) If the date of the event falls within the same calendar month in
- 10 which the motor vehicle or trailer is acquired, no refund shall be
- 11 allowed for such month.
- 12 (3) If the transferor or lessee acquires another motor vehicle at
- 13 the time of the transfer, trade-in, or surrender, the transferor or
- 14 lessee shall have the credit provided for in this section applied toward
- 15 payment of the motor vehicle fees and taxes then owing. Otherwise, the
- 16 transferor or lessee shall file a claim for refund with the county
- 17 treasurer upon an application form prescribed by the department.
- 18 (4) The registered owner or lessee shall make a claim for refund or
- 19 credit of the fees and taxes for the unexpired months in the registration
- 20 period within sixty days after the date of the event or shall be deemed
- 21 to have forfeited his or her right to such refund or credit.
- 22 (5) For purposes of this section, the date of the event shall be:
- 23 (a) In the case of a transfer or loss, the date of the transfer or loss;
- 24 (b) in the case of a change in the situs, the date of registration in
- 25 another state; (c) in the case of a trade-in or surrender under a lease,
- 26 the date of trade-in or surrender; (d) in the case of a legislative act,
- 27 the effective date of the act; and (e) in the case of a court decision,
- 28 the date the decision is rendered.
- 29 (6) Application for registration or for reassignment of license
- 30 plates and, when appropriate, validation decals to another motor vehicle
- 31 or trailer shall be made within thirty days of the date of purchase.

- 1 (7) If a motor vehicle or trailer was reported stolen under section 2 60-178, a refund under this section shall not be reduced for a lost plate 3 charge and a credit under this section may be reduced for a lost plate 4 charge but the applicant shall not be required to pay the plate fee for 5 new plates.
- 6 (8) The county treasurer shall refund the motor vehicle fee and
 7 registration fee from the fees which have not been transferred to the
 8 State Treasurer. The county treasurer shall make payment to the claimant
 9 from the undistributed motor vehicle taxes of the taxing unit where the
 10 tax money was originally distributed. No refund of less than two dollars
 11 shall be paid.

- 3 replacement motor vehicle, trailer, or semitrailer is so registered, the
- 4 county treasurer shall forward the application and affidavit, if any, to
- 5 the State Treasurer who shall determine the amount, if any, of the
- 6 allowable credit for the registration fee and issue a credit certificate
- 7 to the owner. For the motor vehicle tax and fee, the county treasurer
- 8 shall determine the amount, if any, of the allowable credit and issue a
- 9 credit certificate to the owner. When such motor vehicle, trailer, or
- 10 semitrailer is removed from service within the same month in which it was
- 11 registered, no credits shall be allowed for such month. The credits may
- 12 be applied against taxes and fees for new or replacement motor vehicles,
- 13 trailers, or semitrailers incurred within one year after cancellation of
- 14 registration of the motor vehicle, trailer, or semitrailer for which the
- 15 credits were allowed. When any such motor vehicle, trailer, or
- 16 semitrailer is reregistered within the same registration year in which
- 17 its registration has been canceled, the taxes and fees shall be that
- 18 portion of the registration fee and the motor vehicle tax and fee for the
- 19 remainder of the registration year.

- 13 the Motor Vehicle Registration Act, each application for initial issuance
- 14 or renewal of alphanumeric The Good Life Is Outside Plates shall be
- 15 <u>accompanied by a fee of five dollars. County treasurers collecting fees</u>
- 16 pursuant to this subdivision shall remit such fees to the State
- 17 Treasurer. The State Treasurer shall credit five dollars of the fee to
- 18 the Game and Parks State Park Improvement and Maintenance Fund for the
- 19 purpose of trail improvement and maintenance.
- 20 <u>(b) In addition to all other fees required for registration under</u>
- 21 the Motor Vehicle Registration Act, each application for initial issuance
- 22 or renewal of personalized message The Good Life Is Outside Plates shall
- 23 be accompanied by a fee of forty dollars. County treasurers collecting
- 24 fees pursuant to this subdivision shall remit such fees to the State
- 25 Treasurer. The State Treasurer shall credit twenty-five percent of the
- 26 <u>fee for initial issuance and renewal of such plates to the Department of</u>
- 27 <u>Motor Vehicles Cash Fund and seventy-five percent of the fee to the Game</u>
- 28 and Parks State Park Improvement and Maintenance Fund for the purpose of
- 29 <u>trail improvement and maintenance.</u>
- 30 (3) When the department receives an application for The Good Life Is
- 31 Outside Plates, the department may deliver the plates and registration

1 certificate to the applicant by United States mail or to the county

- 2 treasurer of the county in which the motor vehicle, trailer, or
- 3 semitrailer is registered and the delivery of the plates and registration
- 4 certificate shall be made through a secure process and system. The county
- 5 treasurer or the department shall issue The Good Life Is Outside Plates
- 6 in lieu of regular license plates when the applicant complies with the
- 7 other provisions of the Motor Vehicle Registration Act for registration
- 8 of the motor vehicle, trailer, or semitrailer. If The Good Life Is
- 9 Outside Plates are lost, stolen, or mutilated, the licensee shall be
- 10 <u>issued replacement license plates upon request pursuant to section</u>
- 11 <u>60-3,157.</u>
- 12 <u>(4) The county treasurer or the department may issue temporary</u>
- 13 license stickers to the applicant under this section for the applicant to
- 14 lawfully operate the vehicle pending receipt of the license plates. No
- 15 charge in addition to the registration fee shall be made for the issuance
- 16 of a temporary license sticker under this subsection. The department
- 17 shall furnish temporary license stickers for issuance by the county
- 18 treasurer at no cost to the counties. The department may adopt and
- 19 promulgate rules and regulations regarding the design and issuance of
- 20 <u>temporary license stickers.</u>
- 21 (5) The owner of a motor vehicle, trailer, or semitrailer bearing
- 22 The Good Life Is Outside Plates may apply to the county treasurer to have
- 23 such plates transferred to a motor vehicle, trailer, or semitrailer other
- 24 than the motor vehicle, trailer, or semitrailer for which such plates
- 25 were originally purchased if such motor vehicle, trailer, or semitrailer
- 26 <u>is owned by the owner of the plates. The owner may have the unused</u>
- 27 portion of the fee for the plates credited to the other motor vehicle,
- 28 trailer, or semitrailer which will bear the plates at the rate of eight
- 29 and one-third percent per month for each full month left in the
- 30 registration period. Application for such transfer shall be accompanied
- 31 by a fee of three dollars. Fees collected pursuant to this subsection

1 <u>shall be remitted to the State Treasurer for credit to the Department of</u>

- 2 <u>Motor Vehicles Cash Fund.</u>
- 3 (6) If the cost of manufacturing The Good Life Is Outside Plates at
- 4 any time exceeds the amount charged for license plates pursuant to
- 5 section 60-3,102, any money to be credited to the Game and Parks State
- 6 Park Improvement and Maintenance Fund shall instead be credited first to
- 7 the Highway Trust Fund in an amount equal to the difference between the
- 8 manufacturing costs of The Good Life Is Outside Plates and the amount
- 9 charged pursuant to section 60-3,102 with respect to such plates and the
- 10 remainder shall be credited to the Game and Parks State Park Improvement
- 11 <u>and Maintenance Fund for the purpose of trail improvement and</u>
- 12 <u>maintenance.</u>
