A BILL

- 1 FOR AN ACT relating to state government; to establish state fleet
- 2 card programs and create a fund.
- 3 Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) State fleet card programs shall be created 2 and shall be administered separately by the University of Nebraska and by the Department of Roads. The Department of Roads shall 3 4 administer a fleet card program on behalf of state government other 5 than the University of Nebraska under a contract through the State 6 Treasurer. The State Treasurer shall determine the type of fleet card 7 or cards utilized in the state fleet card program. The State 8 Treasurer shall contract with one or more financial institutions, 9 card-issuing banks, credit card companies, charge card companies, 10 debit card companies, or third-party merchant banks capable of operating a fleet card program on behalf of the state, including the 11 12 University of Nebraska, and political subdivisions that participate 13 in the state contract for such services. Rules and regulations may be adopted and promulgated as needed for the operation of the state 14 15 fleet card programs. The rules and regulations shall provide 16 authorization instructions for all transactions. Expenses associated 17 with the state fleet card programs shall be considered as an 18 administrative or operational expense. (2) For purposes of this section, fleet card means a 19 20 payment card used for gasoline, diesel, and other fuels. Fleet cards 21 may also be used to pay for vehicle maintenance and expenses at the 22 discretion of the program administrator. 23 (3) Any state official, state agency, or political 24 subdivision may utilize the state fleet card for the purchase of goods and services for and on behalf of the State of Nebraska. No 25

1 <u>disbursements or cash back on fleet card transactions shall be</u>

- 2 allowed.
- 3 (4) Vendors accepting a state fleet card shall obtain
- 4 <u>authorization for all transactions in accordance with instructions</u>
- 5 from the program administrator. Transaction authorization shall be
- 6 from the financial institution, card-issuing bank, credit card
- 7 company, charge card company, debit card company, or third-party
- 8 merchant bank contracted to provide such service to the State of
- 9 Nebraska. Each transaction shall be authorized in accordance with the
- 10 <u>instructions provided by each state official, state agency, or</u>
- 11 political subdivision.
- 12 (5) Detailed transaction information for the purposes of
- 13 tracking expenditures shall include fleet card identification,
- 14 merchant name and address, transaction number, date, time, product,
- 15 quantity, cost, and equipment meter reading if applicable. A state
- 16 <u>fleet card program may require an itemized receipt for purposes of</u>
- 17 tracking expenditures of a state fleet card purchase from a
- 18 commercial vendor as acceptable detailed transaction information. If
- 19 detailed transaction information is not provided, the program
- 20 administrator shall have the authority to temporarily or permanently
- 21 suspend state fleet card purchases in accordance with rules and
- 22 <u>regulations</u>.
- 23 <u>(6) Upon termination or suspension of employment of an</u>
- 24 <u>individual using a state fleet card, such individual's state fleet</u>
- 25 card account shall be immediately closed and he or she shall return

1 the state fleet card to the agency from which it was obtained.

- 2 (7) No officer or employee of the state shall use a state
- 3 fleet card for any unauthorized use as determined by the rules and
- 4 regulations.
- 5 Sec. 2. The State Fleet Card Distributive Fund is 6 created. All rebates received by the state from the fleet card 7 program entered into by the State of Nebraska pursuant to section 1 8 of this act, except for rebates received from the fleet card program 9 of the University of Nebraska, shall be credited to the fund. The 10 fund may consist of fleet card rebates received on behalf of state agencies, boards, commissions, and political subdivisions and shall 11 12 be administered by the State Treasurer. Fleet card rebates shall be 13 distributed by the State Treasurer, consistent with volume spent and contract terms, to: (1) The University of Nebraska; (2) any political 14 15 subdivision participating in the state fleet card program; and (3) 16 the State Treasurer for distribution to the remainder of state 17 government. The State Treasurer or his or her designee is authorized to distribute through the fund or through a vendor contractual 18

agreement the remaining program rebates. Rebates received by the

vendor after the effective date of this act shall be disbursed to

participating entities under the contract consistent with volume
