- the teacher has signed a contract to complete such teacher's second 8
- 9 complete school year of full-time employment as a teacher at a Nebraska
- school in school year 2023-24, 2024-25, 2025-26, or 2026-27; 10
- (b) A retention two grant of two thousand five hundred dollars if 11
- the teacher has signed a contract to complete such teacher's fourth 12
- 13 complete school year of full-time employment as a teacher at a Nebraska
- school in school year 2023-24, 2024-25, 2025-26, or 2026-27; 14
- (c) A retention three grant of two thousand five hundred dollars if 15
- the teacher has signed a contract to complete such teacher's sixth 16
- 17 complete school year of full-time employment as a teacher at a Nebraska
- school in school year 2023-24, 2024-25, 2025-26, or 2026-27; and 18
- (d)(i) A high-need retention grant of five thousand dollars if on or 19
- after June 2, 2023, a teacher: 20
- (A) Obtains an endorsement in special education, mathematics, 21
- 22 science, technology, or dual credit; and
- (B)(I) For an application submitted prior to the effective date of 23
- 24 this act, signs (B) Signs a contract to complete a school year of full-
- 25 time employment as a teacher at a Nebraska school in school year 2024-25,
- 2025-26, or 2026-27; or -26
- (II) For an application submitted on or after the effective date of 27
- this act, signs a contract to complete a school year of full-time 28
- employment as a teacher to teach in such endorsement area at a Nebraska 29
- school in school year 2024-25, 2025-26, or 2026-27. 30
- (ii) A teacher shall only be eligible to receive one high-need 31
