LEGISLATIVE RESOLUTION 283CA

PROPOSED CONSTITUTIONAL AMENDMENT

Introduced by Cavanaugh, M., 6.

Read first time January 17, 2024

Committee:

- 1 THE MEMBERS OF THE ONE HUNDRED EIGHTH LEGISLATURE OF NEBRASKA,
- 2 SECOND SESSION, RESOLVE THAT:
- 3 Section 1. At the general election in November 2024 the following
- 4 proposed amendment to the Constitution of Nebraska shall be submitted to
- 5 the electors of the State of Nebraska for approval or rejection:
- To amend Article III, sections 7 and 19, and add a new section 31 to
- 7 Article III:
- 8 III-7 At the general election to be held in November 1964, one-half
- 9 the members of the Legislature, or as nearly thereto as may be
- 10 practicable, shall be elected for a term of four years and the remainder
- 11 for a term of two years, and thereafter all members shall be elected for
- 12 a term of four years, with the manner of such election to be determined
- 13 by the Legislature. When the Legislature is redistricted, the members
- 14 elected prior to the redistricting shall continue in office, and the law
- 15 providing for such redistricting shall where necessary specify the newly
- 16 established district which they shall represent for the balance of their
- 17 term. Each member shall be nominated and elected in a nonpartisan manner
- 18 and without any indication on the ballot that he or she is affiliated
- 19 with or endorsed by any political party or organization. Each member of
- 20 the Legislature shall receive a salary of not to exceed one thousand
- 21 dollars per month during the term of his or her office until July 1,
- 22 2025. In addition to his or her salary, each member shall receive an
- 23 amount equal to his or her actual expenses in traveling by the most usual

- 1 route once to and returning from each regular or special session of the
- 2 Legislature. Members of the Legislature shall receive no pay nor
- 3 perquisites other than his or her salary and expenses, and employees of
- 4 the Legislature shall receive no compensation other than their salary or
- 5 per diem.
- 6 III-19 The Legislature shall never grant any extra compensation to
- 7 any public officer, agent, or servant after the services have been
- 8 rendered nor to any contractor after the contract has been entered into,
- 9 except that retirement benefits of retired public officers and employees
- 10 may be adjusted to reflect changes in the cost of living and wage levels
- 11 that have occurred subsequent to the date of retirement.
- 12 The compensation of any public officer, including any officer whose
- 13 compensation is fixed by the Legislature, shall not be increased or
- 14 diminished during his or her term of office, except that when there are
- 15 members elected or appointed to the Legislature or the judiciary, or
- 16 officers elected or appointed to a board or commission having more than
- 17 one member, and the terms of such members commence and end at different
- 18 times, the compensation of all members of the Legislature, of the
- 19 judiciary, or of such board or commission may be increased or diminished
- 20 at the beginning of the full term of any member thereof.
- 21 Nothing in this section shall prevent local governing bodies from
- 22 reviewing and adjusting vested pension benefits periodically as
- 23 prescribed by ordinance.
- 24 The surviving spouse of any retired public officer, agent, or
- 25 servant, who has retired under a pension plan or system, shall be
- 26 considered as having pensionable status and shall be entitled to the same
- 27 benefits which may, at any time, be provided for or available to spouses
- 28 of other public officers, agents, or servants who have retired under such
- 29 pension plan or system at a later date, and such benefits shall not be
- 30 prohibited by the restrictions of this section or of Article XIII,
- 31 section 3 of the Constitution of Nebraska.

- 1 <u>III-31</u> (1) The salary of members of the Legislature shall be
- 2 prescribed by the Legislative Salary Commission.
- 3 (2) The members of the commission shall be one person from each
- 4 congressional district appointed by the Chief Justice of the Supreme
- 5 <u>Court and one member from each congressional district appointed by the</u>
- 6 Governor. If Nebraska has an odd number of congressional districts, the
- 7 Governor and the Chief Justice shall each appoint an at-large member in
- 8 <u>addition to a member from each congressional district.</u>
- 9 (3) No more than one-half of the members appointed by the Governor
- 10 may be affiliated with the same political party. No more than one-half of
- 11 the members appointed by the Chief Justice may be affiliated with the
- 12 <u>same political party.</u>
- 13 (4) The following individuals shall be ineligible to be a member of
- 14 the commission:
- 15 (a) A current or former member of the Legislature or a spouse of a
- 16 current or former member of the Legislature;
- 17 (b) A current or former lobbyist registered under Nebraska law;
- 18 (c) A current employee of the Legislature;
- 19 (d) A current or former judge of any court in Nebraska;
- 20 <u>(e) A current or former Governor, Lieutenant Governor, Attorney</u>
- 21 General, Secretary of State, Auditor of Public Accounts, or State
- 22 Treasurer for the State of Nebraska; and
- 23 (f) A current employee of the State of Nebraska.
- 24 (5) The Legislature shall provide for the terms of office,
- 25 compensation, and procedure for removal of the members of the commission.
- 26 (6) The commission shall prescribe the salary for members of the
- 27 Legislature by March 31 of each odd-numbered year, taking into account
- 28 any other legislative compensation provided to members of the Legislature
- 29 by the State of Nebraska, with any changes in salary to take effect on
- 30 July 1 of that year.
- 31 Sec. 2. The proposed amendment shall be submitted to the electors

- 1 in the manner prescribed by the Constitution of Nebraska, Article XVI,
- 2 section 1, with the following ballot language:
- 3 A constitutional amendment to create the Legislative Salary
- 4 Commission and change provisions relating to legislative salaries.
