SUMMARY

Synopsis: Requires minimum level of police staffing based on municipal

population and violent crime rate.

Type of Impact: Annual municipal expenditure increase.

Agencies Affected: Municipalities.

- The Office of Legislative Services (OLS) estimates that the bill will result in an annual expenditure increase of at least \$376.8 million for 17 municipalities that will have to hire additional police officers in order to comply with the provisions of the bill.
- Actual costs in each year are likely to be higher because this estimate does not include any
 equipment or training expenses, nor does it include future costs associated with overtime pay
 or negotiated adjustments to salaries or benefits.
- This estimate is based on data as of a certain point in time. Costs to municipalities will vary with changes in population, crime rate, and police force staffing.

BILL DESCRIPTION

This bill requires municipalities in New Jersey with a population of more than 60,000 people and a violent crime rate exceeding 10 per 1,000 residents, as reported in the Uniform Crime Report published by the Department of Law and Public Safety, to maintain a full-time police department comprised of at least four police officers per 1,000 residents. The Uniform Crime Report identifies murder, rape, robbery, and aggravated assault as violent crimes.



FISCAL ANALYSIS

EXECUTIVE BRANCH

According to information from the Department of Law and Public Safety, which was based on data compiled out of the 2020 Uniform Crime Report, there were 18 New Jersey municipalities with a population over 60,000 and a crime index greater than 10 per 1,000 residents:

OFFICE OF LEGISLATIVE SERVICES

The OLS estimates that the bill will result in an annual expenditure increase of at least \$376.8 million for 17 municipalities that will have to hire additional police officers in order to comply with the provisions of the bill. Actual costs in each year are likely to be higher because this estimate does not include any equipment or training expenses, nor does it include future costs associated with overtime pay or negotiated adjustments to salaries or benefits.

Based on the criteria set forth in the bill, population statistics from the 2020 U.S. Census, and violent crime rates from the 2020 Uniform Crime Report, the OLS concludes that there are 18 municipalities in the State that meet the thresholds established in the bill, 17 of which will have to increase the number of police officers on their forces by a combined total of 3,110 additional officers, as shown in the table below. According to the July 1, 2021 New Jersey Police and Firemen's Retirement System actuarial valuation report, the average starting salary for a local police officer is \$60,127. Factoring in the fringe benefit rate of 101.5 percent, total employer personnel costs for a new officer would be \$121,156 on average. The affected municipalities will also incur upfront training costs for new officers and additional equipment costs, including vehicular equipment and body cameras, which are not reflected in this cost estimate.
