AN ACT

RELATING TO FORFEITURES; PROVIDING FOR FORFEITURE OF REAL
PROPERTY USED IN THE COMMISSION OF A FELONY OFFENSE IN
VIOLATION OF THE CONTROLLED SUBSTANCES ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 30-31-34 NMSA 1978 (being Laws 1972,
Chapter 84, Section 33, as amended) is amended to read:

"30-31-34. FORFEITURES--PROPERTY SUBJECT.--The following
are subject to forfeiture:

A. all controlled substances and all controlled
substance analogs [~~which~~] that have been manufactured,
distributed, dispensed or acquired in violation of the
Controlled Substances Act;

B. all raw materials, products and equipment of any
kind, including firearms [~~which~~] that are used or intended for

1 use in manufacturing, compounding, processing, delivering,
2 importing or exporting any controlled substance or controlled
3 substance analog in violation of the Controlled Substances Act;

7 D. all conveyances, including aircraft, vehicles or
8 vessels ~~[which]~~ that are used or intended for use to transport
9 or in any manner to facilitate the transportation for the
10 purpose of sale of property described in Subsection A or B of
11 this section;

12 E. all books, records and research products and
13 materials, including formulas, microfilm, tapes and data
14 ~~[which]~~ that are used or intended for use in violation of the
15 Controlled Substances Act;

16 F. all real property, including any right, title
17 and interest in any lot or tract of land and any appurtenances
18 or improvements, that is used or intended to be used, in any
19 manner or part, to commit or to facilitate the commission of a
20 felony offense in violation of the Controlled Substances Act;

2 carrier is subject to forfeiture under this section unless it
3 appears that the owner or other person in charge of the
4 conveyance is a consenting party or privy to a violation of the

6 (2) no conveyance or real property is subject
7 to forfeiture under this section by reason of ~~[any]~~ an act or
8 omission established for the owner to have been committed or
9 omitted without ~~[his]~~ the owner's knowledge or consent;

10 (3) a conveyance is not subject to forfeiture
11 for a violation of law the penalty for which is a misdemeanor;
12 and

13 (4) a forfeiture of a conveyance or real
14 property encumbered by a bona fide security interest shall be
15 subject to the interest of a secured party if the secured party
16 neither had knowledge of nor consented to the act or omission;
17 and

18 ~~[H.]~~ I. all drug paraphernalia as defined by
19 Subsection ~~[W]~~ V of Section 30-31-2 NMSA 1978."

20 **SECTION 2. EFFECTIVE DATE.**--The effective date of the
21 provisions of this act is July 1, 2011.
