AN ACT

RELATING TO PUBLIC EDUCATION; REQUIRING THE PUBLIC EDUCATION DEPARTMENT TO CONVENE A WORKING GROUP TO STUDY A BILITERACY AND ORAL LANGUAGE DEVELOPMENT FRAMEWORK; MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. TEMPORARY PROVISION--BILITERACY AND ORAL LANGUAGE DEVELOPMENT FRAMEWORK WORKING GROUP--MEMBERS-- PURPOSE--DUTIES.--

A. The public education department shall convene a "biliteracy and oral language development framework working group" that includes local experts in culturally and linguistically responsive instruction, tribal language experts designated by participating tribes, service providers, including special education providers, universities, school districts, charter schools and other education providers

1 and administrators that are successfully implementing a
2 biliteracy and oral language development framework. The
3 working group shall function from the date of its appointment
4 until December 1, 2021.

5 B. Members of the working group who are not paid
6 with public money are entitled to per diem and mileage as
7 provided in the Per Diem and Mileage Act and shall receive no
8 other compensation, perquisite or allowance.

9 C. The purpose of the working group is to:

10 (1) study potential statewide frameworks that
11 will provide all public school students with access to a
12 culturally and linguistically responsive education;

13 (2) identify a biliteracy and oral language
14 development framework that will improve the biliteracy rate and
15 indigenous oral language development comprehension levels in
16 New Mexico and help students become college and career ready;

17 (3) identify research-based pre-kindergarten
18 through twelfth grade biliteracy frameworks in English and
19 Spanish for public school students in developmental bilingual
20 multicultural education programs in New Mexico;

21 (4) identify best practices for oral language
22 development that respect, honor and promote indigenous
23 languages; and

24 (5) study biliteracy framework implementation
25 and oral language development practices for indigenous language

1 instruction so as to provide guidance on the biliteracy
2 framework and appropriate professional development to support
3 school districts and charter schools that are implementing or
4 choosing to implement developmental bilingual multicultural
5 education program models.

6 D. In carrying out its charge, the working group
7 shall:

8 (1) identify and study biliteracy and oral
9 language development frameworks that align with the state's
10 pre-kindergarten through twelfth grade English and Spanish
11 language arts standards and that are culturally and
12 linguistically responsive and have proven successful in
13 developing language and academic proficiency in English and
14 Spanish;

15 (2) for indigenous languages:

16 (a) identify and study biliteracy
17 frameworks for indigenous languages that utilize indigenous
18 literacy; and

19 (b) identify and study approaches that
20 are used for indigenous languages that focus primarily on oral
21 language development with input from tribal language experts
22 and tribal communities; and

23 (3) focus on how and why identified frameworks
24 have been successful, and identify which culturally and
25 linguistically responsive curriculum, assessment, instructional

1 materials and professional development have best supported the
2 implementation of biliteracy and oral language development
3 frameworks that provide biliteracy skills and indigenous oral
4 language skills for public school students.

5 E. The working group shall publish a final report
6 regarding biliteracy and oral language development frameworks
7 in New Mexico, including why identified frameworks have been
8 successful and how state standards for Spanish language arts
9 should align with the state's pre-kindergarten through twelfth
10 grade biliteracy and oral language development framework. For
11 indigenous languages, the report shall identify key findings
12 regarding instructional approaches that best meet the purposes
13 for indigenous language instruction including native literacy,
14 where an indigenous language is used for that purpose, and
15 native languages that focus primarily on oral language
16 instruction. The report shall provide recommendations on the
17 biliteracy and oral language development frameworks and
18 appropriate professional development to support school
19 districts and charter schools implementing bilingual
20 multicultural education program models.

21 F. The working group shall report its findings and
22 recommendations to the public education department, the
23 legislative education study committee, the governor and the
24 deans of the colleges of education and the presidents of the
25 state universities by December 1, 2021 and to New Mexico Indian

1 nations, tribes and pueblos that have approved language
2 programs in the public schools by December 1, 2021.

3 SECTION 2. APPROPRIATION.--Four hundred thousand dollars
4 (\$400,000) is appropriated from the general fund to the public
5 education department for expenditure in fiscal year 2022 to pay
6 the expenses of and staffing for the biliteracy and oral
7 language development framework working group, including paying
8 for state or national biliteracy experts and in-depth research
9 and publication of the working group's report. Any unexpended
10 or unencumbered balance remaining at the end of fiscal year
11 2022 shall revert to the general fund.
