11	RELATING TO PUBLIC EDUCATION; PROVIDING THAT CAREER AND
12	TECHNICAL EDUCATION COURSES OFFERED BY HIGH SCHOOLS SHALL BE A
13	PART OF A SERIES OF AT LEAST THREE COURSES THAT ARE PART OF A
14	SINGLE PROGRAM OF STUDY THAT IS RELEVANT TO A CAREER FIELD OR
15	INDUSTRY CERTIFICATION.

17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. Section 22-13-1.1 NMSA 1978 (being Laws 1986,
19	Chapter 33, Section 5, as amended) is amended to read:
20	"22-13-1.1. GRADUATION REQUIREMENTS
21	A. At the end of grades eight through eleven, each
22	student shall prepare an interim next-step plan that sets forth
23	the coursework for the grades remaining until high school
24	graduation. Each year's plan shall explain any differences
25	from previous interim next-step plans, shall be filed with the

principal of the student's high school and shall be signed by the student, the student's parent and the student's guidance counselor or other school official charged with coursework planning for the student.

B. Each student must complete a final next-step plan during the senior year and prior to graduation. The plan shall be filed with the principal of the student's high school and shall be signed by the student, the student's parent and the student's guidance counselor or other school official charged with coursework planning for the student.

C. An individualized education program that meets the requirements of Subsections A and B of this section and that meets all applicable transition and procedural requirements of the federal Individuals with Disabilities Education Act for a student with a disability shall satisfy the next-step plan requirements of this section for that student.

D. A local school board shall ensure that each high school student has the opportunity to develop a next-step plan based on reports of college and workplace readiness assessments, as available, and other factors and is reasonably informed about:

(1) curricular and course options, including honors or advanced placement courses, dual-credit courses, distance learning courses, career clusters and career pathways, pre-apprenticeship programs or remediation programs that the .227180.3

1 college and workplace readiness assessments indicate to be 2 appropriate; 3 opportunities available that lead to (2) 4 different post-high-school options; and 5 alternative opportunities available if the (3) 6 student does not finish a planned curriculum. 7 Ε. performance standards. Student service learning shall be offered as an elective. Financial literacy shall be offered as an elective. Pre-apprenticeship programs may be offered as electives. Media literacy may be offered as an elective.

H.] <u>G.</u> For students entering the ninth grade beginning in the 2009-2010 school year, at least one of the units required for graduation shall be earned as an advanced placement or honors course, a dual-credit course offered in cooperation with an institution of higher education or a distance learning course.

[I.] <u>H.</u> The department shall establish a procedure for students to be awarded credit through completion of specified career technical education courses for certain graduation requirements, and districts may choose to allow students who successfully complete an industry-recognized credential, certificate or degree to receive additional weight in the calculation of the student's grade point average.

[J.] I. Successful completion of the requirements of the New Mexico diploma of excellence shall be required for graduation for students entering the ninth grade beginning in the 2009-2010 school year. Successful completion of a minimum of twenty-four units aligned to the state academic content and performance standards shall be required to earn a New Mexico diploma of excellence. These units shall be as follows:

on grammar, nonfiction writing and literature; provided that department-approved work-based training or career and technical education courses that meet state English academic content <u>and</u> performance standards shall qualify as one of the four required English units;

(2) four units in mathematics, of which one shall be the equivalent to or higher than the level of algebra 2, unless the parent submitted written, signed permission for the student to complete a lesser mathematics unit; and provided that a financial literacy course or department-approved workbased training or career and technical education course that meets state mathematics academic content and performance standards shall qualify as one of the four required mathematics units;

(3) three units in science, two of which shall have a laboratory component; provided that department-approved work-based training or career and technical education courses that meet state science academic content and performance standards shall qualify as one of the three required science units;

(4) three and one-half units in social science, which shall include United States history and geography, world history and geography, government and economics and one-half unit of New Mexico history;

one unit in physical education, as

determined by each school district, which may include a physical education program that meets state content and performance standards or participation in marching band, junior reserve officers' training corps or interscholastic sports sanctioned by the New Mexico activities association or any other co-curricular physical activity;

(6) one unit in one of the following: a career cluster course, workplace readiness or a language other than English; and

(7) seven and one-half elective units that meet department content and performance standards. Career and technical education courses shall be offered as an elective; provided that every career and technical education course offered shall be a part of a series of at least three courses that are a part of a single program of study that is relevant to a career field or industry certification. Student service learning shall be offered as an elective. Financial literacy shall be offered as an elective. Pre-apprenticeship programs may be offered as electives. Media literacy may be offered as an elective.

[K.] J. For students entering the eighth grade in the 2012-2013 school year, a course in health education is required prior to graduation. Health education may be required in either middle school or high school, as determined by the school district. Each school district shall submit to the .227180.3

department by the beginning of the 2011-2012 school year a health education implementation plan for the 2012-2013 and subsequent school years, including in which grade health education will be required and how the course aligns with department content and performance standards. Health education courses shall include:

(1) age-appropriate sexual abuse and assault awareness and prevention training that meets department standards developed in consultation with the federal centers for disease control and prevention that are based on evidencebased methods that have proven to be effective; and

(2) lifesaving skills training that follows nationally recognized guidelines for hands-on psychomotor skills cardiopulmonary resuscitation training. Students shall be trained to recognize the signs of a heart attack, use an automated external defibrillator and perform the Heimlich maneuver for choking victims. The secretary shall promulgate rules to provide for the:

(a) use of the following instructors for the training provided pursuant to this paragraph: 1) school nurses, health teachers and athletic department personnel as instructors; and 2) any qualified persons volunteering to provide training at no cost to the school district that the school district determines to be eligible to offer instruction pursuant to this paragraph; and

If a student exits from the school 2 system at the end of grade twelve without having passed a state 3 graduation examination, the student shall receive an appropriate state certificate indicating the number of credits earned and the grade completed. If within five years after a student exits from the school system the student takes and 7 passes the state graduation examination, the student may 8 receive a high school diploma. Any student passing the state graduation examination and completing all other requirements 10 within five years of entering ninth grade, including a final summer session if completed by August 1, may be counted by the 11 12 school system in which the student is enrolled as a high school 13 graduate for the year in which completion and examination 14 occur.

[0.] N. Beginning with the 2010-2011 school year, a student shall not receive a New Mexico diploma of excellence if the student has not demonstrated competence in the subject areas of mathematics, reading and language arts, writing, social studies and science, including a section on the constitution of the United States and the constitution of New Mexico, based on a standards-based assessment or assessments or a portfolio of standards-based indicators established by the department by rule. The standards-based assessments required in Section 22-2C-4 NMSA 1978 may also serve as the assessment required for high school graduation. If a student exits from .227180.3

1 the school system at the end of grade twelve without having 2 satisfied the requirements of this subsection, the student 3 shall receive an appropriate state certificate indicating the 4 number of credits earned and the grade completed. If within 5 five years after a student exits from the school system the 6 student satisfies the requirements of this subsection, the 7 student may receive a New Mexico diploma of excellence. Any 8 student satisfying the requirements of this subsection and 9 completing all other requirements within five years of entering 10 ninth grade, including a final summer session if completed by 11 August 1, may be counted by the school system in which the 12 student is enrolled as a high school graduate for the year in 13 which all requirements are satisfied.

(1) "career and technical education", sometimes referred to as "vocational education", means organized programs offering a sequence of courses, including technical education and applied technology education, that are directly related to the preparation of individuals for paid or unpaid employment in current or emerging occupations requiring an industry-recognized credential, certificate or degree;

(2) "career and technical education course" means a course with content that provides technical knowledge, skills and competency-based applied learning and that aligns with educational standards and expectations as defined in rule; .227180.3

1 (3) "career cluster" means a grouping of 2 occupations in industry sectors based on recognized 3 commonalities that provide an organizing tool for developing 4 instruction within the educational system; 5 (4) "career pathways" means a sub-grouping 6 used as an organizing tool for curriculum design and 7 instruction of occupations and career specialities that share a set of common knowledge and skills for career success; 8 9 "final next-step plan" means a next-step (5) 10 plan that shows that the student has committed or intends to 11 commit in the near future to a four-year college or university, 12 a two-year college, a trade or vocational program, an 13 internship or apprenticeship, military service or a job; 14 "interim next-step plan" means an annual (6) 15 next-step plan in which the student specifies post-high-school 16 goals and sets forth the coursework that will allow the student 17 to achieve those goals; and 18 (7) "next-step plan" means an annual personal 19 written plan of studies developed by a student in a public 20 school or other state-supported school or institution in 21 consultation with the student's parent and school counselor or 22 other school official charged with coursework planning for the 23 student that includes one or more of the following: 24 (a) advanced placement or honors 25 courses;
