C. a cigar bar; provided that, for a cigar bar established on or after [the effective date of this 2019 act] June 14, 2019, the bar shall be located in a standalone building;

the facilities of a tobacco manufacturing 6 D. 7 company licensed by the United States to manufacture tobacco 8 products that are operated by the company in its own name and 9 that are used exclusively by the company in its business of 10 manufacturing, marketing or distributing its tobacco products; 11 provided that secondhand smoke does not infiltrate other indoor 12 workplaces or other indoor public places where smoking is 13 otherwise prohibited under the Dee Johnson Clean Indoor Air 14 Act;

E. a state-licensed gaming facility, casino or bingo parlor, <u>except a racetrack licensed by the state racing</u> <u>commission with a gaming operator's license issued by the</u> <u>gaming control board;</u>

F. designated outdoor smoking areas;

G. private clubs;

H. hotel and motel rooms that are rented to guests and are designated as smoking-permitted rooms; provided that not more than ten percent of rooms rented to guests in a hotel or motel may be so designated;

I. a site that is being used in connection with the .219289.1
