13	ACTIVITIES REGULATED BY AN ASSOCIATION AND TO ESTABLISH

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. Section 22-1-2.1 NMSA 1978 (being Laws 1985,
18	Chapter 21, Section 2, as amended) is amended to read:
19	"22-1-2.1. HOME SCHOOLREQUIREMENTSHOME SCHOOL
20	TEAMS
21	<u>A.</u> Any person operating or intending to operate a
22	home school shall:
23	$[A_{\bullet}]$ (1) submit a home school registration
24	form made available by the department and posted on the
25	department's [web site] <u>website</u> to notify the department within

1	thirty days of the establishment of the home school and to
2	notify the department on or before August 1 of each subsequent
3	year of operation of the home school;
4	[B.] <u>(2)</u> maintain records of student disease
5	immunization or a waiver of that requirement; and
6	[C.] <u>(3)</u> provide instruction by a person
7	possessing at least a high school diploma or its equivalent.
8	B. A home school parent, guardian or other person
9	having custody of a school-age person may organize a team
10	consisting of home school students to participate in academic
11	activities that are regulated by an association pursuant to
12	Section 22-2-2 NMSA 1978. A home school team shall:
13	(1) be entitled to regular or affiliate
14	membership in the association;
15	<u>(2) be eligible for a separate membership in</u>
16	the association; provided that the association may promulgate
17	rules to allow for consolidation of team memberships as the
18	association may deem appropriate; and
19	(3) designate a home school administrator who
20	shall have the same authority and responsibility as that of a
21	public school administrator or athletic director regarding the
22	<u>activity.</u>
23	C. The association shall promulgate such rules as
24	required regarding home school team participation in academic
25	activities.

3	designated by the home school team who shall be qualified

7	school students organized to participate in a specific academic
8	activity, as determined by an association or organization
9	pursuant to Section 22-2-2 NMSA 1978."
