AN ACT

RELATING TO THE REDISTRICTING OF THE HOUSE OF REPRESENTATIVES;
ESTABLISHING REPRESENTATIVE DISTRICTS; PROVIDING THE METHOD FOR
ELECTING REPRESENTATIVES; PROVIDING FOR THE FILLING OF
VACANCIES; SETTING PRECINCTS; FIXING THE NUMBER, RESIDENCE AND
TERMS OF REPRESENTATIVES; REPEALING AND ENACTING SECTIONS OF
THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. [NEW MATERIAL] SHORT TITLE.--This act may be
cited as the "2021 House Redistricting Act".

SECTION 2. [NEW MATERIAL] MEMBERSHIP.--The house of
representatives is composed of seventy members to be elected
from districts that are contiguous and that are as compact as
is practicable.

SECTION 3. [NEW MATERIAL] RESIDENCE.--At the time of

1 filing a declaration of candidacy for the office of
2 representative, a candidate shall reside in the district for
3 which the candidate files. Thereafter, if a representative
4 permanently removes the representative's residence from or
5 maintains no residence in the district from which the
6 representative was elected, the representative shall be deemed
7 to have resigned, and a successor shall be selected as provided
8 in Section 4 of the 2021 House Redistricting Act.

9 SECTION 4. [NEW MATERIAL] ELECTIONS--VACANCIES.--

10 A. Members of the house of representatives shall be
11 elected for terms of two years.

12 B. If a vacancy occurs in the office of
13 representative for any reason, the vacancy shall be filled as
14 follows:

15 (1) for a representative district that is
16 situated wholly within the exterior boundaries of a single
17 county, the board of county commissioners of that county shall
18 appoint the representative to fill the vacancy; and

19 (2) for a representative district situated
20 within two or more counties:

21 (a) the board of county commissioners of
22 each county in the representative district shall submit one
23 name to the governor; and

24 (b) the governor shall appoint the
25 representative to fill the vacancy from the list of names so

1 submitted.

2 C. An appointment to fill a vacancy in the house of
3 representatives shall be for a term ending on December 31 after
4 the next general election.

5 D. An appointment to fill a vacancy made before the
6 general election of 2022 shall be made from the district as it
7 was described in Section 2-7E-1 NMSA 1978, as established by
8 the court in *Egolf v. Duran*, D-101-CV-2011-02942 (1st Dist.
9 Ct., Judgment and Final Order on Remand (State House of
10 Representatives Trial) filed February 28, 2012). On or after
11 the general election of 2022, a vacancy shall be filled by
12 appointment from the district as set out in the 2021 House
13 Redistricting Act.

14 SECTION 5. [NEW MATERIAL] PRECINCTS.--

15 A. Precinct designations and boundaries used in the
16 2021 House Redistricting Act are those precinct designations
17 and boundaries established pursuant to the Precinct Boundary
18 Adjustment Act and revised and approved pursuant to that act by
19 the secretary of state as of November 30, 2021.

20 B. A board of county commissioners shall not create
21 any precinct that lies in more than one representative district
22 and shall not divide any precinct so that the divided parts of
23 the precinct are situated in two or more representative
24 districts. Votes cast in any general, primary or other
25 statewide election from precincts created or divided in

2 counted or canvassed.
