A JOINT MEMORIAL

EXPRESSING SUPPORT FOR A STRENGTHENED COMMITMENT TO THE  
ELIMINATION OF THE ACHIEVEMENT GAP IN NEW MEXICO.

WHEREAS, according to the national education association,  
despite decades of overall progress in narrowing achievement  
gaps, disparities in educational outcomes related to racial and  
ethnic backgrounds persist; and

WHEREAS, minority students constitute seventy-five percent  
of all students, totaling more than two hundred fifty thousand  
students in the state; and

WHEREAS, New Mexico is a rising minority-majority state  
whose minority numbers will continue to increase for  
generations to come; and

WHEREAS, according to the public education department,  
Latino students make up sixty-one percent of all students in

1 the state, totaling more than two hundred twenty thousand  
2 students; Native American students make up eleven percent,  
3 totaling about thirty-three thousand students; African American  
4 students make up two percent, totaling about seven thousand  
5 students; and Caucasian students make up twenty-three percent,  
6 totaling about seventy-eight thousand students; and

7 WHEREAS, in a report released by the Annie E. Casey  
8 foundation, New Mexico is identified as the worst state in  
9 which to raise a child; and

10 WHEREAS, the state would benefit from a new educational  
11 paradigm to address the achievement gap; and

12 WHEREAS, the state's students represent its future  
13 workforce; and

14 WHEREAS, New Mexico's children are its most precious  
15 asset; and

16 WHEREAS, the cultural and linguistic diversity of the  
17 state and equal opportunity for all New Mexicans should be  
18 fostered; and

19 WHEREAS, the first judicial district court ruled in the  
20 consolidated cases of *Yazzie v. State of New Mexico* and  
21 *Martinez v. State of New Mexico* that the legislative and  
22 executive branches of government must make changes to address  
23 the achievement gap and provide for a "sufficient education"  
24 for all students, which includes funding and programming; and

25 WHEREAS, as held in the *Yazzie/Martinez* decision, the

1 funding provided has not been sufficient for all districts to  
2 provide the programs and services required by the constitution  
3 of New Mexico; and

4 WHEREAS, in the *Yazzie/Martinez* decision, the court  
5 observed that it is the duty of the public education department  
6 to provide a constitutionally adequate education system that  
7 ensures that New Mexico schools have the resources necessary to  
8 give at-risk students the opportunity to obtain a uniform and  
9 sufficient education that prepares them for college and  
10 careers; and

11 WHEREAS, the state must continue to implement the  
12 standards stated in the Hispanic Education Act and the Indian  
13 Education Act to aid in the elimination of the achievement gap;  
14 and

15 WHEREAS, the state must address the achievement gap and  
16 develop its human potential; and

17 WHEREAS, sufficient financial resources must be applied to  
18 combat the achievement gap that minority students face;

19 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
20 STATE OF NEW MEXICO that the legislature's strengthened  
21 commitment to providing sufficient education for all students  
22 regardless of race be expressed; and

23 BE IT FURTHER RESOLVED that all agencies of the state,  
24 school districts and local governments be encouraged to work  
25 together to commit to the elimination of the achievement gap
