A MEMORIAL

DECLARING JANUARY 25, 2018 "SANTA FE COUNTY DAY" IN THE HOUSE OF REPRESENTATIVES.

WHEREAS, in 1852, Santa Fe county was established as one of the first counties in the United States territory of New Mexico; and

WHEREAS, Santa Fe county has within its boundaries the local government jurisdictions of the city of Espanola, the city of Santa Fe and the town of Edgewood; and

WHEREAS, Santa Fe county has within its boundaries the tribal government jurisdictions of the Pueblo of Santa Clara, the Pueblo of San Ildefonso, the Pueblo of Nambe, the Pueblo of Pojoaque, the Pueblo of Tesuque, the Pueblo of Cochiti and the Pueblo of Santo Domingo; and

WHEREAS, Santa Fe county also encompasses many long-

1 inhabited traditional communities extending from the north to
2 the south of the county; and

3 WHEREAS, county residents are governed by publicly elected
4 officials on the board of county commissioners, the county
5 clerk, the county assessor, the county treasurer, the county
6 probate judge and the county sheriff; and

7 WHEREAS, the Santa Fe county government and its elected
8 officials work to be inclusive of all persons and authorities
9 in the county to utilize resources to best provide services for
10 everyone; and

11 WHEREAS, Santa Fe county honors and promotes the strong
12 traditions and multicultural history of New Mexico;

13 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
14 REPRESENTATIVES OF THE STATE OF NEW MEXICO that Santa Fe county
15 residents, past and present, be recognized for their
16 contributions in creating an inclusive environment honoring the
17 county's diverse cultures and traditions; and

18 BE IT FURTHER RESOLVED that January 25, 2018 be declared
19 "Santa Fe County Day" in the house of representatives; and

20 BE IT FURTHER RESOLVED that copies of this memorial be
21 transmitted to the Santa Fe county board of county
22 commissioners, the mayor of the city of Espanola, the mayor of
23 the city of Santa Fe, the mayor of the town of Edgewood and the
24 governors of the Pueblo of Santa Clara, the Pueblo of San
