11 RELATING TO PUBLIC OFFICERS; ENACTING THE DISCLOSURE ACT;  
12 REQUIRING PERSONS HOLDING OR SEEKING A POSITION OF DUTY, TRUST  
13 OR AUTHORITY WITH THE STATE TO FILE ANNUAL DISCLOSURES RELATED  
14 TO EMPLOYMENT, INCOME, ASSETS AND LIABILITIES, PROFESSIONAL  
15 LICENSES, GIFTS AND PROCUREMENT; PROVIDING DUTIES; REQUIRING  
16 RETENTION AND PUBLIC INSPECTION; PROVIDING RULEMAKING  
17 AUTHORITY; ESTABLISHING FINES; CREATING A PENALTY; RENAMING THE  
18 "FINANCIAL DISCLOSURE ACT" THROUGHOUT THE NMSA 1978 THE  
19 "DISCLOSURE ACT"; REPEALING THE FINANCIAL DISCLOSURE ACT,  
20 SECTIONS 10-16A-1 THROUGH 10-16A-9 NMSA 1978 (BEING LAWS 1993,  
21 CHAPTER 46, SECTIONS 39 THROUGH 45, LAWS 1995, CHAPTER 153,  
22 SECTION 25 AND LAWS 2021, CHAPTER 109, SECTION 21, AS AMENDED).

24 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

25 SECTION 1. [NEW MATERIAL] SHORT TITLE.--Sections 1

1 through 15 of this act may be cited as the "Disclosure Act".

2 SECTION 2. [NEW MATERIAL] DEFINITIONS.--As used in the  
3 Disclosure Act:

4 A. "beneficially owned" means a beneficiary's  
5 interest in trust property;

6 B. "business entity" means a corporation, business  
7 trust, estate, trust, partnership, limited liability company,  
8 association, joint venture or any legal or commercial entity;

9 C. "controlled" means the ability of a person,  
10 through share ownership or other means, to make changes in the  
11 management of a business entity or to appoint persons who will  
12 control the management of that business entity;

13 D. "dependent children" means any natural or  
14 adopted children of a reporting individual who are under the  
15 age of eighteen and living in the household of the reporting  
16 individual;

17 E. "disclosure statement" means a statement on a  
18 form prepared by the secretary of state for purposes of  
19 compliance with the Disclosure Act;

20 F. "employer" means a person that hires or pays  
21 another person in exchange for work;

22 G. "employment" means providing work to another  
23 person in exchange for compensation;

24 H. "income" means the money or other form of  
25 payment that a person receives from labor or services,

1 including from employment, a business entity, contracts, goods  
2 or services rendered and investments;

3 I. "office" means a position of duty, trust or  
4 authority;

5 J. "ordinary consumer debt" means a personal debt  
6 that is owed as a result of purchasing goods that are used for  
7 individual or household consumption, including credit card debt  
8 and auto loans;

9 K. "person" means an individual or business entity;

10 L. "public agency" means a department, commission,  
11 council, board, committee, agency or institution of the  
12 executive or legislative branch of state government or a  
13 political subdivision of the state or an instrumentality of the  
14 state or of a political subdivision of the state;

15 M. "professional license" means a certificate,  
16 permit or other authorization required by law for an individual  
17 to engage in a regulated profession or occupation;

18 N. "reporting individual" means:

19 (1) a person holding an elected office in the  
20 legislative or executive branch of state government;

21 (2) a state agency head;

22 (3) a person whose appointment to a board or  
23 commission is subject to confirmation by the senate;

24 (4) a member of the insurance nominating  
25 committee;

1 (5) a member of the state ethics commission;  
2 and

3 (6) a candidate for a legislative or statewide  
4 elected office; and

5 0. "state agency head" means the person who has the  
6 ultimate responsibility for exercising the powers of or  
7 expending the appropriated funds of a department, institution,  
8 board, bureau, commission, district or committee of government  
9 of the state of New Mexico, including of the legislative and  
10 judicial branches of the state.

11 SECTION 3. [NEW MATERIAL] DISCLOSURE STATEMENT REQUIRED--  
12 WHO MUST FILE.--

13 A. A reporting individual, other than a candidate  
14 for a legislative or statewide elected office, shall file with  
15 the secretary of state a disclosure statement:

16 (1) within thirty days of appointment or  
17 election to the office held by the reporting individual;

18 (2) after the year of appointment or election,  
19 during the month of January every year that the person holds  
20 the office; and

21 (3) upon leaving the office.

22 B. A person who files to be a candidate for a  
23 legislative or statewide elected office shall file a disclosure  
24 statement at the time of filing a declaration of candidacy;  
25 provided that a disclosure statement is not required to be

1 filed if the person has already filed a disclosure statement  
2 with the secretary of state in the same calendar year. If the  
3 person fails or refuses to file a financial disclosure  
4 statement required by this section before the final date for  
5 qualification of the person as a candidate pursuant to the  
6 Election Code, the person shall not be qualified as a  
7 candidate.

8 C. For a state agency head, an official whose  
9 appointment to a board or commission is subject to confirmation  
10 by the senate, a member of the insurance nominating committee  
11 or a member of the state ethics commission, the filing of the  
12 disclosure statement is a condition of entering upon and  
13 continuing in state employment or holding the appointed office.

14 SECTION 4. [NEW MATERIAL] DISCLOSURE OF EMPLOYMENT.--The  
15 disclosure statement filed by a reporting individual shall  
16 include the following information related to employment for the  
17 prior calendar year:

18 A. the full name of the reporting individual and  
19 the reporting individual's spouse; and

20 B. the name and address of any employer employing  
21 the reporting individual or the reporting individual's spouse,  
22 the title or position held and a brief description of the  
23 nature of the business or occupation.

24 SECTION 5. [NEW MATERIAL] DISCLOSURE OF ASSETS AND  
25 INCOME.--The disclosure statement filed by a reporting

1 individual shall include the following information related to  
2 assets and income for the prior calendar year:

3 A. the identity, location and purpose of use of  
4 real property owned by the reporting individual, the reporting  
5 individual's spouse or the reporting individual's dependent  
6 children; provided that, for personal residences only the zip  
7 code or, in the absence of a zip code, the county of situs is  
8 required to be disclosed;

9 B. the identity of assets of more than fifty  
10 thousand dollars (\$50,000) directly or beneficially owned by  
11 the reporting individual, the reporting individual's spouse or  
12 the reporting individual's dependent children; provided that,  
13 in determining whether an asset has a value of more than fifty  
14 thousand dollars (\$50,000), the value should not be reduced by  
15 any indebtedness secured by the asset, such as a mortgage or  
16 other secured loan, and a good faith estimate of the fair  
17 market value of an asset is permitted if the exact value is  
18 neither known or easily obtainable. The disclosure of assets  
19 shall include:

20 (1) commodities, including the type of  
21 commodity;

22 (2) investments in stocks, bonds, futures  
23 contracts, options, derivatives, currency, real estate  
24 investment trusts, mutual funds, private equity funds,  
25 exchange-traded funds and trust funds of which the reporting

1 individual is a beneficiary; provided that, if the investment  
2 is or forms part of a fund, the reporting individual is only  
3 required to identify the fund, the fund manager and any  
4 underlying holdings of the fund that have a value of more than  
5 fifty thousand dollars (\$50,000); and

6 (3) contractual rights that are reasonably  
7 likely to generate future income, such as royalties and  
8 intellectual property, the names of the contracting parties and  
9 the purpose of the contract; and

10 C. all sources of income equal to or greater than  
11 the amount that must be disclosed to the internal revenue  
12 service pursuant to 26 U.S.C. Section 6041(a), as amended,  
13 directly or indirectly accrued by the reporting individual, the  
14 reporting individual's spouse or the reporting individual's  
15 dependent children, including:

16 (1) the identity of the source of earned  
17 income; provided that:

18 (a) if a source of earned income is owed  
19 a legal or professional duty of confidentiality and the  
20 identity of the source of the income has not been disclosed to  
21 a public agency, the reporting individual may identify the  
22 source as "confidential" and describe the duty of  
23 confidentiality that prevents disclosure of the source of the  
24 earned income; and

25 (b) if an indirect source of earned

1 income is a client of a business entity of which the reporting  
2 individual or the reporting individual's spouse is a member,  
3 the indirect source of earned income is not required to be  
4 disclosed if the reporting individual or the reporting  
5 individual's spouse has no role in any matter involving the  
6 source; and

7 (2) the identity of sources of unearned  
8 income, including taxable interest, capital gains, dividends,  
9 annuities, trust distributions, rents from real property and  
10 insurance policies.

11 SECTION 6. [NEW MATERIAL] DISCLOSURE OF LIABILITIES.--

12 A. The disclosure statement filed by a reporting  
13 individual shall include for the prior calendar year  
14 liabilities of more than five thousand dollars (\$5,000) owed  
15 by:

16 (1) the reporting individual, the reporting  
17 individual's spouse or the reporting individual's dependent  
18 children; and

19 (2) a trust of which the reporting individual,  
20 the reporting individual's spouse or the reporting individual's  
21 dependent children are beneficiaries.

22 B. For a liability identified pursuant to  
23 Subsection A of this section, the reporting individual shall  
24 disclose:

25 (1) the identity of the person who owes the

1 debt or liability;

2 (2) the person to whom the debt or liability  
3 is owed;

4 (3) the amount of the debt or liability; and

5 (4) any payments on the debt or liability  
6 during the previous calendar year.

7 C. The disclosure statement is not required to  
8 include:

9 (1) ordinary consumer debt;

10 (2) mortgage debt on the primary residence of  
11 the reporting individual, the reporting individual's spouse or  
12 the reporting individual's dependent children;

13 (3) student loans; and

14 (4) liabilities owed to parents, grandparents,  
15 children or siblings of the reporting individual, the reporting  
16 individual's spouse or the reporting individual's dependent  
17 children.

18 SECTION 7. [NEW MATERIAL] DISCLOSURE OF INFORMATION AND  
19 ASSETS OF BUSINESS ENTITIES.--The disclosure statement filed by  
20 a reporting individual shall include the following information  
21 related to any privately held business controlled by the  
22 reporting individual, the reporting individual's spouse or the  
23 reporting individual's dependent children:

24 A. the name of the business entity, a brief  
25 description of the nature of its activities and its geographic

1 location, including the city and state; and

2 B. for a privately held business entity that was  
3 formed for the purpose of holding investments:

4 (1) assets of more than fifty thousand dollars  
5 (\$50,000) or that generated income directly or beneficially  
6 owned by the business entity in an amount equal to or greater  
7 than the amount that must be disclosed to the internal revenue  
8 service pursuant to 26 U.S.C. Section 6041(a), as amended;  
9 provided that, in determining whether an asset has a value of  
10 more than fifty thousand dollars (\$50,000), the value should  
11 not be reduced by any indebtedness secured by the asset, such  
12 as a mortgage or other secured loan; and

13 (2) any liability of the business entity in an  
14 amount greater than fifty thousand dollars (\$50,000),  
15 including:

16 (a) the identity of the business entity  
17 that owes the debt or liability;

18 (b) the person to which the debt or  
19 liability is owned;

20 (c) the amount of the debt or liability;

21 and

22 (d) any payments on the debt or  
23 liability during the previous calendar year.

24 SECTION 8. [NEW MATERIAL] DISCLOSURE OF PROFESSIONAL  
25 LICENSES AND MEMBERSHIPS.--The disclosure statement filed by a

1 reporting individual shall include the following information  
2 related to professional licenses, memberships and offices held  
3 for the prior calendar year:

4 A. professional licenses held by the reporting  
5 individual and the reporting individual's spouse; and

6 B. board memberships, offices or other positions  
7 held by the reporting individual and the reporting individual's  
8 spouse in:

9 (1) corporations, partnerships, trusts or  
10 other for-profit business entities; and

11 (2) nonprofit organizations, educational  
12 organizations, political organizations or other nongovernmental  
13 organizations.

14 SECTION 9. [NEW MATERIAL] DISCLOSURE OF GIFTS.--

15 A. The disclosure statement filed by a reporting  
16 individual shall include any gift received in the prior  
17 calendar year by the reporting individual, the reporting  
18 individual's spouse or the reporting individual's dependent  
19 children having a market value greater than fifty dollars  
20 (\$50.00) from a restricted donor, a lobbyist registered with  
21 the secretary of state, a lobbyist's employer, a government  
22 contractor or a person that has responded to a request for  
23 proposals or an invitation to bid issued by the public agency  
24 that the reporting individual serves.

25 B. As used in this section, "gift" and "restricted

1 donor" have the same meaning as those terms are defined in the  
2 Gift Act.

3 SECTION 10. [NEW MATERIAL] DISCLOSURES RELATED TO PUBLIC  
4 AGENCIES.--The disclosure statement filed by a reporting  
5 individual shall include the following information related to  
6 public agencies:

7 A. each public agency that purchased goods or  
8 services in excess of five thousand dollars (\$5,000) during the  
9 prior calendar year from the reporting individual, the  
10 reporting individual's spouse or a business entity controlled  
11 by the reporting individual or the reporting individual's  
12 spouse; and

13 B. each public agency, other than a court, before  
14 which the reporting individual or the reporting individual's  
15 spouse represented or assisted clients in the course of  
16 employment during the prior calendar year.

17 SECTION 11. [NEW MATERIAL] RETENTION AND PUBLIC  
18 INSPECTION OF DISCLOSURE STATEMENTS.--

19 A. The secretary of state shall retain for ten  
20 years from the date of filing any disclosure statement filed by  
21 a reporting individual and shall make the same available to the  
22 state ethics commission.

23 B. The secretary of state shall make publicly  
24 available the disclosure statements filed by a person holding  
25 an elected office in the legislative or executive branch of

1 state government and by a candidate for legislative or  
2 statewide elected office.

3 C. The secretary of state shall make available for  
4 public inspection, upon written request, disclosure statements  
5 filed by a state agency head, a person whose appointment to a  
6 board or commission is subject to confirmation by the senate, a  
7 member of the insurance nominating committee or a member of the  
8 state ethics commission; provided that:

9 (1) prior to the public inspection of the  
10 reporting individual's disclosure statements, the secretary of  
11 state shall inform the reporting individual of the written  
12 request and the identity of the requester; and

13 (2) the secretary of state shall not make  
14 available for public inspection any personal residence address  
15 of a reporting individual, the reporting individual's spouse or  
16 the reporting individual's dependent children.

17 SECTION 12. [NEW MATERIAL] EDUCATION AND VOLUNTARY  
18 COMPLIANCE.--

19 A. The secretary of state shall advise and seek to  
20 educate all reporting individuals on their duties pursuant to  
21 the Disclosure Act, including providing timely advance notice  
22 of the required disclosure statement and preparing disclosure  
23 statement forms that are clear and easy to complete.

24 B. The secretary of state shall refer violations of  
25 the Disclosure Act to the state ethics commission after first

1 seeking voluntary compliance and correction of all violations  
2 alleged from the reporting individual. The secretary of state  
3 shall give a person who violates any provision of the  
4 Disclosure Act ten days' notice to correct the matter before  
5 the secretary of state refers the violation to the state ethics  
6 commission.

7 SECTION 13. [NEW MATERIAL] RULEMAKING AUTHORITY--  
8 DISCLOSURE STATEMENT FORM.--The secretary of state may  
9 promulgate rules to implement the provisions of the Disclosure  
10 Act.

11 SECTION 14. [NEW MATERIAL] INVESTIGATIONS--FINES--CIVIL  
12 ENFORCEMENT.--

13 A. The state ethics commission may conduct  
14 examinations of disclosure statements and initiate complaints  
15 and investigations to determine whether the Disclosure Act has  
16 been violated. The state ethics commission may also receive,  
17 investigate and adjudicate complaints alleging violations of  
18 the Disclosure Act subject to the provisions of the State  
19 Ethics Commission Act.

20 B. The state ethics commission may institute a  
21 civil action in district court or refer a matter to the  
22 attorney general or a district attorney to institute a civil  
23 action in district court if a violation has occurred or to  
24 prevent a violation of a provision of the Disclosure Act.  
25 Relief may include a permanent or temporary injunction, a

1 restraining order or any other appropriate order, including an  
2 order for a civil penalty of up to one thousand dollars  
3 (\$1,000) for each violation not to exceed twenty thousand  
4 dollars (\$20,000).

5 C. A reporting individual who files a report after  
6 the deadline imposed by the Disclosure Act is additionally  
7 liable for a penalty of fifty dollars (\$50.00) per day for each  
8 regular working day after the deadline required for the filing  
9 of the disclosure statement until the report is filed, not to  
10 exceed five thousand dollars (\$5,000).

11 D. If the secretary of state or the state ethics  
12 commission reasonably believes that a person committed, or is  
13 about to commit, a violation of the Disclosure Act that is  
14 subject to criminal penalties, the secretary of state or the  
15 state ethics commission may refer the matter to the attorney  
16 general or a district attorney for criminal enforcement.

17 SECTION 15. [NEW MATERIAL] CRIMINAL PENALTIES.--

18 A. A person who knowingly and willfully violates  
19 any provision of the Disclosure Act is guilty of a misdemeanor  
20 and shall be punished by a fine of not more than one thousand  
21 dollars (\$1,000) or by imprisonment for not more than one year  
22 or both.

23 B. Notwithstanding the time limitations for  
24 commencing prosecutions pursuant to Subsection C of Section  
25 30-1-8 NMSA 1978, a person shall not be prosecuted, tried or

1 punished in any court of this state for knowingly and willfully  
2 violating any of the provisions of the Disclosure Act unless  
3 the indictment is found or information or complaint is filed  
4 within five years from the time the violation was committed.

5 SECTION 16. A new section of Chapter 1, Article 8 NMSA  
6 1978 is enacted to read:

7 "[NEW MATERIAL] CANDIDATES FOR LEGISLATIVE AND STATEWIDE  
8 OFFICES--CANDIDATE QUALIFICATION--COMPLIANCE WITH DISCLOSURE  
9 ACT REQUIRED.--Pursuant to the Disclosure Act, a person who  
10 files to be a candidate for a legislative or statewide elected  
11 office shall file a disclosure statement at the time of filing  
12 a declaration of candidacy; provided that a disclosure  
13 statement is not required to be filed if the person has already  
14 filed a disclosure statement with the secretary of state in the  
15 same calendar year. If the person fails or refuses to file a  
16 disclosure statement before the final date for qualification of  
17 the person as a candidate pursuant to the Election Code, the  
18 person shall not be qualified as a candidate."

19 SECTION 17. Section 1-22A-6 NMSA 1978 (being Laws 2013,  
20 Chapter 180, Section 6) is amended to read:

21 "1-22A-6. VOLUNTARY COMPLIANCE--COMPLAINTS AND  
22 INVESTIGATIONS--ARBITRATION--REFERRALS FOR ENFORCEMENT.--

23 A. The secretary of state may initiate  
24 investigations to determine whether any provision of the School  
25 District Campaign Reporting Act has been violated.

1 Additionally, any person who believes that a provision of that  
2 act has been violated may file a written complaint with the  
3 secretary of state any time prior to ninety days after an  
4 election, except that no complaints from the public may be  
5 filed within eight days prior to an election. The secretary of  
6 state shall adopt procedures for issuing advisory opinions and  
7 processing complaints and notifications of violations.

8 B. The secretary of state shall at all times seek  
9 to ensure voluntary compliance with the provisions of the  
10 School District Campaign Reporting Act. If the secretary of  
11 state determines that a provision of that act for which a  
12 penalty may be imposed has been violated, the secretary of  
13 state shall by written notice set forth the violation and the  
14 fine imposed and inform the reporting individual that the  
15 individual has ten working days from the date of the letter to  
16 correct the matter and to provide a written explanation, under  
17 penalty of perjury, stating any reason why the violation  
18 occurred. If a timely explanation is filed and the secretary  
19 of state determines that good cause exists to waive the fine  
20 imposed, the secretary of state may by a written notice of  
21 final action partially or fully waive any fine imposed for any  
22 late, incomplete or false report or statement of exception. A  
23 written notice of final action shall be sent by certified mail.

24 C. Upon receipt of the notice of final action, the  
25 person against whom the penalty has been imposed may protest

1 the secretary of state's determination by submitting on a  
2 prescribed form a written request for binding arbitration to  
3 the secretary of state within ten working days of the date of  
4 the notice of final action. Any fine imposed shall be due and  
5 payable within ten working days of the date of notice of final  
6 action. No additional fine shall accrue pending the issuance  
7 of the arbitration decision. Fines paid pursuant to a notice  
8 of final action that are subsequently reduced or dismissed  
9 shall be reimbursed with interest within ten working days after  
10 the filing of the arbitration decision with the secretary of  
11 state. Interest on the reduced or dismissed portion of the  
12 fine shall be the same as the rate of interest earned by the  
13 secretary of state's escrow account to be established by the  
14 department of finance and administration.

15 D. An arbitration hearing shall be conducted by a  
16 single arbitrator selected within ten days by the person  
17 against whom the penalty has been imposed from a list of five  
18 arbitrators provided by the secretary of state. Neither the  
19 secretary of state nor a person subject to the School District  
20 Campaign Reporting Act, Campaign Reporting Act, Lobbyist  
21 Regulation Act or ~~[Financial]~~ Disclosure Act may serve as an  
22 arbitrator. Arbitrators shall be considered to be independent  
23 contractors, not public officers or employees, and shall not be  
24 paid per diem and mileage.

25 E. The arbitrator shall conduct the hearing within

1 thirty days of the request for arbitration. The arbitrator may  
2 impose any penalty the secretary of state is authorized to  
3 impose. The arbitrator shall state the reasons for the  
4 arbitrator's decision in a written document that shall be a  
5 public record. The decision shall be final and binding. The  
6 decision shall be issued and filed with the secretary of state  
7 within thirty days of the conclusion of the hearing. Unless  
8 otherwise provided for in this section or by rule or regulation  
9 adopted by the secretary of state, the procedures for the  
10 arbitration shall be governed by the Uniform Arbitration Act.  
11 No arbitrator shall be subject to liability for actions taken  
12 pursuant to this section.

13 F. The secretary of state may refer a matter to the  
14 attorney general or a district attorney for a civil injunction  
15 or other appropriate order or for criminal enforcement."

16 SECTION 18. Section 10-16G-4 NMSA 1978 (being Laws 2019,  
17 Chapter 86, Section 4, as amended) is amended to read:

18 "10-16G-4. COMMISSIONERS--QUALIFICATIONS--LIMITATIONS.--

19 A. To qualify for appointment to the commission, a  
20 person shall:

21 (1) be a qualified elector of New Mexico;

22 (2) not have changed party registration in the  
23 five years next preceding the member's appointment in such a  
24 manner that the member's prior party registration would make  
25 the member ineligible to serve on the commission;

1 (3) not continue to serve as a commissioner if  
2 the member changes party registration after the date of  
3 appointment in such a manner as to make the member ineligible  
4 to serve on the commission; and

5 (4) not be, or within the two years prior to  
6 appointment shall not have been, in New Mexico, any of the  
7 following:

- 8 (a) a public official;
- 9 (b) a public employee;
- 10 (c) a candidate;
- 11 (d) a lobbyist;
- 12 (e) a government contractor; or
- 13 (f) an office holder in a political  
14 party at the state or federal level.

15 B. Before entering upon the duties of the office of
