The department shall annually report to the 4 D. 5 revenue stabilization and tax policy committee aggregate amounts of deductions taken pursuant to this section, the 6 7 number of taxpayers claiming the deduction and any other information that is necessary to determine that the deduction 8 9 is performing the purpose for which it is enacted. As used in this section: 10 Ε. "out-of-state" means that delivery of the (1)11 12 service is to an address outside of New Mexico; and "small business" means a business: (2)13 14 (a) with fewer than ten employees, including all persons for whom the business pays part or all of 15 the person's social security taxes due pursuant to the Federal 16 Insurance Contributions Act; and 17 (b) that has paid gross receipts taxes 18 19 pursuant to the provisions of the Gross Receipts and 20 Compensating Tax Act for the five consecutive years prior to the first year in which a deduction pursuant to this section is 21 taken." 22 SECTION 2.
