20	A. The "horse shelter rescue fund" is created as a
21	nonreverting fund in the state treasury. The fund consists of

25	the board to carry out the intent of aiding horse rescues and

SECTION 2. A new section of the Income Tax Act is enacted 8 9 to read: "[NEW MATERIAL] OPTIONAL DESIGNATION OF TAX REFUND 10 11 CONTRIBUTION--HORSE SHELTER RESCUE FUND.--12 Any individual whose state income tax liability Α. 13 after application of allowable credits and tax rebates in any 14 year is lower than the amount of money held by the department to the credit of such individual for that tax year may 15 designate any portion of the income tax refund due to the 16 individual to be paid to the horse shelter rescue fund. 17 In the 18 case of a joint return, both individuals must make such a 19 designation. 20 Β. The department shall revise the state income tax form to allow the designation of such contributions in the 21 following form: 22 "Horse Shelter Rescue Fund - Check [] if you wish 23 to contribute a part or all of your tax refund to 24
