2	Subsections A, B and C of this section shall be applied in a
3	tax year in which the owner claiming entitlement files with the
4	county assessor an application for the limitation on a form
5	furnished to the owner by the assessor. The application form
6	shall be designed by the department and shall provide for proof
7	of age or disability, occupancy and income eligibility for the
8	tax year for which application is made.]
9	E. The limitation of value specified in Subsections
10	A, B and C of this section shall be claimed in order to be
11	allowed. The limitations may be claimed by filing proof of
12	eligibility with the county assessor on an application form for
13	the limitation furnished by the assessor. The application form
14	shall be designed by the department and shall provide for proof
15	of age or disability, occupancy and income eligibility. An
16	owner who applies for the limitation of value specified in this
17	section and files proof of income eligibility for the three
18	consecutive years immediately prior to the tax year for which
19	the application is made need not claim the limitation for
20	subsequent tax years if there is no change in eligibility. The
21	county assessor shall apply that limitation automatically in
22	subsequent tax years until a change in eligibility occurs.

need not claim the limitation for subsequent tax years if there is no change in eligibility. The county assessor shall apply that limitation automatically in subsequent tax years until a change in eligibility occurs.

5 G. A person who has had a limitation applied to a tax year and subsequently becomes ineligible for the limitation 6 7 because of a change in the person's status or income or a change in the ownership of the property against which the 8 9 limitation was applied shall notify the county assessor of the loss of eligibility for the limitation by the last day of 10 February of the tax year immediately following the year in 11 12 which loss of eligibility occurs.

H. A person who violates the provisions of this section by intentionally claiming and receiving the benefit of a limitation to which the person is not entitled or who fails to comply with the provisions of Subsection G of this section may be liable for any additional taxes due, interest and a civil penalty of three times the amount of additional taxes due.

[F.] <u>I.</u> For the 2002 tax year and each subsequent tax year, the maximum amount of modified gross income in Subsections A, B and C of this section shall be adjusted to account for inflation. The department shall make the adjustment by multiplying the maximum amount for tax year 2000 by a fraction, the numerator of which is the consumer price

1 index ending during the prior tax year and the denominator of 2 which is the consumer price index ending in tax year 2000. The 3 result of the multiplication shall be rounded down to the 4 nearest one hundred dollars (\$100), except that if the result 5 would be an amount less than the corresponding amount for the preceding tax year, then no adjustment shall be made. For 6 7 purposes of this subsection, "consumer price index" means the consumer price index for all urban consumers published by the 8 9 United States department of labor for the month ending September 30. The department shall publish annually the amount 10 determined by the calculation and distribute it to each county 11 12 assessor no later than December 1 of each tax year.

[<del>G.</del>] <u>J.</u> The limitation of value specified in Subsections A, B and C of this section does not apply to:

(1) a change in valuation resulting from any physical improvements made to the property during the year immediately prior to the tax year or a change in the permitted use or zoning of the property during the year immediately prior to the tax year; or

(2) a residential property in the first tax year that is valued for property taxation purposes.

[H.] <u>K.</u> As used in this section, "disabled" means a person who has been determined to be blind or permanently disabled with medical improvement not expected pursuant to 42 USCA 421 for purposes of the federal Social Security Act or .192607.2
