17	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
18	SECTION 1. Section 29-1-11 NMSA 1978 (being Laws 1972,
19	Chapter 8, Section 1, as amended) is amended to read:
20	"29-1-11. AUTHORIZATION OF TRIBAL AND PUEBLO POLICE
21	OFFICERS AND CERTAIN FEDERAL OFFICERS TO ACT AS NEW MEXICO
22	PEACE OFFICERS [AUTHORITY AND PROCEDURE FOR COMMISSIONED PEACE
23	OFFICERS]
24	A. [ <del>All persons who are duly</del> ] Commissioned officers
25	of the police [ <del>or sheriff's</del> ] department of [ <del>any</del> ] <u>a</u> New Mexico

1 Indian nation, tribe or pueblo or who are law enforcement 2 officers employed by the bureau of Indian affairs and [are] assigned in New Mexico and who are [when commissioned under 3 Subsection B of this section] certified by the New Mexico law 4 enforcement academy or a basic law enforcement training program 5 approved by the academy are recognized and authorized to act as 6 7 New Mexico peace officers. These officers have all the powers of New Mexico peace officers to enforce state laws [in New 8 9 Mexico], including the power to make arrests for violation of 10 state laws.

[B. The chief of the New Mexico state police is granted authority to issue commissions as New Mexico peace officers to members of the police or sheriff's department of any New Mexico Indian nation, tribe or pueblo or a law enforcement officer employed by the bureau of Indian affairs to implement the provisions of this section. The procedures to be followed in the issuance and revocation of commissions and the respective rights and responsibilities of the departments shall be set forth in a written agreement to be executed between the chief of the New Mexico state police and the Indian nation, tribe or pueblo or the appropriate federal official.

C. The agreement referred to in Subsection B of this section shall contain the following conditions: (1) the Indian nation, tribe or pueblo, but not the bureau of Indian affairs, shall submit proof of

1 adequate public liability and property damage insurance for 2 vehicles operated by the peace officers and police professional 3 liability insurance from a company licensed to sell insurance 4 in the state; (2) each applicant for a commission shall 5 6 successfully complete four hundred hours of basic police 7 training that is approved by the director of the New Mexico law enforcement academy; 8 9 (3) the chief of the New Mexico state police 10 shall have the authority to suspend any commission granted 11 pursuant to Subsection B of this section for reasons solely 12 within the chief's discretion; 13 (4) if any provision of the agreement is 14 violated by the Indian nation, tribe or pueblo or any of its 15 agents, the chief of the New Mexico state police shall suspend 16 the agreement on five days' notice, which suspension shall last 17 until the chief is satisfied that the violation has been 18 corrected and will not recur: 19 (5) the goldenrod-colored officer's second 20 copy of any citation issued pursuant to a commission authorized 21 by this section shall be submitted within five days to the 22 chief of the New Mexico state police; 23 (6) any citation issued pursuant to a 24 commission authorized by this section] 25 B. 1 Indian nation, tribe or pueblo or the bureau of Indian affairs 2 shall be liable for any acts of that officer acting within the scope of the officer's employment or authority when acting as a 3 New Mexico peace officer. Neither the state nor any political 4 subdivision shall be liable for acts or failures to act by such 5 peace officer. The New Mexico Indian nation, tribe or pueblo 6 7 or the bureau of Indian affairs shall submit proof to the risk 8 management division of the general services department of 9 adequate public liability and property damage insurance for 10 motor vehicles operated by the peace officer and police 11 professional liability insurance from a company licensed to 12 sell insurance in New Mexico. Citations shall be to a 13 magistrate court of New Mexico; except that [any] citations 14 issued to Indians within the exterior boundaries of an Indian 15 reservation shall be cited into tribal court.

[<del>(7) the agreement or any commission issued</del> pursuant to it shall not confer any authority on a tribal court or other tribal authority that the court or authority would not otherwise have;

(8)] <u>C.</u> The authority conferred [by any agreement entered into] pursuant to the provisions of this section shall be coextensive with the exterior boundaries of the <u>tribal or</u> <u>pueblo officer's</u> reservation except that an officer [commissioned under this section] may proceed in hot pursuit of an offender beyond the exterior boundaries of the <u>officer's</u> .223414.2

<u>D.</u> The authority conferred in [any] <u>a</u> written agreement between the chief of the New Mexico state police and the Navajo Nation may extend beyond the exterior boundaries of the Navajo reservation to and including the area enclosed by the following description:

Beginning at a point where the southern boundary line of the Navajo Nation reservation intersects the western right-of-way line of US 491, and running thence; southerly along the western right-of-way line of US 491 to the northerly city limits of Gallup; thence, easterly along the northerly city limits of Gallup to the northern side of the right of way of I-40; thence, in an easterly direction along the northerly side of the right of way of I-40 to the northerly limits of the village of Prewitt; thence, in a straight line between the northerly boundary of the village of Prewitt to the southerly boundary of Ambrosia Lake; thence in a straight line between the southerly boundary of Ambrosia Lake to the southerly boundary of Hospah; thence, east along a straight line from the southerly boundary of Hospah to the southern boundary of Torreon; thence along the easterly side of the right of way of state road 197 to the

westerly city limits of Cuba; thence, north along the westerly side of the right of way of state road 44 to the southerly boundary of the Jicarilla Apache Nation reservation; thence, westerly along the southerly boundary of the Jicarilla Apache Nation reservation to the southwest corner of that reservation; thence, northerly along the westerly boundary of the Jicarilla Apache Indian reservation to a point where the westerly boundary of the reservation intersects the southerly side of the right of way of state road 44; thence, northerly along the southerly side of the right of way of state road 44 to its intersection with the northerly side of the right of way of Navajo road 3003; thence, along the northerly side of the right of way of Navajo road 3003 to a point where the northerly side of the right of way of Navajo road 3003 intersects the westerly side of the right-of-way line of state road 371; thence, northerly along the west side of the right of way of state road 371 to the southerly side of the right of way of Navajo road 36; thence, westerly along the southerly side of the right of way of Navajo road 36 to the eastern border of the Navajo Nation reservation; thence, along the eastern and southerly borders of the

2 The municipalities of Cuba and Gallup and the Ε. 3 villages of Thoreau and Prewitt are excluded from the grant of 4 authority that may be conferred in [any] the written agreement 5 entered into pursuant to the provisions of this [section] 6 subsection and Subsection D of this section; provided, however, 7 [any] a written agreement may include under [such] the grant of 8 authority the communities of Ambrosia Lake, Hospah, Torreon, 9 Lybrook, Nageezi, Counselors and Blanco Trading Post and those 10 communities commonly known as the Wingate community; the Navajo 11 Nation Blue Water ranch area of the Thoreau community; the 12 Prewitt community, exclusive of the village of Prewitt; the 13 Haystack community; the Desidero community; the Sand Springs 14 community; the Rincon Marquis community; the Charley Jesus 15 Arviso and the Castillo community; and state road 264 beginning 16 at the point where it intersects US 491 and ending where state 17 road 264 intersects the Arizona-New Mexico state line. the existing status and sovereignty of an Indian nation, tribe or pueblo as established under the laws of the United States.

[E.] G. All persons who are duly commissioned federal law enforcement officers employed by the federal bureau of investigation; drug enforcement administration; bureau of alcohol, tobacco and firearms; United States secret service; United States customs service; immigration and naturalization service; United States marshals service; postal inspection service; United States probation department; and United States pretrial services agency; and other appropriate federal officers whose primary duty is law enforcement related, who are assigned in New Mexico and who are required to be designated by the county sheriff on a case-by-case basis in the county in which they are working, are recognized and authorized to act as New Mexico peace officers and have all the powers of New Mexico peace officers to enforce state laws in New Mexico, including the power to make arrests for violation of state laws. The department of public safety shall maintain a registry that lists the name and affiliated federal agency of every federal law enforcement officer recognized and authorized to act as a New Mexico peace officer pursuant to the provisions of this This subsection shall not be construed to impose subsection. liability upon or to require indemnification by the state for any act performed by a federal law enforcement officer pursuant to this subsection.

"conviction" means an adjudication of guilt or a D. plea of no contest and includes convictions that are suspended or deferred:

Ε. "council" means the New Mexico law enforcement standards and training council;

"director" means the director of the division; "division" means the New Mexico law enforcement G. academy of the department of public safety;

"in-service law enforcement training" means a н. course of instruction required of all certified peace officers and designed to train and equip all police officers in the state with specific law enforcement skills and to ensure the continuing development of all police officers in the state. The training and instruction shall be kept current and may be conducted on a regional basis at the discretion of the director;

"law enforcement agency" means an agency of the I. state or local political subdivision of the state that employs certified law enforcement officers or the police department of a tribe that has entered into an agreement with the department of public safety pursuant to Section 29-1-11 NMSA 1978;

J. "police officer" means [any] a commissioned .223414.2

1 employee of a law enforcement agency that is part of or 2 administered by the state or any political subdivision of the 3 state; a commissioned police officer of an Indian nation, tribe 4 or pueblo; and [includes any] an employee of a missile range 5 civilian police department, who is a graduate of the law 6 enforcement academy, a recognized certified regional law 7 enforcement training facility or other law enforcement training 8 approved by the academy and who is currently certifiable by the 9 academy, which employee is responsible for the prevention and 10 detection of crime or the enforcement of the penal or traffic 11 or highway laws of this state. The term specifically includes 12 deputy sheriffs. Sheriffs are eligible to attend the academy 13 and are eligible to receive certification as provided in the 14 Law Enforcement Training Act. As used in this subsection, 15 "commissioned" means an employee of a law enforcement agency 16 who is authorized by a sheriff or chief of police to apprehend, 17 arrest and bring before the court all violators within the law 18 enforcement agency's jurisdiction; and

K. "certified regional law enforcement training facility" means a law enforcement training facility within the state certified by the director, with the approval of the academy's board of directors, that offers basic law enforcement training and in-service law enforcement training that is comparable to or exceeds the standards of the programs of the academy."
