AN ACT

MAKING AN APPROPRIATION FOR THE PROVISION OF ACADEMICALLY INTEGRATED OUT-OF-SCHOOL AND SUMMER PROGRAMS STATEWIDE; PROVIDING REQUIREMENTS TO RECEIVE FUNDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. APPROPRIATION. --

Seven hundred fifty thousand dollars (\$750,000) is appropriated from the general fund to the public education department for expenditure in fiscal years 2022 through 2024 to contract with an organization to address long-term economic development throughout the state by providing project-based programs, either in person or through remote learning, that support academic achievement and college and career readiness. Any unexpended or unencumbered balance remaining at the end of fiscal year 2024 shall revert to the general fund.

В. The programs shall:

- include a dual credit component;
- (2) provide access to an industry standard digital media authoring tool set for students;
 - (3) provide professional mentor training;
- provide digital badging and professional certification in partnership with public post-secondary educational institutions;
- (5) focus on serving low-income Hispanic, American Indian and African American students and other generationally underserved populations statewide;
 - support academic success; and (6)
- (7) open career paths into growing industries in New Mexico, including science, technology, engineering and mathematics fields; creative arts; health care; trades; and energy.
- C. A request for proposals and award to an organization to provide programming shall require that the organization has an established academic and career readiness program that:
- contains comprehensive kindergarten (1) through twelfth grade programming taught by professionals in science, technology, engineering, mathematics, media arts, media literacy, cultural relevance, leadership, equity and proven systems that address needs in the modern economy; .219501.1

- (3) provides teaching and learning strategies in digital transformation that support all required content areas and that may affect students on a schoolwide and statewide basis; and
- (4) directly remedies the opportunity gaps based on the *Martinez and Yazzie v. State of New Mexico* lawsuit by providing college and career opportunities that boost employability for participants.
- D. The public education department shall work with the New Mexico alliance for college and career readiness to develop the request for proposals.
