19	A. The "educational retirement board" is created.	
20	B. The board shall be composed of [seven] <u>nine</u>

administration, and one member shall have a background in public education; and

- (7) one member to be elected for a term of four years by the members of the American federation of teachers in New Mexico.
- A designee of a board member shall have the same responsibilities, duties, liabilities and immunities as the board member, including the indemnification provided by Subsection H of Section 22-11-13 NMSA 1978. The appointment of a designee does not relieve the board member of the member's responsibilities, duties, liabilities and immunities as a board member, and the board member shall be fully responsible and liable for the actions of the designee while serving on the board.
- D. In the initial composition of the board, the member elected by the members of the American association of university professors shall serve for a term of three years; one member appointed by the governor shall serve for a term of two years; and the other member appointed by the governor shall serve for a term of one year. In electing or appointing new members after the enactment of this 2019 act, the member elected by the American federation of teachers shall serve an initial term of three years and the new member appointed by the governor shall serve an initial term of two years; thereafter, these members shall serve terms of four years.
