14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	SECTION 1. A new section of the Public Assistance Act is
16	enacted to read:

18	REQUIREMENTSTo be eligible for medicaid, an applicant shall
19	be living in New Mexico on the date the medicaid application is
20	submitted and shall provide at least two of the following
21	documents that include the applicant's name and principal
22	residence:
23	A. a current real property rental agreement or a
24	purchase agreement;
25	B. a utility bill that is dated within sixty days

Μ. a document evidencing eligibility and proof that 10 the applicant is currently receiving services from a nonprofit 11 organization, qualified pursuant to Section 501(c)(3) of the 12 federal Internal Revenue Code of 1986; provided that the 13 document displays the applicant's address."
