| 19 | SECTION 1. It is proposed to amend Article 7, Section l         |

| 22 | pursuant to the constitution and laws of the United States and  |
| 23 | a citizen thereof shall be qualified to vote in all elections   |

<u>underscored material = new</u> [<del>bracketed material</del>] = delete either by reason of criminal conviction for a felony or by reason of mental incapacity, being limited only to those persons who are unable to mark their ballot and who are concurrently also unable to communicate their voting preference. The legislature may enact laws providing for absentee voting by qualified electors. All school elections shall be held at different times from partisan elections.

8 Β. The legislature shall have the power to require 9 the registration of the qualified electors as a requisite for voting and shall regulate the manner, time and places of 10 voting. If the legislature requires the registration of 11 12 qualified electors as a requisite for voting, the state shall ensure that all qualified electors are registered to vote for 13 each election, except for those who affirmatively choose not to 14 be registered, and that the vote of a qualified elector shall 15 not be excluded from being counted for failure of the state to 16 provide for the qualified elector's voter registration on or 17 before election day. 18

<u>C.</u> The legislature shall enact such laws as will secure the secrecy of the ballot and the purity of elections and guard against the abuse of elective franchise. Not more than two members of the board of registration and not more than two judges of election shall belong to the same political party at the time of their appointment."
