AN ACT relating to parentage; adopting provisions of the Uniform Parentage Act; revising provisions relating to the establishment of a parent and child relationship and the presumption of parentage; establishing provisions concerning the voluntary acknowledgment of parentage and denial of parentage by certain persons; authorizing the State Board of Health to adopt regulations relating to an acknowledgment of parentage or denial of parentage; establishing provisions governing genetic testing in proceedings to adjudicate parentage; establishing and revising various provisions relating to proceedings to adjudicate parentage; authorizing a person who claims to be a de facto parent of a child to be adjudicated as a parent of the child in certain circumstances; authorizing a court to adjudicate a child to have more than two parents in certain circumstances; establishing and revising provisions relating to assisted reproduction and gestational agreements; providing for the right of a gestational carrier to make all health care decisions regarding the gestational carrier and the pregnancy of the gestational carrier; repealing various provisions relating to parentage; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law sets forth provisions governing parentage and the establishment of parent  
2 and child relationships. (Chapter 126 of NRS) **Sections 28-91** of this bill generally replace  
3 such provisions with provisions modeled after those of the Uniform Parentage Act (hereinafter  
4 “UPA”), adopted by the Uniform Law Commission in 2017. **Sections 4-26** of this bill define  
5 terms for the purposes of chapter 126 of NRS that are modeled after the definitions of the  
6 terms used in the UPA.

7 Existing law provides the manners in which the legal relationship of a mother and child  
8 can be established, including: (1) except in the case of a gestational agreement, proof that a  
9 woman gave birth to a child; (2) an adjudication that a woman is the mother of a child; (3)  
10 proof that a woman has adopted a child; (4) an un rebutted presumption of a woman's  
11 maternity; (5) the consent of a woman to assisted reproduction that resulted in the birth of a  
12 child; or (6) an adjudication confirming a woman as a parent of a child born to a gestational  
13 carrier. (NRS 126.041) Existing law also provides the manners in which the legal relationship  
14 of a father and child can be established, including: (1) an adjudication that a man is the father  
15 of a child; (2) proof that a man has adopted a child; (3) the consent of a man to assisted  
16 reproduction that resulted in the birth of a child; (4) an adjudication confirming a man as a  
17 parent of a child born to a gestational carrier; (5) a presumption of paternity that arises if a  
18 man was married to or cohabiting with the natural mother of a child or resides with and holds  
19 out a child as his natural child; (6) genetic testing establishing a man as the father of a child;  
20 or (7) a voluntary acknowledgment of paternity by a man. (NRS 126.041, 126.051, 126.053)  
21 **Section 34** of this bill uses the gender-neutral language of the UPA to set forth the  
22 circumstances in which a parent and child relationship is established between a person and a  
23 child. Similarly, **section 37** of this bill uses the gender-neutral language of the UPA to  
24 establish the circumstances in which a person is presumed to be a parent of a child.

25 **Sections 38-51** of this bill establish provisions modeled after those of the UPA relating to  
26 the voluntary acknowledgment or voluntary denial of parentage by certain persons, including  
27 provisions relating to the requirements for, rescission of and challenge to an acknowledgment  
28 of parentage or denial of parentage. **Section 42** of this bill provides that, unless an  
29 acknowledgment of parentage or denial of parentage is rescinded or challenged, such an  
30 acknowledgment of parentage or denial of parentage that meets all requirements of law and is  
31 filed with the State Registrar of Vital Statistics is equivalent to an adjudication of the  
32 parentage of a child or the nonparentage of a person, respectively. **Section 43** of this bill  
33 prohibits the State Registrar of Vital Statistics from charging a fee for filing an  
34 acknowledgment of parentage or denial of parentage, and **section 51** of this bill authorizes the  
35 State Board of Health to adopt any necessary regulations relating to an acknowledgment of  
36 parentage or denial of parentage.

37 Existing law provides that in an action to determine paternity, a court is authorized or  
38 required, depending on the circumstances, to order genetic testing of a mother, child, alleged  
39 father or any other person. (NRS 126.121) **Sections 52-68** of this bill establish various  
40 provisions modeled after those of the UPA concerning genetic testing, including: (1) the  
41 limitation on the use of genetic testing; (2) the authority to order facilitate or deny genetic  
42 testing; (3) the requirements of genetic testing; (4) reports and costs of genetic testing; (5)  
43 additional genetic testing when a result is contested; (6) genetic testing when a specimen is  
44 not available from an alleged genetic parent; and (7) genetic testing of a deceased person or  
45 identical sibling. **Section 68** of this bill provides that a person commits a misdemeanor if,  
46 without proper authority, he or she intentionally releases an identifiable specimen of another  
47 person collected for genetic testing for a purpose not relevant to a proceeding regarding  
48 parentage.

49 Existing law establishes various provisions relating to an action to determine paternity or  
50 maternity. (NRS 126.071-126.231) **Sections 69-89** of this bill replace several of those  
51 provisions with provisions modeled after those of the UPA governing proceedings to  
52 adjudicate parentage. Existing law provides that if an action to determine paternity is brought  
53 before the birth of a child, all proceedings are generally required to be stayed until after the  
54 birth of the child. (NRS 126.071) **Section 84** of this bill instead authorizes a proceeding to  
55 adjudicate parentage to be commenced and an order or judgment to be entered before the birth  
56 of a child, but requires enforcement of the order or judgment to be stayed until after the birth  
57 of the child.

58 Existing law does not bar an action to determine paternity until 3 years after a child  
59 reaches the age of majority. (NRS 126.081) **Sections 75 and 76** of this bill instead provide  
60 that a proceeding to determine whether an alleged genetic parent or presumed parent,  
61 respectively, is a parent of a child may be commenced after the child becomes an adult if the  
62 child initiates the proceeding.

63 Existing law requires that an informal hearing be held after an action to determine  
64 paternity has been brought and further requires a court to attempt to resolve the issues raised  
65 in the action during the pretrial hearing. (NRS 126.111) **Section 136** of this bill repeals the

66 provisions relating to such a pretrial hearing, as the UPA does not require any such pretrial  
67 hearing to be conducted.

68 **Section 77** of this bill authorizes a person who claims to be a de facto parent of a child to  
69 commence a proceeding to establish parentage of the child if the child is alive and less than 18  
70 years of age. **Section 77** provides that a person who claims to be a de facto parent of a child  
71 must be adjudicated as a parent of the child if there is only one other person who is a parent or  
72 has a claim to parentage of the child and the person who claims to be a de facto parent can  
73 demonstrate certain facts by clear and convincing evidence. **Section 81** of this bill authorizes  
74 a court to adjudicate a child to have more than two parents if the court finds that failure to  
75 recognize more than two parents would be detrimental to the child.

76 Existing law establishes provisions concerning assisted reproduction and gestational  
77 surrogacy. (NRS 126.500-126.810) This bill establishes only certain provisions modeled after  
78 those of the UPA relating to such matters. **Section 92** of this bill establishes provisions  
79 relating to the parental status of certain persons who die before a child is conceived by  
80 assisted reproduction. **Section 93** of this bill authorizes a party to a gestational agreement to  
81 terminate the agreement at any time before an embryo transfer or, if an embryo transfer does  
82 not result in pregnancy, at any time before a subsequent embryo transfer.

83 Existing law requires that a gestational agreement provide for the express written  
84 agreement of the gestational carrier to undergo embryo or gamete transfer and attempt to carry  
85 and give birth to any resulting child. (NRS 126.750) **Section 107** of this bill specifies that a  
86 gestational carrier has the right to make all health and welfare decisions regarding the  
87 gestational carrier and the pregnancy of the gestational carrier, including whether to: (1)  
88 consent to a cesarean section or the transfer of multiple embryos; (2) use the services of a  
89 health care practitioner chosen by the gestational carrier; (3) terminate or continue the  
90 pregnancy; and (4) reduce or retain the number of fetuses or embryos carried by the  
91 gestational carrier. **Section 107** provides that any provision in a gestational agreement that  
92 contradicts such a right is void and unenforceable.

93 Existing law provides that the subsequent marriage or domestic partnership of a  
94 gestational carrier after the execution of a gestational agreement does not affect the validity of  
95 the agreement. (NRS 126.770) **Section 108** of this bill provides that the subsequent marriage,  
96 domestic partnership or divorce of any party to a gestational agreement does not affect the  
97 validity of the agreement unless the agreement expressly provides otherwise.

98 Existing law provides that if a gestational carrier breaches a gestational agreement, a  
99 specific performance remedy that would require the gestational carrier to be impregnated is  
100 prohibited. (NRS 126.780) **Section 109** of this bill instead provides that specific performance  
101 is not an available remedy with regard to a gestational agreement except to enforce any  
102 provision in the agreement that is necessary to enable the intended parents to exercise the full  
103 rights of parentage immediately upon the birth of the child, if the intended parents are being  
104 prevented from exercising such rights.

105 **Sections 98-106** of this bill make various other changes to the provisions of existing law  
106 concerning assisted reproduction and gestational surrogacy.

107 **Section 136** repeals provisions of existing law that are not necessary because of the  
108 establishment of the provisions modeled after those of the UPA in **sections 28-91**.

109 **Sections 1, 94-97, 110-133 and 136** of this bill make conforming changes to reflect the  
110 revisions made to existing law because of the establishment of the provisions modeled after  
111 those of the UPA in **sections 28-91** and the repeal of unnecessary provisions in **section 136**.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

 7 hearing and finding by clear and convincing evidence that a parent has engaged in  
 8 one or more acts of domestic violence against the child, a parent of the child or any  
 9 other person residing with the child. The presumption created by this ~~[paragraph]~~  
 10 **subsection** is a rebuttable presumption.

11 ~~[(2) A court may award primary physical custody of a child born out of  
 12 wedlock to:~~

13 ~~— (a) The mother of the child if:~~

14 ~~— (1) The mother has not married the father of the child;~~

15 ~~— (2) A judgment or order of a court, or a judgment or order entered pursuant  
 16 to an expedited process, determining the paternity of the child has not been entered;

19 ~~— (I) Is not subject to any presumption of paternity under NRS 126.051;~~

23 ~~— (b) The father of the child if:~~

24 ~~— (1) The mother has abandoned the child; and~~

25 ~~— (2) The father has provided sole care and custody of the child in her

28 ~~(a) “Abandoned” means that a mother or father has:~~

29 ~~— (1) Failed, for a continuous period of not less than 6 months, to provide  
 30 substantial personal and economic support to the child; or~~

31 ~~— (2) Knowingly declined, for a continuous period of not less than 6 months,  
 32 to have any meaningful relationship with the child.~~

33 ~~— (b) “Expedited process” has the meaning ascribed to it in NRS 126.161.]~~

34 **Sec. 2.** Chapter 126 of NRS is hereby amended by adding thereto the  
 35 provisions set forth as sections 3 to 93, inclusive, of this act.

36 **Sec. 3.** *As used in this chapter, unless the context otherwise requires, the  
 37 words and terms defined in sections 4 to 26, inclusive, of this act have the  
 38 meanings ascribed to them in those sections.*

39 **Sec. 4.** *“Acknowledged parent” means a person who has established a  
 40 parent and child relationship under sections 38 to 51, inclusive, of this act.*

41 **Sec. 5.** *“Adjudicated parent” means a person who has been adjudicated to  
 42 be a parent of a child by a court with jurisdiction.*

43 **Sec. 6.** *“Alleged genetic parent” means a person who is alleged to be, or  
 44 alleges that the person is, a genetic parent or possible genetic parent of a child  
 45 whose parentage has not been adjudicated. The term includes an alleged genetic  
 46 father and alleged genetic mother. The term does not include:*

47 *1. A presumed parent;*

48 *2. A person whose parental rights have been terminated or declared not to  
 49 exist; or*

50 *3. A donor.*

51 **Sec. 7.** *“Assisted reproduction” means a method of causing pregnancy  
 52 other than sexual intercourse. The term includes:*

53 *1. Intrauterine or intracervical insemination;*

2. *Donation of gametes;*
3. *Donation of embryos;*
4. *In vitro fertilization and transfer of embryos; and*
5. *Intracytoplasmic sperm injection.*

6. **Sec. 8.** *“Birth” includes stillbirth.*

7. **Sec. 9.** *“Child” means a person of any age whose parentage may be determined under sections 28 to 91, inclusive, of this act.*

8. **Sec. 10.** *“Child support agency” means a governmental entity, public official or private agency authorized to provide parentage-establishment services under Title IV-D of the Social Security Act, 42 U.S.C. §§ 651 to 669, inclusive.*

9. **Sec. 11.** *“Custodial parent” means a parent who has been awarded physical custody of a child or, if no award of physical custody has been made by a court, the parent with whom the child resides.*

10. **Sec. 12.** *“Determination of parentage” means establishment of a parent and child relationship by a judicial or administrative proceeding or signing of a valid acknowledgment of parentage under sections 38 to 51, inclusive, of this act.*

11. **Sec. 13.** *“Donor” means a person who provides gametes intended for use in assisted reproduction, whether or not for consideration. The term does not include:*

12. *1. A person who gives birth to a child conceived by assisted reproduction, except as otherwise provided in NRS 126.500 to 126.810, inclusive, and sections 92 and 93 of this act; or*

13. *2. A parent or an intended parent under NRS 126.500 to 126.810, inclusive, and sections 92 and 93 of this act.*

14. **Sec. 14.** *“Gamete” means a sperm or egg.*

15. **Sec. 15.** *“Genetic testing” means an analysis of genetic markers to identify or exclude a genetic relationship.*

16. **Sec. 16.** *“Intended parent” means a person, married or unmarried, or in or not in a domestic partnership, who manifests an intent to be legally bound as a parent of a child conceived by assisted reproduction.*

17. **Sec. 17.** *“Parent” means a person who has established a parent and child relationship under section 34 of this act.*

18. **Sec. 18.** *“Parentage” or “parent and child relationship” means the legal relationship between a child and a parent of the child.*

19. **Sec. 19.** *“Person” means a natural person of any age.*

20. **Sec. 20.** *“Presumed parent” means a person who under section 37 of this act is presumed to be a parent of a child, unless the presumption is overcome in a judicial proceeding, a valid denial of parentage is made under sections 38 to 51, inclusive, of this act or a court adjudicates the person to be a parent.*

21. **Sec. 21.** *“Record” means information that is inscribed on a tangible medium or that is stored in an electronic or other medium and is retrievable in perceivable form.*

22. **Sec. 22.** *“Sign” means, with present intent to authenticate or adopt a record:*

23. *1. To execute or adopt a tangible symbol; or*

24. *2. To attach to or logically associate with the record an electronic symbol, sound or process.*

25. **Sec. 23.** *“Signatory” means a person who signs a record.*

26. **Sec. 24.** *“State” means a state of the United States, the District of Columbia, Puerto Rico, the United States Virgin Islands or any territory or insular possession under the jurisdiction of the United States. The term includes a federally recognized Indian tribe.*

1       **Sec. 25.** *“Transfer” means a procedure for assisted reproduction by which*  
2 *an embryo is placed in the body of the person who will give birth to the child.*

3       **Sec. 26.** *“Witnessed” means that at least one person who is authorized to*  
4 *sign has signed a record to verify that the person personally observed a signatory*  
5 *sign the record.*

6       **Sec. 27.** *As used in this chapter, unless the context otherwise requires, any*  
7 *reference to the father of a child or the mother of a child includes a parent of any*  
8 *gender, and any reference to paternity is equally applicable to parentage.*

9       **Sec. 28.** *Sections 28 to 91, inclusive, of this act may be cited as the Uniform*  
10 *Parentage Act (2017).*

11       **Sec. 29.** *1. Sections 28 to 91, inclusive, of this act apply to an*  
12 *adjudication or determination of parentage.*

13       *2. Sections 28 to 91, inclusive, of this act do not create, affect, enlarge or*  
14 *diminish parental rights or duties under law of this State other than sections 28 to*  
15 *91, inclusive, of this act.*

16       **Sec. 30.** *Each district court may adjudicate parentage under sections 28 to*  
17 *91, inclusive, of this act.*

18       **Sec. 31.** *In any proceeding in which a court of this State has jurisdiction to*  
19 *determine the parentage of a child, the court shall apply the law of this State to*  
20 *adjudicate parentage. The applicable law does not depend on:*

21       *1. The place of birth of the child; or*

22       *2. The past or present residence of the child.*

23       **Sec. 32.** *A proceeding under sections 28 to 91, inclusive, of this act is*  
24 *subject to law of this State other than sections 28 to 91, inclusive, of this act*  
25 *which governs the health, safety, privacy and liberty of a child or other person*  
26 *who could be affected by disclosure of information that could identify the child or*  
27 *other person, including, without limitation, address, telephone number, digital*  
28 *contact information, place of employment, social security number and the child’s*  
29 *day care facility or school.*

30       **Sec. 33.** *To the extent practicable, a provision of sections 28 to 91,*  
31 *inclusive, of this act applicable to a father and child relationship applies to a*  
32 *mother and child relationship and a provision of sections 28 to 91, inclusive, of*  
33 *this act applicable to a mother and child relationship applies to a father and child*  
34 *relationship.*

35       **Sec. 34.** *A parent and child relationship is established between a person*  
36 *and a child if:*

37       *1. The person gives birth to the child, except as otherwise provided in NRS*  
38 *126.500 to 126.810, inclusive, and sections 92 and 93 of this act;*

39       *2. There is a presumption under section 37 of this act of the person’s*  
40 *parentage of the child, unless the presumption is overcome in a judicial*  
41 *proceeding or a valid denial of parentage is made under sections 38 to 51,*  
42 *inclusive, of this act;*

43       *3. The person is adjudicated a parent of the child by a court of this State or*  
44 *any other state;*

45       *4. The person adopts the child;*

46       *5. The person acknowledges parentage of the child under sections 38 to 51,*  
47 *inclusive, of this act, unless the acknowledgment is rescinded under section 45 of*  
48 *this act or successfully challenged under sections 38 to 51, inclusive, or sections*  
49 *69 to 89, inclusive, of this act; or*

50       *6. The person’s parentage of the child is established under NRS 126.500 to*  
51 *126.810, inclusive, and sections 92 and 93 of this act.*

52       **Sec. 35.** *A parent and child relationship extends equally to every child and*  
53 *parent, regardless of the marital status of the parent.*



1       **Sec. 36.** *Unless parental rights are terminated, a parent and child*  
2 *relationship established under sections 28 to 91, inclusive, of this act applies for*  
3 *all purposes.*

4       **Sec. 37.** *1. A person is presumed to be a parent of a child if:*

5       *(a) Except as otherwise provided under NRS 126.500 to 126.810, inclusive,*  
6 *and sections 92 and 93 of this act or law of this State other than sections 28 to 91,*  
7 *inclusive, of this act:*

8       *(1) The person and the person who gave birth to the child are married to*  
9 *or in a domestic partnership with each other and the child is born during the*  
10 *marriage or domestic partnership, whether the marriage or domestic partnership*  
11 *is or could be declared invalid;*

12       *(2) The person and the person who gave birth to the child were married*  
13 *to or in a domestic partnership with each other and the child is born not later*  
14 *than 300 days after the marriage or domestic partnership is terminated by death,*  
15 *divorce, dissolution, annulment or declaration of invalidity, or after a decree of*  
16 *separation or separate maintenance, whether the marriage or domestic*  
17 *partnership is or could be declared invalid; or*

18       *(3) The person and the person who gave birth to the child married or*  
19 *entered into a domestic partnership with each other after the birth of the child,*  
20 *whether the marriage or domestic partnership is or could be declared invalid, the*  
21 *person at any time asserted parentage of the child, and:*

22       *(I) The assertion is in a record filed with the State Registrar of Vital*  
23 *Statistics; or*

24       *(II) The person agreed to be and is named as a parent of the child on*  
25 *the birth certificate of the child; or*

26       *(b) The person resided in the same household with the child for the first 2*  
27 *years of the life of the child, including any period of temporary absence, and*  
28 *openly held out the child as the person's child.*

29       *2. A presumption of parentage under this section may be overcome, and*  
30 *competing claims to parentage may be resolved, only by an adjudication under*  
31 *sections 69 to 89, inclusive, of this act or a valid denial of parentage under*  
32 *sections 38 to 51, inclusive, of this act.*

33       **Sec. 38.** *A person who gave birth to a child and an alleged genetic parent*  
34 *of the child, intended parent under NRS 126.500 to 126.810, inclusive, and*  
35 *sections 92 and 93 of this act, or presumed parent may sign an acknowledgment*  
36 *of parentage to establish the parentage of the child.*

37       **Sec. 39.** *1. An acknowledgment of parentage under section 38 of this act*  
38 *must:*

39       *(a) Be in a record signed by the person who gave birth to the child and by the*  
40 *person seeking to establish a parent and child relationship, and the signatures*  
41 *must be attested by an electronic notary public or other notarial officer or signed*  
42 *by at least one witness;*

43       *(b) State that the child whose parentage is being acknowledged:*

44       *(1) Does not have a presumed parent other than the person seeking to*  
45 *establish the parent and child relationship or has a presumed parent whose full*  
46 *name is stated; and*

47       *(2) Does not have another acknowledged parent, adjudicated parent or*  
48 *person who is a parent of the child under NRS 126.500 to 126.810, inclusive, and*  
49 *sections 92 and 93 of this act other than the person who gave birth to the child;*  
50 *and*

51       *(c) State that the signatories understand that the acknowledgement is the*  
52 *equivalent of an adjudication of parentage of the child and that a challenge to the*

1 *acknowledgment is permitted only under limited circumstances and is barred 2*  
2 *years after the effective date of the acknowledgment.*

3 2. *An acknowledgment of parentage is void if, at the time of signing:*

4 (a) *A person other than the person seeking to establish parentage is a*  
5 *presumed parent, unless a denial of parentage by the presumed parent in a signed*

7 (b) *A person, other than the person who gave birth to the child or the person*  
8 *seeking to establish parentage, is an acknowledged or adjudicated parent or a*  
9 *parent under NRS 126.500 to 126.810, inclusive, and sections 92 and 93 of this*  
10 *act.*

11 **Sec. 40.** *A presumed parent or alleged genetic parent may sign a denial of*  
12 *parentage in a record. The denial of parentage is valid only if:*

13 1. *An acknowledgment of parentage by another person is filed under*  
14 *section 42 of this act;*

15 2. *The signature of the presumed parent or alleged genetic parent is attested*  
16 *by an electronic notary public or other notarial officer or signed by at least one*  
17 *witness; and*

18 3. *The presumed parent or alleged genetic parent has not previously:*

19 (a) *Completed a valid acknowledgment of parentage for the same child,*  
20 *unless the previous acknowledgment was rescinded under section 45 of this act or*  
21 *challenged successfully under section 46 of this act; or*

22 (b) *Been adjudicated to be a parent of the child.*

23 **Sec. 41.** 1. *An acknowledgment of parentage and a denial of parentage*  
24 *may be contained in a single document or may be in counterparts and may be*

33 4. *An acknowledgment of parentage or denial of parentage signed by a*  
34 *person who is a minor is valid if the acknowledgment complies with sections 28 to*  
35 *91, inclusive, of this act.*

36 **Sec. 42.** 1. *Except as otherwise provided in sections 45 and 46 of this act,*  
37 *an acknowledgment of parentage that complies with sections 38 to 51, inclusive,*  
38 *of this act and is filed with the State Registrar of Vital Statistics is equivalent to*  
39 *an adjudication of parentage of the child and confers on the acknowledged*  
40 *parent all rights and duties of a parent.*

41 2. *Except as otherwise provided in sections 45 and 46 of this act, a denial of*  
42 *parentage by a presumed parent or alleged genetic parent which complies with*  
43 *sections 38 to 51, inclusive, of this act and is filed with the State Registrar of Vital*  
44 *Statistics with an acknowledgment of parentage that complies with sections 38 to*  
45 *51, inclusive, of this act is equivalent to an adjudication of the nonparentage of*  
46 *the presumed parent or alleged genetic parent who signed the denial and*  
47 *discharges the presumed parent or alleged genetic parent who signed the denial*  
48 *from all rights and duties of a parent.*

49 **Sec. 43.** *The State Registrar of Vital Statistics may not charge a fee for*  
50 *filing an acknowledgment of parentage or denial of parentage.*

51 **Sec. 44.** *A court conducting a judicial proceeding or an administrative*  
52 *agency conducting an administrative proceeding is not required or permitted to*  
53 *ratify an unchallenged acknowledgment of parentage. A court may determine*

1 *that a person who signed an acknowledgment of parentage is a parent in a later*  
2 *proceeding based on other grounds.*

3 **Sec. 45.** *1. A signatory may rescind an acknowledgment of parentage or*

46 **Sec. 48.** *The court shall give full faith and credit to an acknowledgment of*  
47 *parentage or denial of parentage effective in another state if the acknowledgment or*

9 *inclusive, of this act have the meanings ascribed to them in those sections.*

10       **Sec. 53.** *“Combined relationship index” means the product of all tested*  
11 *relationship indices.*

12       **Sec. 54.** *“Ethnic or racial group” means, for the purpose of genetic testing,*  
13 *a recognized group that a person identifies as the person’s ancestry or part of the*  
14 *ancestry or that is identified by other information.*

15       **Sec. 55.** *“Hypothesized genetic relationship” means an asserted genetic*  
16 *relationship between a person and a child.*

17       **Sec. 56.** *“Probability of parentage” means, for the ethnic or racial group to*  
18 *which a person alleged to be a parent belongs, the probability that a hypothesized*  
19 *genetic relationship is supported, compared to the probability that a genetic*  
20 *relationship is supported between the child and a random person of the ethnic or*  
21 *racial group used in the hypothesized genetic relationship, expressed as a*  
22 *percentage incorporating the combined relationship index and a prior*  
23 *probability.*

24       **Sec. 57.** *“Relationship index” means a likelihood ratio that compares the*  
25 *probability of a genetic marker given a hypothesized genetic relationship and the*  
26 *probability of the genetic marker given a genetic relationship between the child*  
27 *and a random person of the ethnic or racial group used in the hypothesized*  
28 *genetic relationship.*

29       **Sec. 58.** *1. Sections 52 to 68, inclusive, of this act govern genetic testing*  
30 *of a person in a proceeding to adjudicate parentage, whether the person:*

31       (i) *Voluntarily submits to testing; or*

32       (ii) *Is tested under an order of the court or as a result of the facilitation of a*  
33 *child support agency.*

34       *2. Genetic testing may not be used:*

35       (i) *To challenge the parentage of a person who is a parent under NRS*  
36 *126.500 to 126.810, inclusive, and sections 92 and 93 of this act; or*

37       (ii) *To establish the parentage of a person who is a donor.*

38       **Sec. 59.** *1. Except as otherwise provided in sections 52 to 68, inclusive, of*  
39 *this act or sections 69 to 89, inclusive, of this act, in a proceeding under sections*  
40 *28 to 91, inclusive, of this act to determine parentage, the court shall order the*  
41 *child and any other person to submit to genetic testing if a request for testing is*  
42 *supported by the sworn statement of a party:*

43       (i) *Alleging a reasonable possibility that the person is the child’s genetic*  
44 *parent; or*

45       (ii) *Denying genetic parentage of the child and stating facts establishing a*  
46 *reasonable possibility that the person is not a genetic parent.*

47       *2. A child support agency may ~~order~~ facilitate genetic testing only if there*  
48 *is no ~~presumed~~ acknowledged or adjudicated parent of a child other than the*  
49 *person who gave birth to the child.*

50       *3. The court ~~for~~ may not order, and a child support agency may not ~~order~~*  
51 *facilitate, in utero genetic testing.*

52       *4. If two or more persons are subject to court-ordered genetic testing, the*  
53 *court may order that testing be completed concurrently or sequentially.*

1           5. Genetic testing of a person who gave birth to a child is not a condition  
2 precedent to testing of the child and a person whose genetic parentage of the  
3 child is being determined. If the person who gave birth to the child is unavailable  
4 or declines to submit to genetic testing, the court may order genetic testing of the  
5 child and each person whose genetic parentage of the child is being adjudicated.

6           6. In a proceeding to adjudicate the parentage of a child having a presumed  
7 parent or a person who claims to be a parent under section 77 of this act, or to  
8 challenge an acknowledgment of parentage, the court may deny a motion for  
9 genetic testing of the child and any other person after considering the factors in  
10 subsections 1 and 2 of section 81 of this act.

11           7. If a person requesting genetic testing is barred under sections 69 to 89,

14           8. An order under this section for genetic testing is enforceable by  
15 contempt.

16           **Sec. 60.** 1. Genetic testing must be of a type reasonably relied on by  
17 experts in the field of genetic testing and performed in a testing laboratory  
18 accredited by:

19           (a) The AABB, formerly known as the American Association of Blood  
20 Banks, or a successor to its functions; or

21           (b) An accrediting body designated by the Secretary of the United States  
22 Department of Health and Human Services.

23           2. A specimen used in genetic testing may consist of a sample or a  
24 combination of samples of blood, buccal cells, bone, hair or other body tissue or

26 person undergoing genetic testing.

27           3. Based on the ethnic or racial group of a person undergoing genetic  
28 testing, a testing laboratory shall determine the databases from which to select

30 support agency objects to the laboratory's choice, the following rules apply:

31           (a) Not later than 30 days after receipt of the report of the test, the objecting  
32 person or child support agency may request the court to require the laboratory to  
33 recalculate the relationship index using an ethnic or racial group different from  
34 that used by the laboratory.

35           (b) The person or the child support agency objecting to the laboratory's  
36 choice under this subsection shall:

37           (1) If the requested frequencies are not available to the laboratory for the  
38 ethnic or racial group requested, provide the requested frequencies compiled in a  
39 manner recognized by accrediting bodies; or

40           (2) Engage another laboratory to perform the calculations.

41           (c) The laboratory may use its own statistical estimate if there is a question  
42 which ethnic or racial group is appropriate. The laboratory shall calculate the  
43 frequencies using statistics, if available, for any other ethnic or racial group  
44 requested.

45           4. If, after recalculation of the relationship index under subsection 3 using  
46 a different ethnic or racial group, genetic testing under section 62 of this act does  
47 not identify a person as a genetic parent of a child, the court may require a  
48 person who has been tested to submit to additional genetic testing to identify a  
49 genetic parent.

50           **Sec. 61.** 1. A report of genetic testing must be in a record and signed  
51 under penalty of perjury by a designee of the testing laboratory. A report  
52 complying with the requirements of sections 52 to 68, inclusive, of this act is self-

2 sufficient to establish a reliable chain of custody and allow the results of genetic

8           (d) The name of the person who received each specimen in the testing

11           **Sec. 62.** 1. Subject to a challenge under subsection 2, a person is  
12 identified under sections 28 to 91, inclusive, of this act as a genetic parent of a  
13 child if genetic testing complies with sections 52 to 68, inclusive, of this act and  
14 the results of the testing disclose:

15           (a) The person has at least a 99 percent probability of parentage, using a  
16 prior probability of 0.50, as calculated by using the combined relationship index  
17 obtained in the testing; and

18           (b) A combined relationship index of at least 100 to 1.

19           2. A person identified under subsection 1 as a genetic parent of the child  
20 may challenge the genetic testing results only by other genetic testing satisfying  
21 the requirements of sections 52 to 68, inclusive, of this act which:

22           (a) Excludes the person as a genetic parent of the child; or

23           (b) Identifies another person as a possible genetic parent of the child other  
24 than:

25                   (1) The person who gave birth to the child; or

26                   (2) The person identified under subsection 1.

27           3. Except as otherwise provided in section 67 of this act, if more than one  
28 person other than the person who gave birth to the child is identified by genetic  
29 testing as a possible genetic parent of the child, the court shall order each person  
30 to submit to further genetic testing to identify a genetic parent.

31           **Sec. 63.** 1. Subject to assessment of fees under sections 69 to 89,  
32 inclusive, of this act, payment of the cost of initial genetic testing must be made in  
33 advance:

34           (a) ~~By a child support agency in a proceeding in which the child support~~  
35 ~~agency is providing services;~~

36           ~~(b)~~ By the person who made the request for genetic testing;

37           ~~(c)~~ (b) As agreed by the parties; or

39           2. If the cost of genetic testing is paid by a child support agency, the agency  
40 may seek reimbursement from the genetic parent whose parent and child  
41 relationship is established.

42           **Sec. 64.** The court shall order, or a child support agency ~~shall order~~ may  
43 facilitate, additional genetic testing on request of a person who contests the result  
44 of the initial testing under section 62 of this act. If initial genetic testing under  
45 section 62 of this act identified a person as a genetic parent of the child, the court  
46 ~~for agency~~ may not order , and a child support agency may not facilitate,  
47 additional testing unless the contesting person pays for the testing in advance.

48           **Sec. 65.** 1. Subject to subsection 2, if a genetic-testing specimen is not

43 7. *A representative authorized by law of this State other than sections 28 to*  
44 *91, inclusive, of this act to act for a person who otherwise would be entitled to*  
45 *maintain a proceeding but is deceased, incapacitated or a minor.*

46 **Sec. 71.** 1. *The petitioner shall give notice of a proceeding to adjudicate*  
47 *parentage to the following persons ~~++~~, if the whereabouts of the person are*  
48 *known:*

49 (a) *The person who gave birth to the child, unless a court has adjudicated*
