

ASSEMBLY BILL NO. 190—ASSEMBLYWOMAN DIAZ

PREFILED FEBRUARY 13, 2017

Referred to Committee on Commerce and Labor

SUMMARY—Requires certain health and safety training for entertainment industry workers and supervisors. (BDR 53-151)

AN ACT relating to occupational safety; requiring employees on certain sites related to the entertainment industry to receive certain health and safety training; providing civil penalties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 **Section 11** of this bill requires: (1) supervisory employees working on certain
- 2 sites related to the entertainment industry to complete a specified 30-hour health
- 3 and safety course not later than 15 days after being hired; and (2) certain other
- 4 workers working on such a site to complete a specified 10-hour course not later
- 5 than 15 days after being hired.
- 6 **Section 9** of this bill requires the Division of Industrial Relations of the
- 7 Department of Business and Industry to adopt regulations approving courses which
- 8 may be used to fulfill the requirements of **section 11**. **Section 10** of this bill
- 9 requires providers of approved courses to display the card evidencing their
- 10 authorization by the Occupational Safety and Health Administration of the United
- 11 States Department of Labor to provide such a course at the location at which the
- 12 course is being provided.
- 13 **Section 12** of this bill requires employers to suspend or terminate the
- 14 employment of an employee on an applicable site who fails to provide proof of
- 15 obtaining the required training not later than 15 days after being hired. **Section 13**
- 16 of this bill provides for administrative fines for employers who fail to suspend or
- 17 terminate certain employees on a site after the 15-day period if those employees
- 18 have not obtained the required training.
- 19 **Section 16** of this bill: (1) allows employees to satisfy the requirements of
- 20 **section 11** by completing an alternative course offered by their employer; (2)
- 21 requires an employee that satisfies the requirements of **section 11** by completing an
- 22 alternative course to take an approved course before January 1, 2019; and (3)
- 23 requires an employer to maintain and make available to the Division of Industrial



24 Relations a record of all employees that have completed an alternative course until  
25 a date to be established by the Division by regulation.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 618 of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 to 13, inclusive, of this  
3 act.

4       **Sec. 2.** *As used in sections 2 to 13, inclusive, of this act,*  
5 *unless the context otherwise requires, the words and terms defined*  
6 *in sections 3 to 7, inclusive, of this act have the meanings ascribed*  
7 *to them in those sections.*

8       **Sec. 3.** *“OSHA-10 course” means a 10-hour course in*  
9 *general industry safety and health hazard recognition and*  
10 *prevention developed by the Occupational Safety and Health*  
11 *Administration of the United States Department of Labor.*

12       **Sec. 4.** *“OSHA-30 course” means a 30-hour course in*  
13 *general industry safety and health hazard recognition and*  
14 *prevention developed by the Occupational Safety and Health*  
15 *Administration of the United States Department of Labor.*

16       **Sec. 5.** *“Site” means a theater where live entertainment is*  
17 *performed, a sound stage, a showroom, a lounge, an arena or a*  
18 *remote site which has been designated as a location for the*  
19 *production of a motion picture or television program.*

20       **Sec. 6.** *“Supervisory employee” means any person having*  
21 *authority in the interest of the employer to hire, transfer, suspend,*  
22 *lay off, recall, promote, discharge, assign, reward or discipline*  
23 *other employees or responsibility to direct them, to adjust their*  
24 *grievances or effectively to recommend such action, if in*  
25 *connection with the foregoing, the exercise of such authority is*  
26 *not of a merely routine or clerical nature but requires the use of*  
27 *independent judgment. The exercise of such authority shall not be*  
28 *deemed to place the employee in supervisory employee status*  
29 *unless the exercise of such authority occupies a significant portion*  
30 *of the employee’s workday.*

31       **Sec. 7.** *“Worker” means a person employed to perform work*  
32 *on a site, including, without limitation, the construction,*  
33 *installation, maintenance, operation, repair or removal of:*

- 34       1. *Theatrical scenery, rigging or props;*  
35       2. *Wardrobe, hair or makeup;*  
36       3. *Audio, camera, projection, video or lighting equipment; or*  
37       4. *Any other items or parts which are related to or*  
38 *components of the items described in subsection 1, 2 or 3 and*



1 *which are used for or in conjunction with the presentation or*  
2 *production of:*

3 *(a) Live entertainment;*

4 *(b) Filmmaking or photography, including, without limitation,*  
5 *motion pictures;*

6 *(c) Television programs, including, without limitation, live*  
7 *broadcasts, closed-circuit broadcasts or videotape recordings and*  
8 *playback;*

9 *(d) Sporting events; or*

10 *(e) Theatrical performances.*

11 **Sec. 8.** *The Division may adopt such regulations as are*  
12 *necessary to carry out the provisions of sections 2 to 13, inclusive,*  
13 *of this act.*

14 **Sec. 9.** *1. The Division shall, by regulation, approve*  
15 *OSHA-10 courses and OSHA-30 courses for the purposes of*  
16 *fulfilling the requirements of section 11 of this act.*

17 *2. The Division shall establish a registry to track the*  
18 *providers of courses approved pursuant to subsection 1.*

19 *3. The Division shall adopt regulations that set forth*  
20 *guidelines for job-specific training to qualify as continuing*  
21 *education for the purposes of section 11 of this act.*

22 **Sec. 10.** *1. Each trainer shall display his or her trainer*  
23 *card in a conspicuous manner at each location where the trainer*  
24 *provides an OSHA-10 course or OSHA-30 course.*

25 *2. No person other than a trainer may provide an OSHA-10*  
26 *course or OSHA-30 course.*

27 *3. As used in this section:*

28 *(a) "Trainer" means a person who is currently authorized by*  
29 *the Occupational Safety and Health Administration of the United*  
30 *States Department of Labor as a trainer, including, without*  
31 *limitation, a person who has completed OSHA 501, the Trainer*  
32 *Course in OSHA Standards for General Industry.*

33 *(b) "Trainer card" means the card issued upon completion of*  
34 *OSHA 501, the Trainer Course in OSHA Standards for General*  
35 *Industry, which reflects the authorization of the holder by the*  
36 *Occupational Safety and Health Administration of the United*  
37 *States Department of Labor to provide OSHA-10 courses and*  
38 *OSHA-30 courses.*

39 **Sec. 11.** *1. Not later than 15 days after the date a worker*  
40 *other than a supervisory employee is hired, the worker must:*

41 *(a) Obtain a completion card for an OSHA-10 course which is*  
42 *issued upon completion of a course approved by the Division*  
43 *pursuant to section 9 of this act; or*

44 *(b) Complete an OSHA-10 alternative course which is offered*  
45 *by his or her employer.*



1       2. *Not later than 15 days after the date a supervisory*  
2 *employee is hired, the supervisory employee must:*

3       (a) *Obtain a completion card for an OSHA-30 course which is*  
4 *issued upon completion of a course approved by the Division*  
5 *pursuant to section 9 of this act; or*

6       (b) *Complete an OSHA-30 alternative course which is offered*  
7 *by his or her employer.*

8       3. *Any completion card used to satisfy the requirements of*

19 *not less than 5 hours; or*

20           (2) *For a completion card issued for an OSHA-30 course,*  
21 *not less than 15 hours.*

28 *not more than \$500.*

29 (b) *Upon the second violation, in lieu of any other penalty*  
30 *under this chapter, impose upon the employer an administrative*  
31 *fine of not more than \$1,000.*

32 (c) *Upon the third and each subsequent violation, impose upon*  
33 *the employer the penalty provided in NRS 618.635 as if the*  
34 *employer had committed a willful violation.*

35 2. *For the purposes of this section, any number of violations*  
36 *discovered in a single day constitutes a single violation.*

37 3. *Before a fine or any other penalty is imposed upon an*  
38 *employer pursuant to this section, the Division must follow the*  
39 *procedures set forth in this chapter for the issuance of a citation,*  
40 *including, without limitation, the procedures set forth in NRS*  
41 *618.475 for notice to the employer and an opportunity for the*  
42 *employer to contest the violation.*

**Sec. 16.** 1. Not later than January 1, 2019, an employee who satisfies the requirements of subsection 1 or 2 of section 11 of this act by completing an OSHA-10 alternative course or OSHA-30 alternative course, as defined in section 11 of this act, must

complete an OSHA-10 course or OSHA-30 course, as defined in sections 3 and 4 of this act, as applicable, in order to continue to satisfy the requirements of subsection 1 or 2 of section 11 of this act.

2. An employer shall maintain a record of all employees who have completed an OSHA-10 alternative course or OSHA-30 alternative course offered by the employer and the date upon which

complete an OSHA-10 course or OSHA-30 course, as defined in sections 3 and 4 of this act, as applicable, in order to continue to satisfy the requirements of subsection 1 or 2 of section 11 of this act.
