SUMMARY—Provides certain employees with the right to use sick leave to assist certain family members with medical needs. (BDR 53-379)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to employment; requiring, with certain exceptions, private employers that provide employees with sick leave to allow an employee to use such leave to assist a member of the employee's immediate family with certain medical needs; providing a penalty; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law requires a private employer to pay an employee certain minimum compensation and to provide certain benefits, including overtime compensation and meal and rest breaks, with certain exceptions. (NRS 608.018, 608.019, 608.250) **Section 1** of this bill requires a private employer that provides employees with sick leave to allow an employee to use accrued sick leave for an absence due to an illness, injury, medical appointment or other authorized medical need of a member of the employee's immediate family. Additionally, **section 1** authorizes such an employer to limit the amount of sick leave an employee may use for such purposes. **Section 1** also requires the Labor Commissioner to prepare and post a bulletin setting forth an explanation of the provisions of this bill and to require each private employer that provides employees with sick leave to post the bulletin in the workplace. Finally, if an employee is covered under a valid collective bargaining agreement, **section 1** exempts the employer from the provisions of **section 1**.

Section 2 of this bill requires the Labor Commissioner to enforce the provisions of **section 1**, and **section 3** of this bill makes a violation of the



16 provisions of **section 1** a misdemeanor and authorizes the Labor Commissioner to
17 impose, in addition to any other remedy or penalty, a penalty of up to \$5,000 for
18 each violation.

1 WHEREAS, More than 40 million Americans provide unpaid care
2 to someone who is over the age of 18 years and ill or disabled and
3 approximately 4 out of 10 caregivers consider their caregiving
4 situation to be highly stressful and report difficulties with managing
5 emotional and physical stress, balancing work and family
6 responsibilities and finding time for themselves; and

7 WHEREAS, 348,000 Nevada family caregivers provided more
8 than 324,000,000 hours of unpaid care in 2013, estimated at a value
9 of \$4.27 billion; and

10 WHEREAS, According to a 2015 survey of registered voters in
11 Nevada, 58 percent of family caregivers in Nevada have been
12 employed full-time or part-time while providing care; and

13 WHEREAS, After surveying numerous studies, the United States
14 Equal Employment Opportunity Commission determined that
15 flexible workplace policies enhance employee productivity, reduce
16 absenteeism, lower costs, aid in retention and recruitment of the best
17 talent and may positively affect profits; now, therefore,

19 THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
20 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:
21

22 **Section 1.** Chapter 608 of NRS is hereby amended by adding
23 thereto a new section to read as follows:

24 *1. Except as otherwise provided in this section, if an employer*
25 *provides paid or unpaid sick leave for the use of his or her*
26 *employees, the employer must allow an employee to use any*
27 *accrued sick leave to assist a member of the immediate family of*
28 *the employee who has an illness, injury, medical appointment or*
29 *other authorized medical need to the same extent and under the*
30 *same conditions that apply to the employee when taking such*
31 *leave.*

32 *2. An employer may limit the amount of sick leave that an*
33 *employee may use pursuant to subsection 1 to an amount which is*
34 *equal to not less than the amount of sick leave that the employee*
35 *accrues during a 6-month period.*

36 *3. The Labor Commissioner shall prepare a bulletin which*
37 *clearly sets forth an explanation of the provisions of this section.*
38 *The Labor Commissioner shall post the bulletin on the Internet*
39 *website maintained by the Office of the Labor Commissioner and*
40 *shall require each employer that provides sick leave to employees*
41 *to post the bulletin in a conspicuous location in each workplace*



1 *maintained by the employer. The bulletin may be included in any*
2 *printed abstract posted by the employer pursuant to NRS 608.013.*

3 **4. The provisions of this section shall not be construed to:**

4 *(a) Limit or abridge any other rights, remedies or procedures*
5 *available under the law;*

6 *(b) Negate any other rights, remedies or procedures available*
7 *to an aggrieved party;*

8 *(c) Prohibit, preempt or discourage any contract or other*
9 *agreement that provides a more generous sick leave benefit or paid*
10 *time off benefit; or*

11 *(d) Extend the maximum amount of leave to which an*
12 *employee is entitled to take pursuant to the Family and Medical*
13 *Leave Act of 1993, 29 U.S.C. §§ 2601 et seq.*

14 **5. An employer shall not deny an employee the right to use**
15 *accrued sick leave in accordance with the provisions of this*
16 *section or retaliate against an employee for attempting to*
17 *prosecute a violation of this section or for exercising any rights*
18 *afforded by this section.*

19 **6. The provisions of this section do not apply:**

20 *(a) To the extent prohibited by federal law; or*

21 *(b) With regard to an employee of the employer if the employee*
22 *is covered under a valid collective bargaining agreement.*

23 **7. As used in this section, "immediate family" means:**

24 *(a) The child, foster child, spouse, domestic partner, sibling,*
25 *parent, mother-in-law, father-in-law, grandchild, grandparent or*
26 *stepparent of an employee; or*

27 *(b) Any person for whom the employee is the legal guardian.*

28 **Sec. 2.** NRS 608.180 is hereby amended to read as follows:

29 608.180 The Labor Commissioner or the representative of the
30 Labor Commissioner shall cause the provisions of NRS 608.005 to
31 608.195, inclusive, *and section 1 of this act* and NRS 608.215 to
32 be enforced, and upon notice from the Labor Commissioner or the
33 representative:

34 1. The district attorney of any county in which a violation of
35 those sections has occurred;

36 2. The Deputy Labor Commissioner, as provided in
37 NRS 607.050;

38 3. The Attorney General, as provided in NRS 607.160 or
39 607.220; or

40 4. The special counsel, as provided in NRS 607.065,

41 ➔ shall prosecute the action for enforcement according to law.

42 **Sec. 3.** NRS 608.195 is hereby amended to read as follows:

43 608.195 1. Except as otherwise provided in NRS 608.0165,
44 any person who violates any provision of NRS 608.005 to 608.195,



1 inclusive, *and section 1 of this act* or *NRS* 608.215, or any
2 regulation adopted pursuant thereto, is guilty of a misdemeanor.
3 2. In addition to any other remedy or penalty, the Labor
4 Commissioner may impose against the person an administrative
5 penalty of not more than \$5,000 for each such violation.
