

ASSEMBLY BILL NO. 2—COMMITTEE OF THE WHOLE

PREFILED JULY 30, 2020

Referred to Committee of the Whole

SUMMARY—Revises and clarifies provisions relating to the Legislative Department of the State Government. (BDR 17-17)

FISCAL NOTE: Effect on Local Government: Increases or Newly Provides for Term of Imprisonment in County or City Jail or Detention Facility. Effect on the State: No.

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to the Legislative Department of the State Government; enacting provisions governing the use by certain committees of remote-technology systems for conducting committee meetings; providing for the publication of certain joint resolutions proposing amendments to the Nevada Constitution under certain circumstances; revising and clarifying provisions governing the organization, operation and personnel of the Legislative Counsel Bureau; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Under existing law, the Legislative Commission, the Interim Finance Committee and various other legislative committees conduct studies and investigations and perform other legislative business during the interim between legislative sessions. (Chapter 218E of NRS) Additionally, the staff of the Legislative Counsel Bureau serves as the primary administrative or professional staff for various advisory committees whose membership consists of Legislators, other public officials and interested citizens, including the Advisory Commission on the Administration of Justice and the Commission on Special License Plates. (NRS 176.0123, 482.367004)

Sections 2-9 of this bill enact provisions governing the use by such interim, advisory and similar committees of remote-technology systems for committee meetings that enable persons from remote locations to attend, participate, vote or take any other action in the committee meetings even though the persons are not physically present at the committee meetings. However, **sections 2-9** do not apply to the Legislature or session committees during a regular or special session because



16 the use of remote-technology systems by the Legislature and session committees is
17 governed by the rules adopted by the Houses pursuant to their constitutional
18 authority to determine the rules of their proceedings. (Nev. Const. Art. 4, § 6)

19 **Section 8** of this bill provides that each committee subject to **sections 2-9** may
20 conduct committee meetings through the use of authorized remote-technology
21 systems, regardless of whether any physical location is made available for the
22 committee meetings, and the members of the committee may attend, participate,
23 vote or take any other action through the use of authorized remote-technology
24 systems, regardless of whether the members are physically present at the committee
25 meetings. **Section 8** further provides that: (1) the committees must conform, to the
26 extent practicable, with any other requirements for conducting the committee
27 meetings which do not conflict with **sections 2-9**; and (2) the staff of the
28 Legislative Counsel Bureau must make reasonable efforts to ensure that the public
29 can hear or observe the committee meetings and participate in public comment
30 during the committee meetings, except to the extent that such activity is otherwise
31 subject to any lawful requirements or restrictions governing the committee
32 meetings. **Section 8** also provides that the members who use authorized remote-
33 technology systems shall be deemed to be present and in attendance at the
34 committee meetings for all purposes. Finally, **section 8** authorizes committee chairs
35 to take, direct or require any necessary and reasonable actions to carry out the
36 committee meetings conducted through the use of authorized remote-technology
37 systems.

38 Under existing law, a person commits the offense of unlawful interference with
39 the legislative process if the person, without legal authority, willfully engages in
40 conduct that: (1) prevents or attempts to prevent the Legislature or committees from
41 conducting meetings; or (2) disturbs, disrupts or interferes with, or attempts to
42 disturb, disrupt or interfere with, the meetings of the Legislature or committees.
43 (NRS 218A.900, 218A.905) A person who commits such an offense is guilty of a
44 gross misdemeanor and is also subject to injunctive relief, contempt citations and
45 other remedies for the offense. (NRS 218A.900-218A.940)

46 Because the Legislature and session committees may use remote-technology
47 systems when authorized pursuant to the rules adopted by the Houses, this bill
48 amends the offense of unlawful interference with the legislative process to include
49 prohibited acts that interfere with the use of remote-technology systems by the
50 Legislature and session committees and any interim, advisory and similar
51 committees subject to **sections 2-9**. Specifically, **sections 9, 15 and 16** of this bill
52 provide that a person commits the offense of unlawful interference with the
53 legislative process if the person, without legal authority, willfully engages in
54 conduct that: (1) prevents or attempts to prevent the use of remote-technology
55 systems for any sessions or meetings of the Legislature or such committees; or (2)
56 disturbs, disrupts, obstructs, tampers or interferes with, or attempts to disturb,
57 disrupt, obstruct, tamper or interfere with, the use of remote-technology systems for
58 any sessions or meetings of the Legislature or such committees. **Sections 9, 15 and**
59 **16** further provide that a person who commits such an offense is guilty of a gross
60 misdemeanor and is also subject to injunctive relief, contempt citations and other
61 remedies for the offense.

62 Under the Nevada Constitution, in order for the Legislature to submit proposed
63 state constitutional amendments to the voters for approval and ratification: (1) the
64 Legislature must approve the proposed amendments for a first time during a regular
65 or special session; and (2) the next Legislature, which is chosen at the general
66 election following first passage of the proposed amendments, must approve them
67 for a second time during a regular or special session. (Nev. Const. Art. 16, § 1) The
68 Nevada Constitution also requires that, after first approval of the proposed
69 amendments, they must be published for at least 3 months before the date of the



70 general election at which the next Legislature is chosen. (Nev. Const. Art. 16, § 1;
71 *State ex rel. Torreyson v. Grey*, 21 Nev. 378 (1893))

72 **Section 17** of this bill provides that if the Legislature first approves any state
73 constitutional amendments during a special session held in an even-numbered year,
74 the Director of the Legislative Counsel Bureau shall immediately publish a separate
75 printed volume of advance sheets of statutes which includes the full text of the
76 proposed amendments as approved by the Legislature. **Section 17** also states that
77 such publication is deemed to be the publication of the proposed amendments for
78 the purposes of the Nevada Constitution without any additional publication being
79 necessary for that specific purpose.

80 Under existing law, the Director of the Legislative Counsel Bureau serves as
81 the executive head of the five divisions of the Legislative Counsel Bureau, which
82 are the Administrative Division, Audit Division, Fiscal Analysis Division, Legal
83 Division and Research Division, and existing law contains provisions governing the
84 chiefs of those divisions. (Chapters 218F and 218G of NRS)

85 **Sections 13 and 19** of this bill clarify, but do not change, existing law by
86 designating in clearer language that the Senate Fiscal Analyst and the Assembly
87 Fiscal Analyst are the chiefs of the Fiscal Analysis Division. (NRS 218A.030,
88 218F.100) Similarly, **sections 10 and 19** of this bill clarify, but do not change,
89 existing law by defining the term "Chief of the Administrative Division" and
90 adding that term to the provisions of existing law governing the appointment of the
91 chiefs of the divisions of the Legislative Counsel Bureau. (NRS 218F.100)

92 Existing law establishes and codifies the position of the Legislative Counsel as
93 a public office, provides that the Legislative Counsel is the chief of the Legal
94 Division and establishes and defines various legal functions assigned to the Legal
95 Division. (NRS 218A.057, 218F.100, 218F.700-218F.730) Additionally, existing
96 law empowers and directs the Legislative Commission to: (1) supervise the
97 functions assigned to the divisions of the Legislative Counsel Bureau; (2) oversee
98 the organization and operation of those divisions; and (3) approve changes
99 regarding the structure and personnel within those divisions as necessary to manage
100 the workload of the Legislative Counsel Bureau and ensure the completion of the
101 work required for the next regular session. (NRS 218E.180, 218E.225) In carrying
102 out these powers and duties, the Legislative Commission, at its meeting on June 5,
103 2020, approved a revised organizational structure of the Legal Division in which
104 the position of the Chief Litigation Counsel was replaced with the position of the
105 General Counsel in order to better manage the workload of the Legal Division and
106 thereby achieve a more efficient and effective separation of legal functions between
107 the General Counsel and the Legislative Counsel to ensure the completion of the
108 work required for the next regular session.

109 **Sections 11, 14 and 18-25** of this bill facilitate and carry out the revised
110 organizational structure of the Legal Division approved by the Legislative
111 Commission by: (1) establishing and codifying the position of the General Counsel
112 as a public office; (2) providing that the Legislative Counsel and the General
113 Counsel are the chiefs of the Legal Division; (3) setting forth the qualifications,
114 powers and duties of the Legislative Counsel and the General Counsel; and (4)
115 stating that if any particular matter requires an appropriate separation of legal
116 functions within the Legal Division, the Legislative Counsel and the General
117 Counsel shall take necessary and proper actions to ensure that the appropriate
118 separation of legal functions is established and maintained within the Legal
119 Division.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 218A of NRS is hereby amended by
2 adding thereto the provisions set forth as sections 2 to 11, inclusive,
3 of this act.

4 **Sec. 2.** *For the purposes of sections 2 to 9, inclusive, of this*
5 *act, the Legislature finds and declares that when committees use*
6 *authorized remote-technology systems for committee meetings,*
7 *such use:*

8 1. *Promotes and facilitates the efficient and effective*
9 *operation of the committees and encourages and fosters*
10 *participation in the committee meetings by enabling persons from*
11 *remote locations to attend, participate, vote or take any other*
12 *action in the committee meetings even though the persons are not*
13 *physically present at the committee meetings;*

14 2. *Enables Legislators and other public officials to represent*
15 *their constituents and carry out their official powers, functions,*
16 *duties and responsibilities at the committee meetings; and*

17 3. *During periods of emergency, crisis or disaster, safeguards*
18 *the workings of the committees and ensures the continuity and*
19 *efficacy of their operations at the committee meetings and protects*
20 *the health, safety and welfare of persons who participate in the*
21 *committee meetings by serving as a necessary protective or safety*
22 *measure to keep the committee meetings as safe and free as*
23 *reasonably possible from danger, risk, harm, injury and peril.*

24 **Sec. 3.** *As used in sections 2 to 9, inclusive, of this act, unless*
25 *the context otherwise requires, the words and terms defined in*
26 *sections 4 to 7, inclusive, of this act have the meanings ascribed to*
27 *them in those sections.*

28 **Sec. 4.** *“Authorized remote-technology system” means any*
29 *system or other means of communication which is approved by the*
30 *Director and which uses any electronic, digital or other similar*
31 *technology to enable a person from a remote location to attend,*
32 *participate, vote or take any other action in any committee meeting*
33 *even though the person is not physically present at the committee*
34 *meeting.*

35 **Sec. 5.** *“Chair” means the chair of a committee or any other*
36 *member of the committee who is serving as the presiding officer of*
37 *the committee.*

38 **Sec. 6.** 1. *“Committee” means:*

39 (a) *The Legislative Commission and any other legislative*
40 *committee or subcommittee created by a specific statute,*
41 *concurrent resolution or order of the Legislative Commission to*



1 *conduct studies or investigations or perform any other legislative*
2 *business during the legislative interim; and*

3 *(b) Any other commission, committee, subcommittee or similar*
4 *body for which legislative staff serves as the primary*
5 *administrative or professional staff.*

6 *2. The term does not include any legislative committee or*
7 *subcommittee appointed by the Legislature or either House to*
8 *conduct or perform legislative business during a regular or special*
9 *session, including, without limitation, any joint, standing,*
10 *temporary, special or select committee or committee of the whole.*

11 **Sec. 7.** *“Legislative staff” means the staff of the Legislative*
12 *Counsel Bureau.*

13 **Sec. 8. 1.** *Notwithstanding any other provisions of law, the*
14 *provisions of sections 2 to 9, inclusive, of this act apply to a*
15 *committee that conducts a committee meeting through the use of*
16 *any authorized remote-technology systems. In conducting such a*
17 *committee meeting, the committee shall conform, to the extent*
18 *practicable, with any other requirements for conducting the*
19 *committee meeting, unless those other requirements conflict with*
20 *the provisions of sections 2 to 9, inclusive, of this act.*

21 *2. A committee may conduct a committee meeting through*
22 *the use of any authorized remote-technology systems, regardless of*
23 *whether any physical location is made available for the committee*
24 *meeting, and the members of the committee may attend,*
25 *participate, vote or take any other action through the use of any*
26 *authorized remote-technology systems during the committee*
27 *meeting, regardless of whether the members of the committee are*
28 *physically present at the committee meeting.*

29 *3. If a committee conducts a committee meeting through the*
30 *use of any authorized remote-technology systems, legislative staff*
31 *must make reasonable efforts to ensure that members of the public*
32 *can hear or observe the committee meeting and participate in any*
33 *periods devoted to public comment during the committee meeting,*
34 *except to the extent that such activity is otherwise regulated or*
35 *limited by any lawful requirements or restrictions governing the*
36 *committee meeting.*

37 *4. If a member of a committee uses any authorized remote-*
38 *technology systems to attend, participate, vote or take any other*
39 *action during a committee meeting, the member shall be deemed*
40 *to be present and in attendance at the committee meeting for all*
41 *purposes.*

42 *5. For a committee meeting, the chair may take, direct or*
43 *require any necessary and reasonable actions to carry out the*
44 *provisions of sections 2 to 9, inclusive, of this act, including,*
45 *without limitation:*



1 (a) *Requiring that one or more authorized remote-technology*
2 *systems must be used by the members of the committee to conduct*
3 *the committee meeting pursuant to the provisions of sections 2 to*
4 *9, inclusive, of this act.*

5 (b) *Directing that a physical location must not be made*
6 *available for the committee meeting if the chair requires that one*
7 *or more authorized remote-technology systems must be used by the*
8 *members of the committee to conduct the committee meeting*
9 *pursuant to the provisions of sections 2 to 9, inclusive, of this act.*

10 **Sec. 9. 1.** *A person who, without legal authority, willfully*
11 *does any of the following acts, alone or in concert with another,*
12 *interferes with the legislative process:*

13 (a) *Prevents or attempts to prevent the use of any authorized*
14 *remote-technology systems for a committee meeting.*

15 (b) *Disturbs, disrupts, obstructs, tampers or interferes with, or*
16 *attempts to disturb, disrupt, obstruct, tamper or interfere with, the*
17 *use of any authorized remote-technology systems for a committee*
18 *meeting.*

19 2. *A person who interferes with the legislative process in*
20 *violation of any provision of this section is subject to the remedies*
21 *and penalties for interference with the legislative process provided*
22 *by NRS 218A.900 to 218A.940, inclusive.*

23 **Sec. 10.** *“Chief of the Administrative Division” means the*
24 *person appointed or serving as the Chief of the Administrative*
25 *Division pursuant to NRS 218F.100.*

26 **Sec. 11.** *“General Counsel” means the person appointed or*
27 *serving as the General Counsel and a chief of the Legal Division*
28 *pursuant to NRS 218F.100.*

29 **Sec. 12.** NRS 218A.003 is hereby amended to read as follows:
30 218A.003 As used in this title, unless the context otherwise
31 requires, the words and terms defined in NRS 218A.006 to
32 218A.090, inclusive, *and sections 10 and 11 of this act* have the
33 meanings ascribed to them in those sections.

34 **Sec. 13.** NRS 218A.030 is hereby amended to read as follows:
35 218A.030 “Fiscal Analyst” means a person appointed or
36 serving as the Senate Fiscal Analyst or Assembly Fiscal Analyst
37 *and a chief of the Fiscal Analysis Division* pursuant to
38 NRS 218F.100.

39 **Sec. 14.** NRS 218A.057 is hereby amended to read as follows:
40 218A.057 “Legislative Counsel” means the person appointed
41 or serving as the Legislative Counsel and *a* chief of the Legal
42 Division pursuant to NRS 218F.100.



1 **Sec. 15.** NRS 218A.900 is hereby amended to read as follows:

27 *ensures the continuity and efficacy of its operations at the sessions*
28 *and meetings and protects the health, safety and welfare of*
29 *persons who participate in the sessions and meetings by serving as*
30 *a necessary protective or safety measure to keep the sessions and*
31 *meetings as safe and free as reasonably possible from danger, risk,*
32 *harm, injury and peril.*

33 2. As used in NRS 218A.900 to 218A.940, inclusive, unless
34 the context otherwise requires ~~[]~~ :

35 (a) "Legislature" means:

38 ~~[(c)]~~ (3) Any joint committee of both Houses; or

1 (b) *“Remote-technology system” means any system or other*
2 *means of communication which is authorized pursuant to any*
3 *statute, joint rule or rule of either House and which uses any*
4 *electronic, digital or other similar technology to enable a person*
5 *from a remote location to attend, participate, vote or take any*
6 *other action in any session or meeting of the Legislature even*
7 *though the person is not physically present at the session or*
8 *meeting. The term includes, without limitation, a remote-*
9 *technology system authorized pursuant to sections 2 to 9,*
10 *inclusive, of this act.*

11 **Sec. 16.** NRS 218A.905 is hereby amended to read as follows:

12 218A.905 A person who, without legal authority, willfully
13 does any of the following acts, alone or in concert with another,
14 interferes with the legislative process:

15 1. Prevents or attempts to prevent the Legislature from
16 conducting meetings ~~§~~, *including, without limitation, preventing*
17 *or attempting to prevent the use of any remote-technology systems.*

18 2. Disturbs, disrupts, *obstructs, tampers* or interferes with, or
19 attempts to disturb, disrupt, *obstruct, tamper* or interfere with, a
20 meeting of the Legislature ~~§~~, *including, without limitation, the*
21 *use of any remote-technology systems.*

22 3. Withholds, defaces, alters or destroys any official document
23 or record of the Legislature, which conduct interferes with the
24 functioning of the Legislature.

25 4. Withholds, defaces, alters or destroys any property owned or
26 used by the Legislature.

27 5. Remains in the legislative chamber, Legislative Building, or
28 any part thereof, or any other place where the Legislature is
29 conducting its business, after being advised that the law or rule of
30 the Legislature requires persons to leave after being asked to do so,
31 and being asked to leave.

32 6. Prevents or attempts to prevent any Legislator or officer or
33 employee of the Legislative Department from performing that
34 person’s official duties.

35 7. Coerces or attempts to coerce any Legislator or officer or
36 employee of the Legislative Department to perform any act under
37 color of office, by any unlawful means, threats of violence, fraud or
38 intimidation.

39 8. Possesses any firearm, explosive, dangerous device or
40 deadly weapon in the Legislative Building or any other place where
41 the Legislature is conducting its business.

42 **9.** *Commits any act in violation of section 9 of this act.*



1 **Sec. 17.** Chapter 218D of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *Notwithstanding any other provisions of law, for the purposes*
4 *of carrying out the publication of any proposed amendment or*
5 *amendments to the Constitution of the State of Nevada pursuant to*
6 *Section 1 of Article 16 of the Nevada Constitution:*

7 1. *If the Legislature first approves a joint resolution*
8 *proposing any such amendment or amendments during a special*
9 *session held in an even-numbered year, the Director shall*
10 *immediately publish a separate printed volume of advance sheets*
11 *of statutes which includes the full text of the proposed amendment*
12 *or amendments as approved by the Legislature.*

13 2. *Upon publication of the proposed amendment or*
14 *amendments pursuant to this section, such publication shall be*
15 *deemed to be the publication of the proposed amendment or*
16 *amendments for the purposes of Section 1 of Article 16 of the*
17 *Nevada Constitution without any additional publication being*
18 *necessary for those purposes.*

19 **Sec. 18.** NRS 218D.155 is hereby amended to read as follows:

20 218D.155 1. In addition to the number of requests authorized
21 pursuant to NRS 218D.150:

22 (a) The Speaker of the Assembly and the Majority Leader of the
23 Senate may each request before the date of the general election
24 preceding a regular session, without limitation, the drafting of not
25 more than 15 legislative measures for that regular session.

26 (b) The Minority Leader of the Assembly and the Minority
27 Leader of the Senate may each request before the date of the general
28 election preceding a regular session, without limitation, the drafting
29 of not more than 10 legislative measures for that regular session.

30 (c) A person designated after the general election as the Speaker
31 of the Assembly, the Majority Leader of the Senate, the Minority
32 Leader of the Assembly or the Minority Leader of the Senate for the
33 next regular session may request before the first day of that regular
34 session the drafting of the remaining number of the legislative
35 measures allowed for the respective officer that were not requested
36 by the previous officer.

39 request before or during a regular session, without limitation, the
40 drafting of as many legislative measures as are necessary or

43 218F.100 1. There is hereby created the Legislative Counsel
44 Bureau, which consists of a Legislative Commission, an Interim
45 Finance Committee, a Director, an Audit Division, a Fiscal Analysis



1 Division, a Legal Division, a Research Division and an
2 Administrative Division.

3 2. The Legislative Auditor is *the* chief of the Audit Division.

29 *General Counsel*, the Research Director and the Fiscal Analysts
30 require them to make recommendations to the Legislature.

33 the Legislative Counsel Bureau the nature or content of any matter
34 entrusted to the Legislative Counsel Bureau, and such matter is
