SUMMARY—Revises provisions governing the confidentiality of personal information of certain persons. (BDR 20-620)

AN ACT relating to confidential information; authorizing certain persons who perform tasks related to code enforcement to obtain court orders requiring a county assessor, county recorder, the Secretary of State or a county or city clerk to maintain certain personal information in a confidential manner; authorizing such persons to request the Department of Motor Vehicles to display an alternate address on the person's driver's license, commercial driver's license or identification card; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law authorizes certain persons to obtain a court order to require a
2 county assessor, county recorder, the Secretary of State or a city or county clerk to
3 maintain the personal information of the person contained in their records in a
4 confidential manner. The person seeking the order must submit to the court a sworn
5 affidavit that, among other things, sets forth sufficient justification for the request
6 for confidentiality. (NRS 247.530, 250.130, 293.906) The persons authorized to
7 obtain such orders include justices, judges, certain court personnel, certain
8 prosecutors and state or county public defenders. Existing law also authorizes the
9 spouse, domestic partner or minor child of any such person and the surviving
10 spouse, domestic partner or minor child of any such person who was killed in the
11 performance of his or her duties to obtain such orders. (NRS 247.540, 250.140,
12 293.908) **Sections 1-3** of this bill further authorize such orders to be obtained by



13 any inspector, officer or investigator employed by this State or a political
14 subdivision of this State designated by his or her employer who: (1) possesses
15 specialized training in code enforcement; (2) interacts with the public; and (3)
16 whose primary duties are the performance of tasks related to code enforcement.

17 Existing law authorizes certain persons to request that the Department of Motor
18 Vehicles display an alternate address on the person's driver's license, commercial
19 driver's license or identification card. (NRS 481.091) **Section 4** of this bill further
20 authorizes any inspector, officer or investigator employed by this State or a political
21 subdivision of this State designated by his or her employer who: (1) possesses
22 specialized training in code enforcement; (2) interacts with the public; and (3)
23 whose primary duties are the performance of tasks related to code enforcement, to
24 make such requests.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

- 16 (a) Any justice or judge in this State.
- 17 (b) Any senior justice or senior judge in this State.
- 18 (c) Any court-appointed master in this State.
- 19 (d) Any clerk of a court, court administrator or court executive
20 officer in this State.
- 21 (e) Any peace officer or retired peace officer.
- 22 (f) Any prosecutor.
- 23 (g) Any state or county public defender.
- 24 (h) **Any inspector, officer or investigator employed by this State**
25 **or a political subdivision of this State designated by his or her**
26 **employer who possesses specialized training in code enforcement,**
27 **interacts with the public and whose primary duties are the**
28 **performance of tasks related to code enforcement.**

20 3. Any court-appointed master in this State.

22 officer in this State.

23 5. Any district attorney or attorney employed by the district
24 attorney who as part of his or her normal job responsibilities
25 prosecutes persons for:

26 (a) Crimes that are punishable as category A felonies; or

27 (b) Domestic violence.

28 6. Any state or county public defender who as part of his or her
29 normal job responsibilities defends persons for:

30 (a) Crimes that are punishable as category A felonies; or

31 (b) Domestic violence.

45 pursuant to this section may subsequently submit a request to the

2 displayed on his or her driver’s license, commercial driver’s license
3 or identification card instead of the alternate address.

4 4. The Department may adopt regulations to carry out the
5 provisions of this section.

6 *5. As used in this section, “code enforcement” means the*
7 *enforcement of laws, ordinances or codes regulating public*
8 *nuisances or the public health, safety and welfare.*
