

ASSEMBLY BILL NO. 230—ASSEMBLYMEN GRAY, GURR,
YUREK, GALLANT; HANSEN, HIBBETTS AND KOENIG

MARCH 1, 2023

SUMMARY—Revises the deadline for returning mail ballots by mail. (BDR 24-736)

AN ACT relating to elections; revising certain deadlines relating to the return of mail ballots by mail; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law requires that a mail ballot that is mailed to a county or city clerk
2 be postmarked on or before the day of the election and received by 5 p.m. on the
3 fourth day following the election. (NRS 293.269921, 293.269923, 293C.26321,
4 293C.26323) This bill revises this deadline to instead require that a mail ballot that
5 is mailed to a county or city clerk be postmarked on or before the last day of the
6 period for early voting and received before the time set for closing of the polls on
7 the day of the election.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 293.269921 is hereby amended to read as
2 follows:

3 293.269921 1. Except as otherwise provided in subsection 2
4 and chapter 293D of NRS, in order for a mail ballot to be counted
5 for any election, the mail ballot must be:

6 (a) Before the time set for closing of the polls, delivered by hand
7 to the county clerk, or any ballot drop box established in the county
8 pursuant to this section; or

9 (b) Mailed to the county clerk, and:



1 (1) Postmarked on or before the *last* day of the ~~[election;]~~
2 *period for early voting;* and

3 (2) Received by the clerk ~~[not later than 5 p.m. on the fourth]~~
4 *day following] before the time set for closing of the polls on the*
5 *day of the election.*

6 2. If a mail ballot is received by mail ~~[not later than 5 p.m. on]~~
7 ~~the third day following]~~ *before the time set for closing of the polls*
8 *on the day of* the election and the date of the postmark cannot be
9 determined, the mail ballot shall be deemed to have been
10 postmarked on or before the *last* day of the ~~[election.]~~ *period for*
11 *early voting.*

12 3. Each county clerk must establish a ballot drop box at every
13 polling place in the county, including, without limitation, a polling
14 place for early voting. A county clerk may establish a ballot drop
15 box at any other location in the county where mail ballots can be
16 delivered by hand and collected during the period for early voting
17 and on election day. No person other than a clerk may establish a
18 drop box for mail ballots.

19 4. A ballot drop box must be:

20 (a) Constructed of metal or any other rigid material of sufficient
21 strength and resistance to protect the security of the mail ballots; and

22 (b) Capable of securely receiving and holding the mail ballots
23 and being locked.

24 5. A ballot drop box must be:

25 (a) Placed in an accessible and convenient location at the office
26 of the county clerk or a polling place in the county; and

27 (b) Made available for use during the hours when the office of
28 the county clerk, or the polling place, is open for business or voting,
29 as applicable.

30 **Sec. 2.** NRS 293.269923 is hereby amended to read as
31 follows:

32 293.269923 1. Except as otherwise provided in subsection 2,
33 at the request of a voter whose mail ballot has been prepared by or
34 on behalf of the voter, a person authorized by the voter may return
35 the mail ballot on behalf of the voter by mail or personal delivery to
36 the county clerk, or any ballot drop box established in the county,
37 pursuant to NRS 293.269921.

38 2. Except for an election board officer in the course of the
39 election board officer's official duties, a person shall not willfully:

40 (a) Impede, obstruct, prevent or interfere with the return of a
41 voter's mail ballot;

42 (b) Deny a voter the right to return the voter's mail ballot; or

43 (c) If the person receives the voter's mail ballot and
44 authorization to return the mail ballot on behalf of the voter by mail

22 guilty of a category E felony and shall be punished as provided in
23 NRS 193.130.

24 **Sec. 3.** NRS 293C.26321 is hereby amended to read as
25 follows:

26 293C.26321 1. Except as otherwise provided in subsection 2
27 and chapter 293D of NRS, in order for a mail ballot to be counted
28 for any election, the mail ballot must be:

29 (a) Before the time set for closing of the polls, delivered by hand
30 to the city clerk, or any ballot drop box established in the city,
31 pursuant to this section; or

32 (b) Mailed to the city clerk, and:

33 (1) Postmarked on or before the *last* day of the ~~[election;]~~
34 *period for early voting*; and

35 (2) Received by the clerk ~~[not later than 5 p.m. on the fourth~~
36 ~~day following]~~ *before the time set for closing of the polls on the*
37 *day of the election.*

38 2. If a mail ballot is received by mail ~~[not later than 5 p.m. on~~
39 ~~the third day following]~~ *before the time set for closing of the polls*
40 *on the day of the election* and the date of the postmark cannot be
41 determined, the mail ballot shall be deemed to have been
42 postmarked on or before the *last* day of the ~~[election.]~~ *period for*
43 *early voting.*

44 3. Each city clerk must establish a ballot drop box at every
45 polling place in the city, including, without limitation, a polling



1 place for early voting. A city clerk may establish a drop box at any
2 other location in the city where mail ballots can be delivered by
3 hand and collected during the period for early voting and on election
4 day. No person other than a clerk may establish a drop box for mail
5 ballots.

6 4. A ballot drop box must be:

7 (a) Constructed of metal or any other rigid material of sufficient
8 strength and resistance to protect the security of the mail ballots; and

9 (b) Capable of securely receiving and holding the mail ballots
10 and being locked.

11 5. A ballot drop box must be:

12 (a) Placed in an accessible and convenient location at the office
13 of the city clerk, or a polling place in the city; and

14 (b) Made available for use during the hours when the office of
15 the city clerk, or the polling place, is open for business or voting, as
16 applicable.

17 **Sec. 4.** NRS 293C.26323 is hereby amended to read as
18 follows:

19 293C.26323 1. Except as otherwise provided in subsection 2,
20 at the request of a voter whose mail ballot has been prepared by or
21 on behalf of the voter, a person authorized by the voter may return
22 the mail ballot on behalf of the voter by mail or personal delivery to
23 the city clerk, or any ballot drop box established in the city, pursuant
24 to NRS 293C.26321.

25 2. Except for an election board officer in the course of the
26 election board officer's official duties, a person shall not willfully:

27 (a) Impede, obstruct, prevent or interfere with the return of a
28 voter's mail ballot;

29 (b) Deny a voter the right to return the voter's mail ballot; or

30 (c) If the person receives the voter's mail ballot and
31 authorization to return the mail ballot on behalf of the voter by mail
32 or personal delivery, fail to return the mail ballot, unless otherwise
33 authorized by the voter ~~{, by}~~ :

6 *voter three or fewer days before the day of the election.*

7 3. A person who violates any provision of subsection 2 is
8 guilty of a category E felony and shall be punished as provided in
9 NRS 193.130.

10 **Sec. 5.** This act becomes effective on July 1, 2023.
