THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 281.1573 is hereby amended to read as
2 follows:

3 281.1573 1. Each member of the Commission is entitled to
4 receive ~~§80~~ **§150** for each day that the member attends a regularly
5 called meeting of the Commission.

6 2. The first meeting of the Commission must be held on or
7 before June 15 of the year in which the members are appointed.
8 Thereafter, the Chair shall call meetings of the Commission as often
9 as the Chair deems necessary.

10 3. The Director of the Legislative Counsel Bureau shall
11 provide the Commission with administrative support.

12 **Sec. 2.** NRS 281A.210 is hereby amended to read as follows:

13 281A.210 1. The Commission shall:

14 (a) At its first meeting and annually thereafter elect a Chair and
15 Vice Chair from among its members.

16 (b) Meet regularly at least once in each calendar quarter, unless
17 there are no requests made for an opinion pursuant to NRS
18 281A.440, and at other times upon the call of the Chair.

19 2. Members of the Commission are entitled to receive a salary
20 of not more than ~~§80~~ **§150** per day, as fixed by the Commission,
21 while engaged in the business of the Commission.



1 3. While engaged in the business of the Commission, each
2 member and employee of the Commission is entitled to receive the
3 per diem allowance and travel expenses provided for state officers
4 and employees generally.

5 4. The Commission may, within the limits of legislative
6 appropriation, maintain such facilities as are required to carry out its
7 functions.

8 **Sec. 3.** NRS 284.045 is hereby amended to read as follows:

9 284.045 1. While engaged in official business of the
10 Division, the members of the Commission are entitled to receive a
11 salary of not more than ~~180~~ \$150 per day, as fixed by the
12 Commission.

13 2. While engaged in the business of the Division, each member
14 and employee of the Commission is entitled to receive the per diem
15 allowance and travel expenses provided for state officers and
16 employees generally.

17 **Sec. 4.** NRS 286.180 is hereby amended to read as follows:

18 286.180 1. Members of the Board are entitled to receive a fee
19 of ~~180~~ \$150 per day for:

20 (a) Attendance at meetings of the Board;

21 (b) Any official function directly related to the System which is
22 approved by the Board; or

23 (c) Necessary travel to attend a meeting of the Board or a
24 conference or seminar on retirement or to perform an official
25 function described in paragraph (b).

26 2. Fees and reimbursement for expenses must be paid from the
27 Public Employees' Retirement Administrative Fund.

28 3. Fees and reimbursement for expenses must be paid from
29 commitment fees obtained from borrowers whenever the members
30 of the Board hold special meetings or perform official functions, as
31 described in paragraph (b) of subsection 1, which are limited solely
32 to mortgage and real estate investments.

33 **Sec. 5.** NRS 287.042 is hereby amended to read as follows:

34 287.042 1. No member who is a public employee may
35 receive any compensation for the member's services as a member of
36 the Board. Any member who is a public employee must be granted
37 administrative leave from the member's duties to engage in the
38 business of the Board without loss of the member's regular
39 compensation. Such leave does not reduce the amount of the
40 member's other accrued leave.

41 2. A member of the Board who is not a public employee is
42 entitled to receive ~~180~~ \$150 per day for the member's attendance
43 at meetings of the Board.



1 **Sec. 6.** NRS 287.325 is hereby amended to read as follows:
2 287.325 1. The Governor shall appoint a Committee to
3 administer the Program. The Committee must consist of:

4 (a) Three members who are employed by state agencies whose
5 payrolls are administered by the Division of Human Resource
6 Management of the Department of Administration;

7 (b) One member who is employed by a state agency whose
8 payroll is administered by an entity other than the Division of
9 Human Resource Management of the Department of
10 Administration; and

11 (c) One member who has retired from employment by the State
12 of Nevada or the Nevada System of Higher Education.

13 ↳ Each member of the Committee must be a participant in the
14 Program, have participated in the Program for not less than 2 years
15 and have been nominated for membership by five or more persons
16 who have each participated in the Program for not less than 6
17 months.

18 2. After their initial terms, members of the Committee serve
19 terms of 4 years or until their successors have been appointed and
20 have qualified.

21 3. A vacancy on the Committee occurs when a member dies,
22 resigns or becomes ineligible for membership on the Committee. A
23 person becomes ineligible for membership on the Committee when:

24 (a) The person ceases to be a participant in the Program; or

25 (b) Except as otherwise provided in this paragraph, the person
26 ceases to have the qualifications for membership required by the
27 paragraph of subsection 1 under which the person was appointed. A
28 member of the Committee who ceases to have those qualifications
29 may serve the remainder of the member's term if that period does
30 not exceed 24 months.

31 4. The member appointed pursuant to paragraph (c) of
32 subsection 1 must be compensated ~~180~~ \$150 per day from money
33 appropriated from the Program pursuant to NRS 287.365 for
34 attending a meeting of the Committee and for acting at the direction
35 of or on behalf of the Committee.

36 5. For the purposes of this section, "participant in the Program"
37 means a person who is:

38 (a) Deferring compensation pursuant to the Program;

39 (b) Maintaining deferred compensation in the Program; or

40 (c) Receiving payments of deferred compensation pursuant to
41 the Program.

42 **Sec. 7.** NRS 288.100 is hereby amended to read as follows:

43 288.100 1. Each member of the Board is entitled to receive a
44 salary of not more than ~~180~~ \$150, as fixed by the Board, for each
45 day in which the member is engaged in the business of the Board.



1 2. While engaged in the business of the Board, each member
2 and employee of the Board is entitled to receive the per diem
3 allowance and travel expenses provided for state officers and
4 employees generally.

5 **Sec. 8.** NRS 1.390 is hereby amended to read as follows:

6 1.390 1. Each member of the Commission on Judicial
7 Selection who is not a judicial officer is entitled to receive a salary
8 of not more than ~~1.390 1. Each member of the Commission on Judicial~~
9 day's attendance at each meeting of the Commission.

10 2. While engaged in the business of the Commission, each
11 member and employee of the Commission is entitled to receive the
12 per diem allowance and travel expenses provided for state officers
13 and employees generally.

14 **Sec. 9.** NRS 1.430 is hereby amended to read as follows:

15 1.430 1. Each member of the Commission who is not a
16 judicial officer is entitled to receive a salary of not more than ~~1.430 1. Each member of the Commission who is not a~~
17 **\$150**, as fixed by the Commission, for each day's attendance at each
18 meeting of the Commission.

19 2. While engaged in the business of the Commission, each
20 member and employee of the Commission is entitled to receive the
21 per diem allowance and travel expenses provided for state officers
22 and employees generally.

23 **Sec. 10.** NRS 116.600 is hereby amended to read as follows:

24 116.600 1. The Commission for Common-Interest
25 Communities and Condominium Hotels is hereby created.

26 2. The Commission consists of seven members appointed by
27 the Governor. The Governor shall appoint to the Commission:

28 (a) One member who is a unit's owner residing in this State and
29 who has served as a member of an executive board in this State;

30 (b) Two members who are units' owners residing in this State
31 but who are not required to have served as members of an executive
32 board;

33 (c) One member who is in the business of developing common-
34 interest communities in this State;

35 (d) One member who holds a certificate;

36 (e) One member who is a certified public accountant licensed to
37 practice in this State pursuant to the provisions of chapter 628 of
38 NRS; and

39 (f) One member who is an attorney licensed to practice in this
40 State.

41 3. Each member of the Commission must be a resident of this
42 State. At least four members of the Commission must be residents
43 of a county whose population is 700,000 or more.

44 4. Each member of the Commission must have resided in a
45 common-interest community or have been actively engaged in a



1 business or profession related to common-interest communities for
2 not less than 3 years immediately preceding the date of the
3 member's appointment.

4 5. After the initial terms, each member of the Commission
5 serves a term of 3 years. Each member may serve not more than two
6 consecutive full terms. If a vacancy occurs during a member's term,
7 the Governor shall appoint a person qualified under this section to
8 replace the member for the remainder of the unexpired term.

9 6. While engaged in the business of the Commission, each
10 member is entitled to receive:

11 (a) A salary of not more than ~~150~~ \$150 per day, as established
12 by the Commission; and

13 (b) The per diem allowance and travel expenses provided for
14 state officers and employees generally.

15 **Sec. 11.** NRS 231.190 is hereby amended to read as follows:

16 231.190 Each appointed member of the Commission on
17 Tourism is entitled to receive a salary of ~~150~~ \$150 for each day's
18 attendance at a meeting of the Commission.

19 **Sec. 12.** NRS 232.363 is hereby amended to read as follows:

20 232.363 1. The Commission shall meet at the call of the
21 Chair at least 6 times but not more than 12 times a year. A meeting
22 may last for more than 1 day. A majority of the members of the
23 Commission constitutes a quorum and is required to transact any
24 business of the Commission.

25 2. Each member of the Commission is entitled to receive a
26 salary of not more than ~~150~~ \$150, as fixed by the Commission,
27 for each day the member is engaged in the business of the
28 Commission.

29 3. While engaged in the business of the Commission, each
30 member and employee of the Commission is entitled to receive the
31 per diem allowance and travel expenses provided for state officers
32 and employees generally.

33 4. A person is ineligible for appointment to or continued
34 service on the Commission if the person or the person's spouse
35 owns an interest in or is employed by any enterprise or organization,
36 whether or not conducted for profit, which derives 25 percent or
37 more of its gross revenues from the Division of Mental Health and
38 Developmental Services.

39 **Sec. 13.** NRS 232.383 is hereby amended to read as follows:

40 232.383 1. The Grants Management Advisory Committee is
41 hereby created within the Department.

42 2. The Advisory Committee consists of the following 15
43 members appointed by the Director:

44 (a) A superintendent of a county school district or the
45 superintendent's designee;



- 1 (b) A director of a local agency which provides services for
2 abused or neglected children, or the director's designee;
- 3 (c) A member who possesses knowledge, skill and experience in
4 the provision of services to children;
- 5 (d) A representative of a department of juvenile justice services;
- 6 (e) A member who possesses knowledge, skill and experience in
7 the provision of services to senior citizens;
- 8 (f) Two members who possess knowledge, skill and experience
9 in finance or in business generally;
- 10 (g) A representative of the Nevada Association of Counties;
- 11 (h) A member who possesses knowledge, skill and experience in
12 building partnerships between the public sector and the private
13 sector;
- 14 (i) Two members of the public who possess knowledge of or
15 experience in the provision of services to persons or families who
16 are disadvantaged or at risk;
- 17 (j) A member who possesses knowledge, skill and experience in
18 the provision of services to persons with disabilities;
- 19 (k) A member who possesses knowledge, skill and experience in
20 the provision of services relating to the cessation of the use of
21 tobacco;
- 22 (l) A member who possesses knowledge, skill and experience in
23 the provision of health services to children; and
- 24 (m) A representative who is a member of the Nevada
25 Commission on Aging, created by NRS 427A.032, who must not be
26 a Legislator.
- 27 3. An entity who employs a member of the Advisory
28 Committee is not eligible to receive a grant. This subsection does
29 not prohibit an entity that serves solely as the fiscal agent for a
30 recipient of a grant from employing a member of the Advisory
31 Committee.
- 32 4. The Director shall ensure that, insofar as practicable, the
33 members whom the Director appoints reflect the ethnic and
34 geographical diversity of this State.
- 35 5. After the initial terms, each member of the Advisory
36 Committee serves for a term of 2 years. Each member of the
37 Advisory Committee continues in office until his or her successor is
38 appointed.
- 39 6. Each member of the Advisory Committee who is not an
40 officer or employee of this State or a political subdivision of this
41 State is entitled to receive a salary of not more than ~~\$80~~ \$150 per
42 day, fixed by the Director, while engaged in the business of the
43 Advisory Committee.
- 44 7. While engaged in the business of the Advisory Committee,
45 each member of the Advisory Committee is entitled to receive the



1 per diem allowance and travel expenses provided for state officers
2 and employees generally.

3 8. A majority of the members of the Advisory Committee
4 constitutes a quorum for the transaction of business, and a majority
5 of a quorum present at any meeting is sufficient for any official
6 action taken by the Advisory Committee.

7 9. A member of the Advisory Committee who is an officer or
8 employee of this State or a political subdivision of this State must be
9 relieved from his or her duties without loss of regular compensation
10 to prepare for and attend meetings of the Advisory Committee and
11 perform any work necessary to carry out the duties of the Advisory
12 Committee in the most timely manner practicable. A state agency or
13 political subdivision of this State shall not require an officer or
14 employee who is a member of the Advisory Committee to:

15 (a) Make up the time he or she is absent from work to carry out
16 his or her duties as a member of the Advisory Committee; or

17 (b) Take annual leave or compensatory time for the absence.

18 10. The Advisory Committee shall:

19 (a) At its first meeting and annually thereafter, elect a Chair
20 from among its members;

21 (b) Meet at the call of the Director, the Chair or a majority of its
22 members as necessary, within the budget of the Advisory
23 Committee, but not to exceed six meetings per year; and

24 (c) Adopt rules for its own management and government.

25 **Sec. 14.** NRS 232.483 is hereby amended to read as follows:

26 232.483 1. To the extent that money is available for that
27 purpose, each member of the Advisory Committee who is not an
28 officer or employee of the State of Nevada is entitled to receive a
29 salary of not more than ~~1500~~ **1500** per day, as fixed by the Manager
30 in consultation with the Advisory Committee, for each day or
31 portion of a day spent on the business of the Advisory Committee.
32 Each member of the Advisory Committee who is an officer or
33 employee of the State of Nevada serves without additional
34 compensation. To the extent that money is available for that
35 purpose, each member of the Advisory Committee is entitled to
36 receive the per diem allowance and travel expenses provided for
37 state officers and employees generally. A claim for a payment
38 pursuant to this section must be made on a voucher approved by the
39 Manager and paid as other claims against the State are paid.

40 2. Each member of the Advisory Committee who is an officer
41 or employee of the State of Nevada or a local government must be
42 relieved from his or her duties without loss of regular compensation
43 so that he or she may prepare for and attend meetings of the
44 Advisory Committee and perform any work necessary to carry out
45 the duties of the Advisory Committee in the most timely manner



1 practicable. A state agency or local governmental entity may not
2 require an employee who is a member of the Advisory Committee to
3 make up time or take annual vacation or compensatory time for the
4 time that he or she is absent from work to carry out his or her duties
5 as a member of the Advisory Committee.

6 **Sec. 15.** NRS 233.030 is hereby amended to read as follows:

7 233.030 1. The Nevada Equal Rights Commission, consisting
8 of five members appointed by the Governor, is hereby created.

9 2. Each member of the Commission is entitled to receive a
10 salary of not more than ~~150~~ **150**, as fixed by the Commission,
11 for each day actually employed on the work of the Commission.

12 3. While engaged in the business of the Commission, each
13 member and employee of the Commission is entitled to receive the
14 per diem allowance and travel expenses provided for state officers
15 and employees generally.

16 **Sec. 16.** NRS 233A.080 is hereby amended to read as follows:

17 233A.080 1. Commissioners who are not in the regular
18 employ of the State are entitled to receive a salary of not more than
19 ~~150~~ **150**, as fixed by the Commission, for each day spent on the
20 work of the Commission. Commissioners who are in the regular
21 employ of the State shall serve without additional salary.

22 2. While engaged in the business of the Commission, each
23 member and employee of the Commission is entitled to receive the
24 per diem allowance and travel expenses provided for state officers
25 and employees generally.

26 3. Claims for payment of all expenses incurred by the
27 Commission, including the salaries and expenses of its
28 commissioners, must be made on vouchers and paid as other claims
29 against the State are paid.

30 **Sec. 17.** NRS 233C.050 is hereby amended to read as follows:

31 233C.050 1. Each member of the Board is entitled to receive
32 a salary of not more than ~~150~~ **150**, as fixed by the Board, for
33 each day or portion thereof during which the member is in
34 attendance at a regularly called meeting of the Board.

35 2. If provided for in the budget of the Division, each member
36 and employee of the Board, while engaged in the business of the
37 Board, is entitled to receive the per diem allowance and travel
38 expenses provided for state officers and employees generally.

39 **Sec. 18.** NRS 239C.150 is hereby amended to read as follows:

40 239C.150 1. Each member of the Commission who is not a
41 public employee is entitled to receive compensation of not more
42 than ~~150~~ **150** per day, as fixed by the Commission, while
43 engaged in the business of the Commission.

44 2. A member of the Commission who is a public employee
45 may not receive any compensation for his or her services as a



1 member of the Commission. Any member of the Commission who
2 is a public employee must be granted administrative leave from the
3 member's duties to engage in the business of the Commission
4 without loss of his or her regular compensation. Such leave does not
5 reduce the amount of the member's other accrued leave.

6 3. Except during a regular or special session of the Legislature,
7 each legislative member of the Commission is entitled to receive the
8 compensation provided for a majority of the members of the
9 Legislature during the first 60 days of the preceding regular session
10 for each day or portion of a day during which the legislative
11 member attends a meeting of the Commission or is otherwise
12 engaged in the business of the Commission. The compensation and
13 expenses of the legislative members of the Commission must be
14 paid from the Legislative Fund.

15 4. In addition to any compensation received pursuant to this
16 section, while engaged in the business of the Commission, each
17 member and employee of the Commission is entitled to receive the
18 per diem allowance and travel expenses provided for state officers
19 and employees generally.

20 **Sec. 19.** NRS 242.123 is hereby amended to read as follows:

21 242.123 1. The Board shall meet at least once every 3 months
22 and may meet at such further times as deemed necessary by the
23 Chair.

24 2. Members of the Board who are officers or employees of the
25 Executive Department of State Government serve without additional
26 compensation. Members who are not officers or employees of the
27 Executive Department of State Government are entitled to a salary
28 of ~~\$80~~ \$150 for each day or part of a day spent on the business of
29 the Board. All members of the Board are entitled to receive the per
30 diem allowance and travel expenses provided for state officers and
31 employees generally.

32 **Sec. 20.** NRS 315.980 is hereby amended to read as follows:

33 315.980 Each commissioner is entitled to receive
34 compensation of ~~\$80~~ \$150 per day for attendance at meetings of
35 the Authority.

36 **Sec. 21.** NRS 321.5967 is hereby amended to read as follows:

37 321.5967 1. There is hereby created a Board of Review
38 composed of:

39 (a) The Director of the State Department of Conservation and
40 Natural Resources;

41 (b) The Administrator of the Division of Environmental
42 Protection of the State Department of Conservation and Natural
43 Resources;

44 (c) The Administrator of the Division of Minerals of the
45 Commission on Mineral Resources;



1 (d) The Administrator of the Division of State Parks of the State
2 Department of Conservation and Natural Resources;

3 (e) The State Engineer;

4 (f) The State Forester Firewarden;

5 (g) The Chair of the State Environmental Commission;

6 (h) The Director of the State Department of Agriculture;

7 (i) The Chair of the Board of Wildlife Commissioners; and

8 (j) The Administrator of the Office of Historic Preservation of
9 the State Department of Conservation and Natural Resources.

10 2. The Chair of the State Environmental Commission serves as
11 Chair of the Board.

12 3. The Board shall meet at such times and places as are
13 specified by a call of the Chair. Six members of the Board constitute
14 a quorum. The affirmative vote of a majority of the Board members
15 present is sufficient for any action of the Board.

16 4. Except as otherwise provided in this subsection, the
17 members of the Board serve without compensation. The Chair of the
18 State Environmental Commission and the Chair of the Board of
19 Wildlife Commissioners are entitled to receive a salary of not more
20 than ~~1500~~ **1500**, as fixed by the Board, for each day's attendance at
21 a meeting of the Board.

22 5. While engaged in the business of the Board, each member
23 and employee of the Board is entitled to receive the per diem
24 allowance and travel expenses provided for state officers and
25 employees generally.

26 6. The Board:

27 (a) Shall review and approve or disapprove all regulations
28 proposed by the State Land Registrar pursuant to NRS 321.597.

29 (b) May review any decision of the State Land Registrar made
30 pursuant to NRS 321.596 to 321.599, inclusive, if an appeal is taken
31 pursuant to NRS 321.5987, and affirm, modify or reverse the
32 decision.

33 (c) Shall review any plan or statement of policy concerning the
34 use of lands in Nevada under federal management which is
35 submitted by the State Land Use Planning Agency.

36 **Sec. 22.** NRS 341.050 is hereby amended to read as follows:

37 341.050 1. Each appointed member of the Board is entitled to
38 receive a salary of not more than ~~1500~~ **1500** per day, as fixed by the
