AN ACT making an appropriation for allocation to the Nevada Health Service Corps to obtain matching federal money for the purpose of encouraging practitioners of certain health professions to practice in underserved areas; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law authorizes the University of Nevada School of Medicine to: (1)  
2 establish a Nevada Health Service Corps to encourage practitioners of certain  
3 health professions to practice in underserved areas of this State; and (2) apply for  
4 any matching money available for the program from the Federal Government.  
5 (NRS 396.900, 396.902) This bill makes an appropriation from the State General  
6 Fund for allocation to the Nevada Health Service Corps for the purpose of  
7 obtaining such matching federal money.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Office of Finance in the Office of the Governor  
3 for allocation to the Nevada Health Service Corps, established  
4 pursuant to NRS 396.900, for the purpose of obtaining matching  
5 federal money for the program the following sums:



1 For the Fiscal Year 2023-2024..... \$250,000  
2 For the Fiscal Year 2024-2025..... \$250,000

3 2. Any balance of the sums appropriated by subsection 1  
4 remaining at the end of the respective fiscal years must not be  
5 committed for expenditure after June 30 of the respective fiscal  
6 years by the entity to which the appropriation is made or any entity  
7 to which money from the appropriation is granted or otherwise  
8 transferred in any manner, and any portion of the appropriated  
9 money remaining must not be spent for any purpose after  
10 September 20, 2024, and September 19, 2025, respectively, by  
11 either the entity to which the money was appropriated or the entity  
12 to which the money was subsequently granted or transferred, and  
13 must be reverted to the State General Fund on or before  
14 September 20, 2024, and September 19, 2025, respectively.

15 **Sec. 2.** This act becomes effective upon passage and approval.
