AN ACT relating to minority affairs; requiring the Interim Finance Committee, the Legislative Commission and state agencies to provide certain reports to the Nevada Commission on Minority Affairs; requiring the Director of the Department of Business and Industry to provide investigative services to the Ombudsman of Consumer Affairs for Minorities in certain circumstances; revising the duties of the Nevada Commission on Minority Affairs; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law creates the Nevada Commission on Minority Affairs, provides for
2 the duties of the Commission and requires the Director of the Department of
3 Administration to provide such staff assistance to the Commission as the Governor
4 deems appropriate. (NRS 232.852, 232.860, 232.864) **Section 1** of this bill requires
5 the Interim Finance Committee and the Legislative Commission to provide to the
6 Nevada Commission on Minority Affairs any report received by the Interim
7 Finance Committee or the Legislative Commission, respectively, relating to
8 minorities. **Section 1** also requires any state agency that prepares a report relating
9 to the social and economic welfare of minorities to provide a copy of the report to
10 the Nevada Commission on Minority Affairs.

11 **Section 2** of this bill revises the duties of the Nevada Commission on Minority
12 Affairs.

13 Existing law creates the Office of Ombudsman of Consumer Affairs for
14 Minorities within the Office of the Director of the Department of Business and
15 Industry. (NRS 232.845) **Section 1.3** of this bill requires the Director, under certain
16 circumstances, to provide the services of an investigator to the Ombudsman.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 232 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. The Interim Finance Committee and the Legislative*
4 *Commission shall provide to the Commission a copy of any report*
5 *received by the Interim Finance Committee or the Legislative*
6 *Commission, respectively, relating to minorities.*

7 *2. Any agency of the State which prepares a report relating to*
8 *the social and economic welfare of minorities shall provide a copy*
9 *of the report to the Commission.*

10 **Sec. 1.3.** NRS 232.845 is hereby amended to read as follows:

11 232.845 1. The Office of Ombudsman of Consumer Affairs
12 for Minorities is hereby created within the Office of the Director.
13 The Ombudsman shall:

14 (a) Provide for continued educational, outreach and service
15 programs for minority groups pertaining to consumer fraud; and

16 (b) Assist the Nevada Commission on Minority Affairs created
17 by NRS 232.852.

18 2. The Director shall ~~appoint~~ :

19 (a) *Appoint* the Ombudsman of Consumer Affairs for Minorities
20 ~~+~~; and

21 (b) *If the position of investigator is created and filled within*
22 *the Office of the Director, provide the services of the investigator*
23 *to the Ombudsman as requested by the Ombudsman.*

24 3. The Ombudsman of Consumer Affairs for Minorities is:

25 (a) In the unclassified service of the State.

26 (b) Directly responsible to the Director.

27 **Sec. 1.7.** NRS 232.850 is hereby amended to read as follows:

28 232.850 As used in NRS 232.850 to 232.866, inclusive, *and*
29 *section 1 of this act*, unless the context otherwise requires,
30 "Commission" means the Nevada Commission on Minority Affairs
31 created by NRS 232.852.

32 **Sec. 2.** NRS 232.860 is hereby amended to read as follows:

33 232.860 The Commission shall, within the limits of available
34 money:

35 1. Study matters affecting the social and economic welfare and
36 well-being of minorities residing in the State of Nevada;

37 2. Collect and disseminate information on :

- 1 ***(a) Business*** activities, programs and essential services available
2 to minorities in the State of Nevada; ***and***
3 ***(b) The procurement of goods and services by state and local***
4 ***governments from businesses that are owned by minorities;***
5 3. ***Collect information on the employment of minorities in the***
6 ***State of Nevada and provide that information to agencies of the***
7 ***State whose duties relate to training and employment;***
8 4. Study the:
9 (a) Availability of employment for minorities in this State, and
10 the manner in which minorities are employed;
11 (b) Manner in which minorities can be encouraged to start and
12 manage their own businesses successfully; and
13 (c) Availability of affordable housing for minorities;
14 ~~14~~ 5. In cooperation with the Nevada Equal Rights
15 Commission, act as a liaison to inform persons regarding:
16 (a) The laws of this State that prohibit discriminatory practices;
17 and
18 (b) The procedures pursuant to which aggrieved persons may
19 file complaints or otherwise take action to remedy such
20 discriminatory practices;
21 ~~15~~ 6. To the extent practicable, strive to create networks
22 within the business community between businesses that are owned
23 by minorities and businesses that are not owned by minorities;
24 ~~16~~ 7. Advise the Governor on matters relating to minorities
25 and of concern to minorities; and
26 ~~17~~ 8. Recommend proposed legislation to the Governor.
