AN ACT relating to contractors; revising the grounds for disciplinary action against a licensed contractor by the State Contractors' Board to include certain acts related to another person's application for a contractor's license; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law provides for the licensure and regulation of contractors by the  
2 State Contractors' Board. (Chapter 624 of NRS) Existing law requires an applicant  
3 for a license as a contractor to demonstrate certain experience and knowledge.  
4 Under existing law, an applicant may qualify in regard to such experience and  
5 knowledge by the appearance of another person on behalf of the applicant. (NRS  
6 624.260) Existing law also sets forth certain acts or omissions that constitute cause  
7 for disciplinary action against a licensed contractor by the Board. (NRS 624.3016)  
8 This bill provides that the making, or the causing to be made, of a false or  
9 misleading statement or representation, or the omission of a material fact, by a  
10 licensee who is a natural person, an owner of a licensee, a managing officer of a  
11 licensee or any person who qualifies on behalf of a licensee in connection with the  
12 application of another person for a contractor's license for the purpose of assisting  
13 the applicant to obtain the license constitutes cause for disciplinary action by the  
14 Board.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** NRS 624.3016 is hereby amended to read as  
2 follows:

3     624.3016 The following acts or omissions, among others,  
4 constitute cause for disciplinary action under NRS 624.300:

5     1. Any fraudulent or deceitful act committed in the capacity of  
6 a contractor, including, without limitation, misrepresentation or the  
7 omission of a material fact.

8     2. A conviction of a violation of NRS 624.730, or a conviction  
9 in this State or any other jurisdiction of a felony relating to the  
10 practice of a contractor or a crime involving moral turpitude.

11     3. Knowingly making a false statement in or relating to the  
12 recording of a notice of lien pursuant to the provisions of  
13 NRS 108.226.

14     4. Failure to give a notice required by NRS 108.227, 108.245,  
15 108.246 or 624.520.

16     5. Failure to comply with NRS 624.920, 624.930, 624.935 or  
17 624.940 or any regulations of the Board governing contracts for  
18 work concerning residential pools and spas.

19     6. Failure to comply with NRS 624.860 to 624.875, inclusive,  
20 or any regulations of the Board governing contracts for work  
21 concerning residential photovoltaic systems used to produce  
22 electricity.

23     7. Failure to comply with NRS 624.600.

24     8. Misrepresentation or the omission of a material fact, or the  
25 commission of any other fraudulent or deceitful act, to obtain a  
26 license.

27     9. Failure to pay an assessment required pursuant to  
28 NRS 624.470.

29     10. Failure to file a certified payroll report that is required for a  
30 contract for a public work.

31     11. Knowingly submitting false information in an application  
32 for qualification or a certified payroll report that is required for a  
33 contract for a public work.

34     12. Failure to notify the Board of a conviction or entry of a  
35 plea of guilty, guilty but mentally ill or nolo contendere pursuant to  
36 NRS 624.266.

37     13. Failure to provide a builder's warranty as required by NRS  
38 624.602 or to respond reasonably to a claim made under a builder's  
39 warranty.

40     ***14. The making, or the causing to be made, of a false or***  
41 ***misleading statement or representation, or the omission of a***  
42 ***material fact, by a licensee who is a natural person, an owner of a***



1 *licensee, a managing officer of a licensee or any person who*  
2 *qualifies on behalf of a licensee pursuant to subsection 2 of NRS*  
3 *624.260 in connection with the application of another person for a*  
4 *contractor's license for the purpose of assisting the applicant to*  
5 *obtain the license.*

6 **Sec. 2.** This act becomes effective upon passage and approval.
