AN ACT relating to commerce; revising provisions governing the jurisdiction and control over items manufactured or produced within this State; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1      **Section 2** of this bill provides that the Federal Government does not have  
2 jurisdiction or control over items manufactured or produced within this State for the purpose of sale, use or consumption within this State, and **section 4** of this bill  
3 specifies that this State retains sole control over taxes pertaining to such items.  
4 **Section 3** of this bill provides that the Federal Government also does not have  
5 jurisdiction or control over certain items manufactured or produced outside this  
6 State which are imported into this State and used in the manufacture or production  
7 of items within this State for the purpose of sale, use or consumption within this  
8 State.

10     **Section 5** of this bill provides that the Federal Government, pursuant to the Commerce Clause of the United States Constitution, retains jurisdiction and control over items manufactured or produced within this State for the purpose of sale, use or consumption outside this State.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** Title 19 of NRS is hereby amended by adding  
2 thereto a new chapter to consist of the provisions set forth as  
3 sections 2 to 6, inclusive, of this act.

4      **Sec. 2.** *All items which are manufactured or produced within  
5 this State for the purpose of sale, use or consumption within this  
6 State are not subject to the jurisdiction or control of the Federal  
7 Government.*

8      **Sec. 3.** *All items which are manufactured or produced  
9 outside this State, including, without limitation, packaging or  
10 shipping containers, labels, components, ingredients, raw  
11 materials, bottled contents or other items customarily used in the  
12 manufacture or production of items, and which are imported into  
13 this State and used in the manufacture or production of items  
14 within this State for the purpose of sale, use or consumption  
15 within this State are not subject to the jurisdiction or control of the  
16 Federal Government.*

17      **Sec. 4.** *This State retains sole control over all taxes arising  
18 from the intrastate commerce of items which are manufactured or  
19 produced within this State for the purpose of sale, use or  
20 consumption within this State.*

21      **Sec. 5. 1.** *Items which are manufactured or produced  
22 within this State for the purpose of sale, use or consumption  
23 outside this State remain, pursuant to the Commerce Clause of the  
24 United States Constitution, subject to the jurisdiction and control  
25 of, and taxation by, the Federal Government.*

26      **2.** *Items which are manufactured or produced within this  
27 State pursuant to subsection 1 must contain a label with the  
28 following language:*

29                  *For export from the State of Nevada.*

30      **Sec. 6.** *This State may, through separate legislative action,  
31 impose any controls, regulation or taxation deemed appropriate  
32 regarding the manufacture or production of items within this State  
33 for the purpose of sale, use or consumption within this State.*
