SUMMARY—Revises provisions governing the management of  
certain wildlife. (BDR 45-273)

AN ACT relating to wildlife; requiring that the wildlife in this State be managed according to the best science available; revising provisions relating to the authorized use of certain money in the Wildlife Fund Account in the State General Fund; requiring the Board of Wildlife Commissioners to establish policies for certain programs, activities and research relating to predatory wildlife; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

- 1 Under existing law, the Nevada Legislature has declared that wildlife in this
- 2 State is part of the natural resources belonging to the people of the State of Nevada
- 3 and that preserving, protecting, managing and restoring wildlife in this State
- 4 contributes immeasurably to the aesthetic, recreational and economic aspects of
- 5 those natural resources. (NRS 501.100) **Section 1** of this bill revises the legislative
- 6 declaration to require that the wildlife in this State be managed according to the
- 7 best science available.
- 8 Under existing law, in addition to the fee for a game tag, the Department of
- 9 Wildlife charges an additional fee of \$3 for processing each application for a game
- 10 tag, the revenue from which must be deposited into the Wildlife Fund Account in
- 11 the State General Fund and be used by the Department for costs related to: (1)
- 12 programs for the management and control of injurious predatory wildlife; (2)
- 13 wildlife management activities relating to the protection of certain game animals
- 14 and wildlife habitat; and (3) research to determine successful techniques for

15 managing and controlling predatory wildlife. Any program developed or wildlife  
16 management activity or research conducted must be developed or conducted under  
17 the guidance of the Board of Wildlife Commissioners. (NRS 501.181, 502.253)  
18 **Section 2** of this bill requires the Department to use at least 50 percent of the  
19 money credited to the Wildlife Fund Account from the additional \$3 processing fee  
20 for use related to the management and control of injurious predatory wildlife other  
21 than research. **Section 2** further requires the Commission, in providing guidance  
22 relating to any wildlife management activity, the development of a program to  
23 control any species of predatory wildlife or any research concerning that species, to  
24 establish a policy for the activity, program or research that specifies the goals and  
25 required results of the activity, program or research.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 501.100 is hereby amended to read as follows:  
2 501.100 1. Wildlife in this State not domesticated and in its  
3 natural habitat is part of the natural resources belonging to the  
4 people of the State of Nevada **† and must be managed according**  
5 **to the best science available.**  
6 2. The preservation, protection, management and restoration of  
7 wildlife within the State contribute immeasurably to the aesthetic,  
8 recreational and economic aspects of these natural resources.  
9 **Sec. 2.** NRS 502.253 is hereby amended to read as follows:  
10 502.253 1. In addition to any fee charged and collected  
11 pursuant to NRS 502.250, a fee of \$3 must be charged for  
12 processing each application for a game tag, the revenue from which  
13 must be accounted for separately, deposited with the State Treasurer  
14 for credit to the Wildlife Fund Account in the State General Fund  
15 and **, except as otherwise provided in subsection 2,** used by the  
16 Department for costs related to:  
17 (a) Programs for the management and control of **, and research**  
18 **relating to,** injurious predatory **wildlife for the benefit of all other**  
19 **species of** wildlife;  
20 (b) Wildlife management activities relating to the protection of  
21 nonpredatory game animals, sensitive wildlife species and **other**  
22 **species of game animals which are historically subject to or are at**  
23 **risk of excessive predation by predatory wildlife,** and related  
24 wildlife habitat;  
25 (c) Conducting research, as needed, to determine successful  
26 techniques for managing and controlling predatory wildlife,  
27 including studies necessary to ensure effective programs for the  
28 management and control of injurious predatory wildlife; and  
29 (d) Programs for the education of the general public concerning  
30 the management and control of predatory wildlife.



1       2. ~~The~~ *Each year, the Department of Wildlife shall use at*  
2 *least 50 percent of the money credited to the Wildlife Fund*  
3 *Account, from revenue received pursuant to subsection 1, for the*  
4 *uses described in paragraph (a) of that subsection other than*  
5 *research.*

6       3. *Except as otherwise provided in subsection 2, the*  
7 *Department of Wildlife is hereby authorized to expend a portion of*  
8 *the money collected pursuant to subsection 1 to enable the State*  
9 *Department of Agriculture to develop and carry out the programs*  
10 *described in subsection 1.*

11       ~~3.1~~ 4. Any program developed or wildlife management activity  
12 or research conducted pursuant to this section must be developed or  
13 conducted under the guidance of the Commission pursuant to  
14 subsection 2 of NRS 501.181.

15       ~~4.1~~ *In providing guidance for the development of a program*  
16 *to control any species of predatory wildlife or for conducting any*  
17 *wildlife management activity or research concerning that species,*  
18 *the Commission shall establish a policy for the program, activity*  
19 *or research. Each policy must specify the goals and required*  
20 *results of the program, activity or research, including, without*  
21 *limitation, provisions:*

22       (a) *Setting forth a specific geographic area in this State in*  
23 *which the program, activity or research must be conducted;*

24       (b) *Setting forth the reasons for conducting the program,*  
25 *activity or research in the geographic area;*

26       (c) *Setting forth the estimated population or density of each*  
27 *species of predatory wildlife and the location of the estimated*  
28 *population or density in the geographic area which must be*  
29 *included in the program, activity or research; and*

30       (d) *Requiring the submission of a report to the Commission*  
31 *upon the completion of the program, activity or research setting*  
32 *forth the results of the program, activity or research and the extent*  
33 *to which the program, activity or research achieved the goals and*  
34 *required results established for the program, activity or research.*

35       5. The money in the Wildlife Fund Account remains in the  
36 Account and does not revert to the State General Fund at the end of  
37 any fiscal year.
