SUMMARY—Revises provisions governing contracts for services entered into by certain public employees. (BDR 23-85)

AN ACT relating to state personnel; exempting certain persons from the restrictions on contracts with or the employment of certain employees by a state agency; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law, with certain exceptions, provides certain restrictions on the  
2 employment of or contracting with current and former state employees by state  
3 agencies. (NRS 284.1729) This bill revises these exceptions: (1) to allow an agency  
4 to contract with a current employee of another agency without the approval of the  
5 State Board of Examiners; and (2) to provide that, in a county whose population is  
6 less than 55,000 (currently counties other than Carson City and Clark and Washoe  
7 Counties), a department, division or other agency of this State is authorized to enter  
8 into a contract that requires a person to perform seasonal work for the department,  
9 division or agency without the approval of the Board.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 284.1729 is hereby amended to read as  
2 follows:

3 284.1729 1. Except as otherwise provided in this section, a  
4 department, division or other agency of this State shall not enter into  
5 a contract with a person to provide services for the agency if:

6 (a) The person is a current employee of ~~that~~ *that department,*  
7 *division or* agency ; ~~of this State;~~



1 (b) The person is a former employee of an agency of this State  
2 and less than 2 years have expired since the termination of the  
3 person's employment with the State; or

4 (c) The person is employed by the Department of Transportation  
5 for a transportation project that is entirely funded by federal money  
6 and the term of the contract is for more than 4 years,

7 unless, before the contract is executed by the agency, the State  
8 Board of Examiners approves the employment of the person. The  
9 requirements of this subsection apply to any person employed by a  
10 business or other entity that enters into a contract to provide services  
11 for a department, division or agency of this State if the person will  
12 be performing or producing the services for which the business or  
13 entity is employed.

14 2. The provisions of paragraph (b) of subsection 1 apply to  
15 employment through a temporary employment service. A temporary  
16 employment service providing employees for a state agency shall  
17 provide the agency with the names of the employees to be provided  
18 to the agency. The State Board of Examiners shall not approve a  
19 contract pursuant to paragraph (b) of subsection 1 unless the Board  
20 determines that one or more of the following circumstances exist:

21 (a) The person provides services that are not provided by any  
22 other employee of the agency or for which a critical labor shortage  
23 exists; or

24 (b) A short-term need or unusual economic circumstance exists  
25 for the agency to contract with the person.

26 3. A department, division or other agency of this State may  
27 contract with a person pursuant to paragraph (a) or (b) of subsection  
28 1 without obtaining the approval of the State Board of Examiners if  
29 ~~that~~ :

30 (a) *The* term of the contract is for less than 4 months and the  
31 executive head of the department, division or agency determines  
32 that an emergency exists which necessitates the contract **H**; or

33 (b) *In a county whose population is less than 55,000, the*  
34 *contract is with a person to perform seasonal work.*

35 If a department, division or agency contracts with a person  
36 pursuant to this subsection, the department, division or agency shall  
37 submit a copy of the contract and a description of the emergency **or**  
38 **seasonal work** to the State Board of Examiners, which shall review  
39 the contract and the description of the emergency **or seasonal work**  
40 and notify the department, division or agency whether the State  
41 Board of Examiners would have approved the contract if it had not  
42 been entered into pursuant to this subsection.

43 4. Except as otherwise provided in subsection 9, a department,  
44 division or other agency of this State shall, not later than 10 days  
45 after the end of each fiscal quarter, report to the Interim Finance



1 Committee concerning all contracts to provide services for the  
2 agency that were entered into by the agency during the fiscal quarter  
3 with a person who is a current or former employee of a department,  
4 division or other agency of this State.

5 5. Except as otherwise provided in subsection 9, a department,  
6 division or other agency of this State shall not contract with a  
7 temporary employment service unless the contracting process is  
8 controlled by rules of open competitive bidding.

9 6. Each board or commission of this State and each institution  
10 of the Nevada System of Higher Education that employs a  
11 consultant shall, at least once every 6 months, submit to the Interim  
12 Finance Committee a report setting forth:

13 (a) The number of consultants employed by the board,  
14 commission or institution;

15 (b) The purpose for which the board, commission or institution  
16 employs each consultant;

17 (c) The amount of money or other remuneration received by  
18 each consultant from the board, commission or institution; and

19 (d) The length of time each consultant has been employed by the  
20 board, commission or institution.

21 7. A department, division or other agency of this State,  
22 including a board or commission of this State and each institution of  
23 the Nevada System of Higher Education:

24 (a) Shall make every effort to limit the number of contracts it  
25 enters into with persons to provide services which have a term of  
26 more than 2 years and which are in the amount of less than \$1  
27 million; and

28 (b) Shall not enter into a contract with a person to provide  
29 services without ensuring that the person is in active and good  
30 standing with the Secretary of State.

31 8. The provisions of chapter 333 of NRS that are not in conflict  
32 or otherwise inconsistent with this section apply to a contract  
33 entered into pursuant to this section.

34 9. The provisions of subsections 1 to 5, inclusive, do not apply  
35 to:

36 (a) The Nevada System of Higher Education or a board or  
37 commission of this State.

38 (b) The employment of professional engineers by the  
39 Department of Transportation if those engineers are employed for a  
40 transportation project that is entirely funded by federal money.

41 (c) Contracts in the amount of \$1 million or more entered into:

42 (1) Pursuant to the State Plan for Medicaid established  
43 pursuant to NRS 422.271.

44 (2) For financial services.

45 (3) Pursuant to the Public Employees' Benefits Program.



1 (d) The employment of a person by a business or entity which is  
2 a provider of services under the State Plan for Medicaid and which  
3 provides such services on a fee-for-service basis or through  
4 managed care.

5 *10. As used in this section, "seasonal work" means full-time*  
6 *work which is performed by an employee who is employed on a*  
7 *full-time basis throughout the year working on different tasks*  
8 *during the various seasons of year, including, without limitation,*  
9 *driving a snowplow, building maintenance and maintaining*  
10 *landscaping.*

11 **Sec. 2.** This act becomes effective on July 1, 2013.
