SUMMARY—Creates the crime of bestiality. (BDR 15-29)

## AN ACT relating to crimes; creating the crime of bestiality; providing a penalty; and providing other matters properly relating thereto.

## Legislative Counsel's Digest:

1 Existing law creates various crimes against public decency and good morals and provides penalties to be imposed upon persons who commit such crimes. (Chapter 201 of NRS) This bill creates the crime of bestiality and sets forth the punishment for the crime.

23456789 Under this bill, a person who commits the crime of bestiality is guilty of a gross misdemeanor, except that the penalty is increased to a category C felony if: (1) the animal dies or suffers serious bodily injury as the result of the crime; or (2) the person has a previous felony conviction for animal cruelty. This bill further authorizes the court to order a person convicted of the crime of bestiality: (1) to undergo a psychological evaluation and any recommended counseling and to pay the expenses for such an evaluation and counseling; (2) to relinquish and 10 11 12 permanently forfeit all animals which are owned by the person and which reside in the same household as the person; (3) not to harbor any animal or reside in any household where an animal is present for a period determined by the court; and (4) 13 14 15 to pay all reasonable costs incurred for the care and maintenance of the animal 16 involved in the crime and any other animal that is relinquished by the person.





## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Chapter 201 of NRS is hereby amended by adding Section 1. 1 2 thereto a new section to read as follows: 3 1. A person commits the crime of bestiality if the person 4 knowingly and intentionally: 5 (a) Engages in sexual conduct with an animal; 6 (b) Causes another person to engage in sexual conduct with an animal or aids or abets another person in engaging in sexual 7 8 conduct with an animal: 9 (c) Permits any sexual conduct with an animal to be conducted on any premises under the control of the person; 10 (d) Engages in, organizes, promotes, conducts, advertises, aids, 11 abets, participates in as an observer or performs any service in the 12 furtherance of an act involving any sexual conduct with an animal 13 for a commercial or recreational purpose; or 14 (e) Photographs or films, for purposes of his or her sexual 15 gratification or the sexual gratification of another person, a 16 person engaged in sexual conduct with an animal. 17 18 2. A person who commits the crime of bestiality is guilty of: 19 (a) If the crime does not cause the death of or serious bodily injury to an animal involved in the crime and the person has not 20 previously been convicted of a violation of NRS 574.100 21 22 punishable as a felony, a gross misdemeanor. 23 (b) If the crime causes the death of or serious bodily injury to an animal involved in the crime or if the person has previously 24 been convicted of a violation of NRS 574.100 punishable as a 25 felony, a category C felony and shall be punished as provided in 26 27 NRS 193.130. In addition to any other penalty imposed by the court, the 28 3. court may order a person convicted of the crime of bestiality to 29 comply with any or all of the following: 30 a psychological evaluation and 31 (a) Undergoing anv recommended counseling and to pay the expenses for the 32 psychological evaluation and any recommended counseling. 33 (b) Relinquishing and permanently forfeiting all animals 34 which are owned by the person and which reside in the same 35 household as the person to an animal shelter, an organization that 36 takes into custody animals which have been abused or neglected, 37 38 or a society for the prevention of cruelty to animals established pursuant to NRS 574.010. 39 40 (c) Not harboring or keeping any animal or residing in any household where an animal is present for a period determined by 41

(d) Paying all reasonable costs incurred for the care and 1 maintenance of the animal involved in the crime and any other 2 animal relinquished by the person to an animal shelter, an organization that takes into custody animals which have been 3 4 abused or neglected, or a society for the prevention of cruelty to 5 animals established pursuant to NRS 574.010. 6 7

4. As used in this section:

(a) "Animal" means every living creature other than a human 8 9 being.

(b) "Animal shelter" has the meaning ascribed to it in 10 NRS 574.240. 11

12 (c) "Licensed veterinarian" has the meaning ascribed to it in 13 NRS 638.007.

(d) "Sexual conduct" means any sexual act involving:

15 (1) The genitalia of a person and the genitalia, anus or mouth of an animal; 16

17 (2) The genitalia of an animal and the genitalia, anus or 18 mouth of a person; or

19 (3)  $\overline{A}$  foreign object and the genitalia or anus of an animal.

• "Sexual conduct" does not include an accepted practice of 20

animal husbandry, any practice relating to conformation judging, 21

or any medical procedure performed by a licensed veterinarian 22 engaging in the practice of veterinary medicine. 23
