AN ACT relating to land use planning; setting forth legislative findings and declarations concerning certain changes in zoning and development standards; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill: (1) sets forth legislative findings relating to proposed changes in
2 zoning and hillside development standards on the undeveloped lands adjacent to the
3 Sunrise and Frenchman Mountains; and (2) declares that it is consistent with the
4 Legislature’s intent that the Board of Commissioners of Clark County maintain
5 the existing zoning and hillside development standards on the undeveloped desert
6 lands adjacent to the western faces of Sunrise and Frenchman Mountains.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. The Legislature hereby finds that:
2 (a) Sunrise Mountain and Frenchman Mountain are undeveloped
3 natural treasures adjacent to the Las Vegas Valley;
4 (b) The Bureau of Land Management has designated over
5 10,000 acres of land encompassing Sunrise and Frenchman
6 Mountains as the Sunrise Mountain Instant Study Area;



1 (c) The Sunrise Mountain Instant Study Area is located
2 approximately 8 miles east of downtown Las Vegas and provides a
3 close and convenient natural mountain xeriscape for the residents of
4 southern Nevada;

5 (d) The Sunrise Mountain Instant Study Area has the Nellis Air
6 Force Base as its neighbor to the north and has easy access to
7 visitors provided by State Route 147;

8 (e) With an elevation variance of nearly 2,000 feet, the Sunrise
9 Mountain Instant Study Area is home to several colorful mountain
10 ranges rising up from the desert lowlands of urban eastern Las
11 Vegas and eastern unincorporated Clark County;

12 (f) In the northeastern corner of the Sunrise Mountain Instant
13 Study Area, Gypsum Cave holds some of the earliest evidence of
14 human inhabitation in the western United States;

15 (g) The Great Unconformity provides the opportunity for
16 southern Nevada geologists and students to view and study an
17 exposed surface of rock that represents more than one quarter of the
18 history (1.2 billion years) of the Earth's crust and tectonic plates;

19 (h) Low desert scrub covers the Sunrise Mountain Instant Study
20 Area and several plant species live within the area that have
21 received special status designation by the Bureau of Land
22 Management;

23 (i) Many residents who live adjacent to Sunrise and Frenchman
24 Mountains decided to live there because they like being somewhat
25 close to urban Las Vegas, and yet also being able to enjoy the peace
26 and quiet of living on the edge of the undeveloped desert in the
27 foothills of Sunrise and Frenchman Mountains;

28 (j) Many residents of Nevada enjoy the natural desert landscape
29 of and outdoor recreational opportunities provided by Sunrise and
30 Frenchman Mountains, including, without limitation, hiking,
31 climbing, camping, rockhounding and bird-watching;

32 (k) Developers are planning large-scale developments on
33 previously undeveloped lands adjacent to the western faces of
34 Sunrise and Frenchman Mountains;

35 (l) These developers are pursuing zoning changes and waivers of
36 established hillside development standards to increase the density of
37 potential developments on the undeveloped lands adjacent to
38 Sunrise and Frenchman Mountains; and

39 (m) Neighbors have expressed grave concerns about the impact
40 any potential zoning changes and waivers of hillside development
41 standards will have on their quality of life, including, without
42 limitation, impacts on traffic, parks, schools, police and fire
43 services, demand for water and flood control and potential negative
44 environmental impacts on this state treasure.



1 2. The Legislature hereby declares that it is consistent with the
2 Legislature's intent that the Board of Commissioners of Clark
3 County maintain the existing zoning and hillside development
4 standards on the undeveloped desert lands adjacent to the western
5 faces of Sunrise Mountain and Frenchman Mountain.
6 **Sec. 2.** This act becomes effective upon passage and approval.
