SUMMARY—Revises provisions concerning the identification of seasonal residents and establishes provisions concerning the permitting of the motor vehicles of seasonal residents. (BDR 43-414)

AN ACT relating to motor vehicles; providing for the issuance of special indicia of the permitting of a motor vehicle of a seasonal resident; modifying the provisions pertaining to the issuance of an identification card to a seasonal resident; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law defines the term “seasonal resident,” in relevant part, as a  
2 person who is not a resident of the State of Nevada but who temporarily  
3 resides in this State for a period of at least 31 consecutive days in each  
4 calendar year, returns to his or her state of residence at least once in each  
5 calendar year, is registered to vote or pays income tax in another state or  
6 jurisdiction and does not engage in gainful employment in this State. (NRS  
7 481.052; NAC 481.005) **Section 3** of this bill allows the Department of  
8 Motor Vehicles to issue to a seasonal resident a decal, sticker or other indicia  
9 of a seasonal resident permit for a motor vehicle if the motor vehicle meets certain  
10 criteria. **Section 3** also deems an out-of-state student to be a seasonal resident  
11 for the purpose of obtaining such a decal, sticker or other indicia. **Section 5** of this  
12 bill modifies the fees charged for an identification card issued to a seasonal  
13 resident and specifies that such a card is valid for a period of 4 years unless  
14 suspended, cancelled or revoked. **Section 5** also deems an out-of-state student  
15 to be a seasonal resident for the purpose of obtaining such an identification card.  
16 **Sections 2 and 4** of this bill allow a seasonal resident who possesses valid  
17 indicia of a seasonal resident permit for a motor vehicle and a valid identification  
18 card for a seasonal resident to operate the motor vehicle upon the highways

19 of this State without registering the vehicle in this State in the same manner as  
20 would be required of a vehicle of a resident of this State.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 482 of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *A seasonal resident may operate a motor vehicle upon*  
4 *the highways of this State without registering the vehicle in this*  
5 *State pursuant to this chapter if the seasonal resident:*

6 *1. Possesses and displays a valid decal, sticker or other*  
7 *indicia of seasonal permitting that is issued pursuant to section 3*  
8 *of this act; and*

9 *2. Possesses a valid identification card for seasonal residents*  
10 *that is issued pursuant to section 5 of this act.*

11 **Sec. 3.** *1. The Department may issue to a seasonal resident*  
12 *a decal, sticker or other indicia of a seasonal resident permit for a*  
13 *motor vehicle, if the motor vehicle:*

14 *(a) Is a private passenger vehicle, a noncommercial truck or a*  
15 *recreational vehicle;*

16 *(b) Is not a commercial vehicle or otherwise used for business*  
17 *purposes;*

18 *(c) Is registered currently and validly in the state of which the*  
19 *owner or operator of the motor vehicle is a resident; and*

20 *(d) Is insured currently and validly in the state of which the*  
21 *owner or operator of the motor vehicle is a resident.*

22 *2. The Department shall not require the payment of any*  
23 *governmental services tax as a condition of issuing a decal, sticker*  
24 *or other indicia of seasonal permitting pursuant to this section.*

25 *3. A decal, sticker or other indicia of seasonal permitting that*  
26 *is issued pursuant to this section must be displayed:*

27 *(a) On the lower left corner of the rear window of the motor*  
28 *vehicle for which it is issued; or*

29 *(b) In another location specified by regulation of the*  
30 *Department.*

31 *4. Except as otherwise provided in subsection 5, a decal,*  
32 *sticker or other indicia of seasonal permitting that is issued*  
33 *pursuant to this section expires 1 year after the date on which it is*  
34 *issued.*

35 *5. The Department may suspend, cancel or revoke a decal,*  
36 *sticker or other indicia of seasonal permitting that is issued*  
37 *pursuant to this section for any reason that would justify the*



1 *suspension, cancellation or revocation, as applicable, of an*  
2 *ordinary motor vehicle registration under the laws of this State.*

3 6. *The fee for the initial issuance of a decal, sticker or other*  
4 *indicia of seasonal permitting that is issued pursuant to this*  
5 *section is \$18. The fee for the renewal of a decal, sticker or other*  
6 *indicia of seasonal permitting that is issued pursuant to this*  
7 *section is \$18.*

8 7. *For the purpose of obtaining a decal, sticker or other*  
9 *indicia of seasonal permitting that is issued pursuant to this*  
10 *section, an out-of-state student shall be deemed to be a seasonal*  
11 *resident.*

12 8. *The Department may adopt regulations to carry out the*  
13 *provisions of this section.*

14 **Sec. 4.** NRS 482.385 is hereby amended to read as follows:

15 482.385 1. Except as otherwise provided in subsections 5 and  
16 7 and NRS 482.390, a nonresident owner of a vehicle of a type  
17 subject to registration pursuant to the provisions of this chapter,  
18 owning any vehicle which has been registered for the current year in  
19 the state, country or other place of which the owner is a resident and  
20 which at all times when operated in this State has displayed upon it  
21 the registration license plate issued for the vehicle in the place of  
22 residence of the owner, may operate or permit the operation of the  
23 vehicle within this State without its registration in this State  
24 pursuant to the provisions of this chapter and without the payment  
25 of any registration fees to this State:

26 (a) For a period of not more than 30 days in the aggregate in any  
27 1 calendar year; and

28 (b) Notwithstanding the provisions of paragraph (a), during any  
29 period in which the owner is:

30 (1) On active duty in the military service of the United  
31 States;

32 (2) An out-of-state student;

33 (3) Registered as a student at a college or university located  
34 outside this State and who is in the State for a period of not more  
35 than 6 months to participate in a work-study program for which the  
36 student earns academic credits from the college or university; ~~for~~

37 (4) A migrant or seasonal farm worker ~~for~~; or

38 (5) *A seasonal resident who is authorized to operate a*  
39 *motor vehicle upon the highways of this State pursuant to section*  
40 *2 of this act.*

41 2. This section does not:

42 (a) Prohibit the use of manufacturers', distributors' or dealers'  
43 license plates issued by any state or country by any nonresident in  
44 the operation of any vehicle on the public highways of this State.



1 (b) Require registration of vehicles of a type subject to  
2 registration pursuant to the provisions of this chapter operated by  
3 nonresident common motor carriers of persons or property, contract  
4 motor carriers of persons or property, or private motor carriers of  
5 property as stated in NRS 482.390.

6 (c) Require registration of a vehicle operated by a border state  
7 employee.

8 3. Except as otherwise provided in subsection 5, when a  
9 person, formerly a nonresident, becomes a resident of this State, the  
10 person shall:

11 (a) Within 30 days after becoming a resident; or

12 (b) At the time he or she obtains a driver's license,

13 ↪ whichever occurs earlier, apply for the registration of each  
14 vehicle the person owns which is operated in this State. When a  
15 person, formerly a nonresident, applies for a driver's license in this  
16 State, the Department shall inform the person of the requirements  
17 imposed by this subsection and of the penalties that may be imposed  
18 for failure to comply with the provisions of this subsection.

19 4. A citation may be issued pursuant to subsection 1, 3 or 5  
20 only if the violation is discovered when the vehicle is halted or its  
21 driver arrested for another alleged violation or offense. The  
22 Department shall maintain or cause to be maintained a list or other  
23 record of persons who fail to comply with the provisions of  
24 subsection 3 and shall, at least once each month, provide a copy of  
25 that list or record to the Department of Public Safety.

26 5. Except as otherwise provided in this subsection, a resident or  
27 nonresident owner of a vehicle of a type subject to registration  
28 pursuant to the provisions of this chapter who engages in a trade,  
29 profession or occupation or accepts gainful employment in this State  
30 or who enrolls his or her children in a public school in this State  
31 shall, within 30 days after the commencement of such employment  
32 or enrollment, apply for the registration of each vehicle the person  
33 owns which is operated in this State. The provisions of this  
34 subsection do not apply to a nonresident who is:

35 (a) On active duty in the military service of the United States;

36 (b) An out-of-state student;

37 (c) Registered as a student at a college or university located  
38 outside this State and who is in the State for a period of not more  
39 than 6 months to participate in a work-study program for which the  
40 student earns academic credits from the college or university; or

41 (d) A migrant or seasonal farm worker.

42 6. A person who violates the provisions of subsection 1, 3 or 5  
43 is guilty of a misdemeanor and, except as otherwise provided in this  
44 subsection, shall be punished by a fine of \$1,000. The fine imposed  
45 pursuant to this subsection is in addition to any fine or penalty



1 imposed for the other alleged violation or offense for which the  
2 vehicle was halted or its driver arrested pursuant to subsection 4.  
3 The fine imposed pursuant to this subsection may be reduced to not  
4 less than \$200 if the person presents evidence at the time of the  
5 hearing that the person has registered the vehicle pursuant to this  
6 chapter.

7 7. Any resident operating upon a highway of this State a motor  
8 vehicle which is owned by a nonresident and which is furnished to  
9 the resident operator for his or her continuous use within this State,  
10 shall cause that vehicle to be registered within 30 days after  
11 beginning its operation within this State.

12 8. A person registering a vehicle pursuant to the provisions of  
13 subsection 1, 3, 5, 7 or 9 or pursuant to NRS 482.390:

14 (a) Must be assessed the registration fees and governmental  
15 services tax, as required by the provisions of this chapter and  
16 chapter 371 of NRS; and

17 (b) Must not be allowed credit on those taxes and fees for the  
18 unused months of the previous registration.

19 9. If a vehicle is used in this State for a gainful purpose, the  
20 owner shall immediately apply to the Department for registration,  
21 except as otherwise provided in NRS 482.390, 482.395 and 706.801  
22 to 706.861, inclusive.

23 10. An owner registering a vehicle pursuant to the provisions  
24 of this section shall surrender the existing nonresident license plates  
25 and registration certificates to the Department for cancellation.

26 11. A vehicle may be cited for a violation of this section  
27 regardless of whether it is in operation or is parked on a highway, in  
28 a public parking lot or on private property which is open to the  
29 public if, after communicating with the owner or operator of the  
30 vehicle, the peace officer issuing the citation determines that:

31 (a) The owner of the vehicle is a resident of this State;

32 (b) The vehicle is used in this State for a gainful purpose;

33 (c) Except as otherwise provided in paragraph (b) of subsection  
34 1, the owner of the vehicle is a nonresident and has operated the  
35 vehicle in this State for more than 30 days in the aggregate in any 1  
36 calendar year; or

37 (d) The owner of the vehicle is a nonresident required to register  
38 the vehicle pursuant to subsection 5.

39 ↪ As used in this subsection, "peace officer" includes a constable.

40 **Sec. 5.** Chapter 483 of NRS is hereby amended by adding  
41 thereto a new section to read as follows:

42 *1. A person who applies for an identification card in*  
43 *accordance with the provisions of this section and who is not*  
44 *ineligible to receive an identification card pursuant to NRS*  
45 *483.861 is entitled to receive an identification card if the person:*



1 (a) *Is a seasonal resident who does not hold a valid Nevada*  
2 *driver's license; and*

3 (b) *Complies with the provisions of this section and any*  
4 *applicable provisions of NRS 483.810 to 483.890, inclusive.*

5 2. *The Department shall charge and collect the following fees*  
6 *for the issuance of an original, duplicate or changed identification*  
7 *card:*

9 *An original or duplicate identification card issued to*  
10 *a seasonal resident ..... \$17*  
11 *A renewal of an identification card for a seasonal*  
12 *resident..... 17*  
13 *A new photograph or change of name, or both, for a*  
14 *seasonal resident ..... 10*

16 3. *The increase in fees authorized in NRS 483.347 must be*  
17 *paid in addition to the fees charged pursuant to this section.*

18 4. *An identification card that is issued to a seasonal resident*  
19 *pursuant to this section expires 4 years after the date on which it is*  
20 *issued, unless the seasonal resident commits an act or omission*  
21 *for which the Department is required or authorized by the laws of*  
22 *this State to suspend, cancel or revoke the identification card.*

23 5. *For the purpose of obtaining an identification card*  
24 *pursuant to this section, an out-of-state student shall be deemed to*  
25 *be a seasonal resident.*

26 6. *As used in this section, "photograph" has the meaning*  
27 *ascribed to it in NRS 483.125.*

28 **Sec. 5.5.** NRS 483.115 is hereby amended to read as follows:

29 483.115 "Out-of-state student" means a student ~~+~~

35 **Sec. 6.** NRS 483.347 is hereby amended to read as follows:

36 483.347 1. Except as otherwise provided in subsection 2, the

37 Department shall issue a rectangular-shaped driver's license which

38 bears a front view colored photograph of the licensee. The

39 photograph and any information included on the license must be

40 placed in a manner which ensures that:

41 (a) If the licensee is 21 years of age or older, the longer edges of

42 the rectangle serve as the top and bottom of the license; or

43 (b) If the licensee is under 21 years of age, the shorter edges of

44 the rectangle serve as the top and bottom of the license.



1 2. The Department may issue a temporary driver's license  
2 without a photograph of the licensee if the licensee is temporarily  
3 absent from this State and requests the renewal of, the issuance of a  
4 duplicate of, or a change in the information on, his or her driver's  
5 license. If the licensee returns to this State for 14 continuous days or  
6 more, the licensee shall, within 24 days after the date of return,  
7 surrender the temporary license and obtain a license which bears his  
8 or her photograph in accordance with subsection 1. A licensee  
9 charged with violating the provisions of this subsection may not be  
10 convicted if the licensee surrenders the temporary license, obtains a  
11 license which bears his or her photograph in accordance with  
12 subsection 1 and produces that license in court or in the office of the  
13 arresting officer.

14 3. The Department shall:

15 (a) Establish a uniform procedure for the production of drivers'  
16 licenses, applicable to renewal as well as to original licenses.

17 (b) Except as otherwise provided in NRS 483.417 and 483.825,  
18 by regulation, increase the fees provided in NRS 483.410, 483.820  
19 and 483.910 *and section 5 of this act* as necessary to cover the  
20 actual cost of production of photographs for drivers' licenses and  
21 identification cards. The increase must be deposited in the State  
22 Treasury for credit to the Motor Vehicle Fund and must be allocated  
23 to the Department to defray the increased costs of producing the  
24 drivers' licenses required by this section.

25 **Sec. 7.** NRS 483.820 is hereby amended to read as follows:

26 483.820 1. A person who applies for an identification card in  
27 accordance with the provisions of NRS 483.810 to 483.890,  
28 inclusive, *and section 5 of this act*, and who is not ineligible to  
29 receive an identification card pursuant to NRS 483.861, is entitled to

7 3. The Department shall not charge a fee for:

- 8 (a) An identification card issued to a person who has voluntarily
- 9 surrendered his or her driver’s license pursuant to NRS 483.420; or
- 10 (b) A renewal of an identification card for a person 65 years of
- 11 age or older.

12 4. Except as otherwise provided in NRS 483.825, the increase

13 in fees authorized in NRS 483.347 must be paid in addition to the

14 fees charged pursuant to this section.

15 5. As used in this section, “photograph” has the meaning

16 ascribed to it in NRS 483.125.

17 **Sec. 7.5.** NRS 483.850 is hereby amended to read as follows:

18 483.850 1. Every application for an identification card must

19 be made upon a form provided by the Department and include,

20 without limitation:

21 (a) The applicant’s:

- 22 (1) Full legal name.
- 23 (2) Date of birth.
- 24 (3) State of legal residence.
- 25 (4) Current address of principal residence and mailing
- 26 address, if different from his or her address of principal residence, in
- 27 this State, unless the applicant is on active duty in the military
- 28 service of the United States.

29 (b) A statement from:

- 30 (1) A resident stating that he or she does not hold a valid
- 31 driver’s license or identification card from any state or jurisdiction;
- 32 or
- 33 (2) A seasonal resident stating that he or she does not hold a
- 34 valid Nevada driver’s license.

35 2. When the form is completed, the applicant must sign the

36 form and verify the contents before a person authorized to

37 administer oaths.

38 3. An applicant who has been issued a social security number

39 must provide to the Department for inspection:

40 (a) An original card issued to the applicant by the Social

41 Security Administration bearing the social security number of the

42 applicant; or

43 (b) Other proof acceptable to the Department bearing the social

44 security number of the applicant, including, without limitation,

45 records of employment or federal income tax returns.





1 4. At the time of applying for an identification card, an  
2 applicant may, if eligible, register to vote pursuant to NRS 293.524.

3 5. A person who possesses a driver's license or identification  
4 card issued by another state or jurisdiction who wishes to apply for  
5 an identification card pursuant to this section shall surrender to the  
6 Department the driver's license or identification card issued by the  
7 other state or jurisdiction at the time the person applies for an  
8 identification card pursuant to this section. *This subsection does not*  
9 *apply to a person who, pursuant to this section, applies for an*  
10 *identification card as a seasonal resident.*

11 **Sec. 8.** NRS 483.865 is hereby amended to read as follows:

12 483.865 1. Upon the application of a person with a disability  
13 which limits or impairs the ability to walk, the Department shall  
14 place on any identification card issued to the person pursuant to  
15 NRS 483.810 to 483.890, inclusive, *and section 5 of this act* a  
16 designation that the person is a person with a disability. The  
17 application must include a statement from a licensed physician  
18 certifying that the applicant is a person with a disability which limits  
19 or impairs the ability to walk.

20 2. For the purposes of this section, "person with a disability  
21 which limits or impairs the ability to walk" has the meaning  
22 ascribed to it in NRS 482.3835.

23 **Sec. 9.** NRS 483.867 is hereby amended to read as follows:

24 483.867 Upon the application of a person who is a seasonal  
25 resident of this State, the Department shall place on any  
26 identification card issued to the person pursuant to NRS 483.810 to  
27 483.890, inclusive ~~H~~, *and section 5 of this act:*

28 1. A designation indicating that the person is a seasonal  
29 resident; and

30 2. A statement indicating that the person holds a valid driver's  
31 license from another state or jurisdiction.

32 **Sec. 10.** This act becomes effective:

33 1. Upon passage and approval for the purpose of adopting  
34 regulations and carrying out any other preparatory administrative  
35 tasks necessary to implement the provisions of this act; and

36 2. On January 1, 2015, for all other purposes.
