**SUMMARY**—Makes various changes concerning the operation of certain vending stands. (BDR 22-1061)

AN ACT relating to regional transportation commissions; revising provisions pertaining to vending stands provided for by such a commission; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law establishes a priority of right for persons who are blind or visually  
2 impaired to operate vending stands in or on any public buildings or properties.  
3 (NRS 426.640) Existing law also exempts from that priority of right vending stands  
4 in any building, terminal or parking facility owned, operated or leased by a regional  
5 transportation commission in a county whose population is 400,000 or more  
6 (currently Clark County). (NRS 277A.320) **Section 2** of this bill removes that  
7 exemption for both existing and future contracts. **Section 3** of this bill clarifies that  
8 the removal of the exemption applies with respect to any vending stand contract  
9 entered into by such a regional transportation commission on or after the effective  
10 date of this bill, and that any such existing vending stand contract must comply  
11 with the amendatory provisions of this bill on and after July 1, 2011.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** The Legislature hereby finds and declares that:  
2           1. There is a great need, as described in NRS 426.640, to  
3 provide persons who are blind with remunerative employment,  
4 enlarge the economic opportunities of persons who are blind and

1 stimulate persons who are blind to greater efforts to make  
2 themselves self-supporting with independent livelihoods; and

3       2. It is the policy of the Legislature and of this State to support  
4 the needs of persons who are blind by vigorously enforcing and  
5 promoting the provisions of NRS 426.630 to 426.720, inclusive.

6       **Sec. 2.** NRS 277A.320 is hereby amended to read as follows:

7       277A.320 1. In a county whose population is 400,000 or  
8 more, the commission may provide for the construction, installation  
9 and maintenance of vending stands for passengers of public mass  
10 transportation in any building, terminal or parking facility owned,  
11 operated or leased by the commission.

12       2. The provisions of NRS 426.630 to 426.720, inclusive, ~~do~~  
13 ~~not~~ apply to a vending stand constructed, installed or maintained  
14 pursuant to this section.

15       **Sec. 3.** 1. The amendatory provisions of this act apply to any  
16 contract for the operation of a vending stand that is entered into on  
17 or after the effective date of this act.

18       2. In addition to the provisions of subsection 1, all contracts for  
19 the operation of a vending stand that are in existence on the date on  
20 which this act becomes effective and are affected by the amendatory  
21 provisions of this act must be in compliance with the amendatory  
22 provisions of this act on and after July 1, 2011.

23       3. As used in this section, "vending stand" has the meaning  
24 ascribed to it in NRS 426.630.

25       **Sec. 4.** This act becomes effective upon passage and approval.
