AN ACT making an appropriation to the Nevada Center for Civic Engagement to support the We the People: The Citizen and the Constitution Program in Nevada's elementary, junior high, middle and high schools; and providing other matters properly relating thereto.

## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. 1. There is hereby appropriated from the State 1 General fund to the Nevada Center for Civic Engagement to support 2 the We the People: The Citizen and the Constitution Program in 3 Nevada's elementary, junior high, middle and high schools the 4 5 following sums:

For the Fiscal Year 2021-2022.....\$175.000 For the Fiscal Year 2022-2023 ..... \$175,000 8 2. Upon acceptance of the money appropriated by subsection 1, the Nevada Center for Civic Engagement agrees to: 9

(a) Prepare and transmit a report to the Interim Finance 10 Committee on or before December 16, 2022, that describes each 11 expenditure made from the money appropriated by subsection 1 12 from the date on which the money was received by the Nevada 13 Center for Civic Engagement through December 1, 2022; 14





1 (b) Prepare and transmit a final report to the Interim Finance 2 Committee on or before September 15, 2023, that describes each 3 expenditure made from the money appropriated by subsection 1 4 from the date on which the money was received by the Nevada 5 Center for Civic Engagement through June 30, 2023; and

6 (c) Upon request of the Legislative Commission, make available 7 to the Legislative Auditor any of the books, accounts, claims, 8 reports, vouchers or other records of information, confidential or 9 otherwise, of the Nevada Center for Civic Engagement, regardless 10 of their form or location, that the Legislative Auditor deems 11 necessary to conduct an audit of the use of the money appropriated 12 pursuant to subsection 1.

13 3. The sums appropriated by subsection 1 are available for 14 either fiscal year. Any remaining balance of those sums must not be committed for expenditure after June 30, 2023, by the entity to 15 which the appropriation is made or any entity to which money from 16 17 the appropriation is granted or otherwise transferred in any manner, and any portion of the appropriated money remaining must not be 18 19 spent for any purpose after September 15, 2023, by either the entity 20 to which the money was appropriated or the entity to which the 21 money was subsequently granted or transferred, and must be 22 reverted to the State General Fund on or before September 15, 2023. 23 **Sec. 2.** This act becomes effective on July 1, 2021.
