AN ACT relating to the Tahoe Regional Planning Agency; requiring the Agency annually to submit certain information to the Governor and the Director of the Legislative Counsel Bureau; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill requires the Tahoe Regional Planning Agency annually to provide the
2 Governor and the Director of the Legislative Counsel Bureau with a copy of
3 the Agency’s most recent independent audit report and certain information about
4 the Agency’s expenditures and its progress in achieving certain performance
5 measures and benchmarks.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 277.220 is hereby amended to read as follows:
2 277.220 **1.** The Account for the Tahoe Regional Planning
3 Agency is hereby established in the State General Fund and consists
4 of any money provided by direct legislative appropriation. Money in
5 this Account must be expended for the support of, or paid over
6 directly to, the Tahoe Regional Planning Agency in whatever
7 amount and manner is directed by each appropriation or provided by
8 law.



1 2. *On or before January 31 of each year, the Tahoe Regional*
2 *Planning Agency shall submit to the Governor and the Director of*
3 *the Legislative Counsel Bureau:*

4 (a) *A copy of the report of the independent audit most recently*
5 *prepared for the Tahoe Regional Planning Agency; and*

6 (b) *A written report detailing:*

7 (1) *The nature and purpose of the expenditures made by*
8 *the Tahoe Regional Planning Agency during the immediately*
9 *preceding calendar year from money appropriated to it by the*
10 *Legislature; and*

11 (2) *The progress of the Tahoe Regional Planning Agency*
12 *in achieving the performance measures and benchmarks included*
13 *in its current biennial budget.*

14 3. *The Director of the Legislative Counsel Bureau shall cause*
15 *copies of the materials submitted pursuant to subsection 2 to be*
16 *transmitted to the Legislative Committee for the Review and*
17 *Oversight of the Tahoe Regional Planning Agency and the*
18 *Marlette Lake Water System created by NRS 218E.555 and:*

19 (a) *In odd-numbered years, the Legislature.*

20 (b) *In even-numbered years, the Interim Finance Committee.*

21 **Sec. 2.** This act becomes effective on July 1, 2013.
